An Act To Allow the Director of the Bureau of Parks and Lands To Transfer Ownership of Snowmobile Trail Maintenance Equipment to Incorporated Nonprofit Snowmobile Clubs. Final Disposition: Enacted, PRIVATE AND SPECIAL LAW, Chapter 16. (Veto Overridden 03/23/16).
