LD 1588 / HP1079

An Act To Require That Public Postsecondary Educational Institutions in the State Give Preference to Maine Producers When Entering into Contracts Related to Heating Fuel. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 205.) Presented by Representative SAUCIER of Presque Isle. Referred to Joint Standing Committee on State and Local Government. Public Hearing 02/24/16. Final Disposition: Died Between Houses 03/30/16.
