LD 1677 / HP1144

Resolve, Directing the Department of Administrative and Financial Services and the Maine Public Employees Retirement System To Identify Retirees Whose Retirement Benefit Calculations Were Adversely Affected by Certain Pay Freezes and To Calculate Costs Associated with Authorizing Those Retirees To Include Such Lost Wages in Retirement Benefit Calculations. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 205.) Presented by Representative PICKETT of Dixfield. Referred to Joint Standing Committee on Appropriations and Financial Affairs. Public Hearing 03/30/16. OTP-AM Accepted 04/05/16. Amended by: CA H-632. Final Disposition: Enacted, RESOLVE, Chapter 78. (Veto Overridden 04/15/16).
