An Act To Protect Children in the State from Possible Sexual, Physical and Emotional Abuse by Persons Who Have Been Convicted of Crimes. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 205.) Presented by Representative MAKER of Calais. Referred to Joint Standing Committee on Judiciary. Public Hearing 03/31/16. OTP-AM Accepted 04/14/16. Amended by: CA H-671. Final Disposition: Emergency Enacted, PUBLIC LAW, Chapter 497. (Veto Overridden Emergency 04/29/16).
