LD 243 / HP0176

Original Title: An Act To Change the Oversight Agency for Recreational Marijuana from the Department of Agriculture, Conservation and Forestry to the Department of Administrative and Financial Services, Bureau of Alcoholic Beverages and Lottery Operations and To Allocate Funds for Implementation. New Title: An Act To Amend the Marijuana Legalization Act to Provide Licensing, Rulemaking and Regulatory and Enforcement Authority within the Department of Administrative and Financial Services; Assign Rulemaking, Regulatory and Enforcement Authority Related to Agricultural Purposes to the Department of Agriculture, Conservation and Forestry; and Allocate Funds for Implementation. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 205.) Presented by Speaker GIDEON of Freeport. Referred to Joint Select Committee on Marijuana Legalization Implementation. Public Hearing 03/17/17. Majority (OTP-AM) Report Accepted 05/25/17. Amended by: CA (Changed Title) H-221, SA/CA S-312. Final Disposition: Emergency Enacted, Emergency Signed 06/29/17, PUBLIC LAW, Chapter 278.
