An Act To Authorize Regional Medical Control Committees To Have Access To Maine Emergency Medical Services Data for Purposes of Quality Improvement. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.)

Presented by President THIBODEAU of Waldo. Referred to Joint Standing Committee on Criminal Justice and Public Safety. Public Hearing 01/29/18. OTP-AM Accepted 03/20/18. Amended by: CA S-383, SA/CA S-384. Final Disposition: Emergency Enacted, PUBLIC LAW, Chapter 373. (Veto Overridden Emergency 04/10/18).
