An Act To Allow The Maine Educational Center for the Deaf and Hard of Hearing and Governor Baxter School for the Deaf To Lease Space To Maine's Protection and Advocacy Agency for Persons with Disabilities. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 205.) Presented by Representative PIERCE of Falmouth. Referred to Joint Standing Committee on Education and Cultural Affairs. Public Hearing 01/10/18. Majority (OTP-AM) Report Accepted 02/08/18. Amended by: CA H-577. Final Disposition: Emergency Enacted, PUBLIC LAW, Chapter 413. (Veto Overridden Emergency 05/02/18).
