(Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Senator MASON of Androscoggin. Referred to Joint Standing Committee on Labor, Commerce, Research and Economic Development. Public Hearing 01/30/18. Majority (OTP-AM) Report Accepted 03/15/18. Amended by: CA (Changed Title) S-374. Final Disposition: Emergency Enacted, RESOLVE, Chapter 42. (Veto Overridden 04/05/18).
