Joint Order, The the Joint Standing Committee on Inland Fisheries and Wildlife be authorized to report out legislation regarding the repeal of Maine Revised Statutes, Title 12, section 11401, subsection 1, paragraph E, which allows nonresidents who own at least 25 acres of land in Maine to hunt deer on the Saturday preceding the first day of open season on deer. Presented by Representative DUCHESNE of Hudson. Final Disposition: Passed in Concurrence, 01/30/18. (See LD 1823)
