Resolve, Directing the Maine Human Rights Commission To Implement a Pilot Program To Investigate and Report on Incidents of Harassment Due to Housing Status, Lack of Employment and Other Issues. Presented by Representative TALBOT ROSS of Portland. Referred to the Joint Standing Committee on Judiciary. Public Hearing 05/06/19. Majority (OTP) Report Accepted 06/10/19. Finally Passed, Held by Governor. Pursuant to Joint Order (HP 1424), Recalled from Governor's Desk. Amended by: HA H-666. Final Disposition: Finally Passed, Signed 02/14/20, RESOLVE, Chapter 113.

Joint Order, That Bill "Resolve, Directing the Maine Human Rights Commission To Implement a Pilot Program To Investigate and Report on Incidents of Harassment Due to Housing Status, Lack of Employment and Other Issues" (HP 937) (LD 1294) be recalled from the Governor's desk to the House.
