Majority (OTP-AM) Report Accepted 06/14/19. Amended by: CA H-594. Enacted, Held by Governor. Pursuant to Joint Order (HP 1428), Recalled from Governor's Desk. Re-referred to the Joint Standing Committee on Judiciary. Final Disposition: Ought Not to Pass Pursuant to Joint Rule 310 03/10/20.
