An Act To Improve Public Safety through Coordinated Reentry of Prisoners into the Community. Presented by Representative TALBOT ROSS of Portland. Referred to the Joint Standing Committee on Criminal Justice and Public Safety. Public Hearing 06/03/19. OTP-AM Accepted 06/13/19. Amended by: CA H-580. Enacted, Held by Governor. Pursuant to Joint Order (HP 1427), Recalled from Governor's Desk. Re-referred to Joint Standing Committee on Criminal Justice and Public Safety. Final Disposition: Died Upon Conclusion of the 129th Legislature 11/16/20.

Joint Order, That Bill "An Act To Improve Public Safety through Coordinated Reentry of Prisoners into the Community" (HP 1250) (LD 1756) be recalled from the Governor's desk to the House. Presented by Representative TALBOT ROSS of Portland. Final Disposition: Passed in Concurrence 01/08/20.
