An Act To Eliminate Waiting Lists for Home and Community-based Services for Adults with Intellectual Disabilities, Autism, Brain Injury and Other Related Conditions. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Senator MILLETT of Cumberland. Referred to the Joint Standing Committee on Health and Human Services. Public Hearing 01/27/20. Final Disposition: Died Upon Conclusion of the 129th Legislature 11/16/20.
