Referred to the Joint Standing Committee on Agriculture, Conservation, and Forestry. Public Hearing 02/23/21. Majority (OTP-AM) Report Accepted 06/02/21. Amended by: CA H-124. Final Disposition: Finally Passed, CONSTITUTIONAL RESOLUTION, Chapter 1. Approved at Referendum, 11/02/2021 (In favor: 249,273; Opposed 160,440).
