Presented by Representative SUPICA of Bangor. Referred to the Joint Standing Committee on Veterans and Legal Affairs. Public Hearing 03/22/23. Majority (OTP-AM) Report Accepted 06/23/23. Amended by: CA H-510, HB H-710. Final Disposition: Finally Passed, CONSTITUTIONAL RESOLUTION, Chapter 2. Approved at Referendum 11/07/23 (In favor: 227,602; Opposed: 166,876)
