Presented by Senator HICKMAN of Kennebec. Referred to the Joint Standing Committee on Veterans and Legal Affairs. Public Hearing 04/21/23. OTP-AM Accepted 06/22/23. Amended by: CA S-394, SA S-408. Final Disposition: Finally Passed, CONSTITUTIONAL RESOLUTION, Chapter 3. Failed at Referendum, 11/07/23 (In favor: 122,646; Opposed: 269,699).
