Presented by Representative COLLINGS of Portland. Referred to the Joint Standing Committee on Veterans and Legal Affairs. Public Hearings 01/03/24, 01/10/24. Carried Over: 07/26/23. Final Disposition: Died Between Houses 04/17/24.
