Original Title: An Act to Strengthen the Maine Veterans' Homes with Increased and Ongoing Funding. New Title: Resolve, to Require the Department of Health and Human Services to Amend Its MaineCare Reimbursement Rules to Provide Reimbursement to Veterans' Facilities on a Per Resident Basis. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by President JACKSON of Aroostook. Referred to the Joint Standing Committee on Veterans and Legal Affairs. Public Hearing 02/27/24. Final Disposition: Carried Over 05/10/24.
