An Act to Create an Income Tax Credit for Investments in a Team's Qualified Minor League Baseball Facility to Keep the Team in the State. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by President JACKSON of Aroostook. Referred to the Joint Standing Committee on Taxation. Public Hearing 03/14/24. Majority (OTP-AM) Report Accepted 04/16/24. Amended by: CA S-704. Final Disposition: Enacted, Signed 04/22/24, PUBLIC LAW, Chapter 667.
