#### SALARIES OF PUBLIC OFFICERS.

Salaries of state officers. SEC. 1. The following public officers are entitled to receive salaries from the treasurer of state in quarterly payments on the first day of January, April, July, and October, of each year, as follows:

He is entitled to mileage on the first day of the session and fifty dollars of his salary on the first day of each month thereafter, during the session, and the balance at the end thereof; but two dollars shall be deducted from the pay of every member for each day he is absent from his duties, without being excused by the house to which he belongs. The president of the senate and speaker of the

house of representatives, shall be paid a salary of three hundred dol- Chap. 116. lars for each session, with the same mileage as other members, and subject to the same deduction in case of absence. Any member acting as president pro tem. of the senate, or speaker pro tem. of the Compensation house, shall receive two dollars per day extra therefor.
