## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND THREE.

AN ACT TO REPEAL THE ACTS CONSOLIDATED IN THE REVISED STATUTES OF THE YEAR ONE THOUSAND NINE HUNDRED AND THREE.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Sec. 1. The public acts, passed during the years hereafter named and herein designated, are repealed, except so far as they are preserved or excepted in the following sections; but no other acts are hereby repealed.

### 1883.

All the chapters of the revised statutes of the year eighteen hundred and eighty-three, numbered one to one hundred and forty-four inclusive.

#### 1885.

Chapters numbered two hundred and fifty-four to three hundred and eighty-one, inclusive, except

Chapter 340, entitled "An act relative to criminal costs and expenditures in the county of Kennebec,"

Chapter 358, entitled "An act to repeal penalties and forfeitures on account of the failure to comply with section eight of chapter forty-eight of the revised statutes of eighteen hundred and seventy-one," and

Chapter 360, entitled "An act to authorize the governor with the advice and consent of the council to appoint some person to be register of deeds for Franklin county."

SEC. 2. The private and special acts passed during the year hereafter named and herein designated are repealed; but no other such acts are hereby repealed:

Chapter 224, entitled "An Act to regulate fishing in Branch and Meadow Brooks in Thomaston and Rockland."

Chapter 228, entitled "An Act to prohibit ice fishing in Androscoggin Pond, situated partly or wholly in Kennebec county."

Chapter 229, entitled "An Act to regulate fishing in Wilson River in Piscataquis county."

Chapter 230, entitled "An Act to regulate winter fishing and to close the tributaries of certain lakes and ponds in Piscataquis county."

Chapter 236, entitled "An Act to open Lambert Lake, Washington county, to ice fishing."

Chapter 237, entitled "An Act to prohibit ice fishing in Bunganeaut Pond, situated in Alfred and Lyman, York county."

Chapter 244, entitled "An Act permitting ice fishing in Cochnewagon Pond in Monmouth."

Chapter 251, entitled "An Act to provide for a close time on Lily Pond, in the town of Shirley, county of Piscataquis."

Chapter 258, entitled "An Act to prohibit the killing of deer in the town of Isle au Haut in the county of Hancock."

Chapter 270, entitled "An Act to regulate fishing in Grand Lake Stream and at the outlet of Grand Lake, Washington county."

Chapter 292, entitled "An Act to prohibit winter fishing in Great Watchic Pond, and regulating the time for fishing in the tributaries of the same."

Chapter 310, entitled "An Act to close a portion of Sandy River and certain of its tributaries against fishing."

Chapter 316, entitled "An Act to close Sandy Stream and tributaries and the tributaries of Unity Pond in the town of Unity."

Chapter 321, entitled "An Act to prohibit fishing in Pleasant Pond and its inlets, situated in Sumner, Oxford county."

Chapter 326, entitled "An Act pertaining to ice fishing and to close certain tributaries to certain lakes and ponds in Oxford county."

Chapter 328, entitled "An Act to prevent ice fishing in Little Sebago Pond in the towns of Gray and Windham."

Chapter 329, entitled "An Act pertaining to ice fishing in certain lakes and ponds in Kennebec county."

Chapter 330, entitled "An Act prohibiting fishing, except in the ordinary method of angling with artificial flies, in any of the ponds lying on Saddleback mountain, or the outlet of same flowing into Dead River pond or Rangeley Lake, or any of the tributaries emptying into said outlet, or in Salmon Lake, formerly known as Gull pond, situated in Dallas Plantation, in Franklin county."

Chapter 336, entitled "An Act to close the tributaries of Upper and Lower Stone Ponds in the Town of Stoneham."

Chapter 368, entitled "An Act to regulate fishing in the Lower Wilson Pond, Prong Pond and Horseshoe Pond."

Chapter 371, entitled "An Act to regulate the taking of deer in Androscoggin county."

Chapter 379, entitled "An Act to regulate winter fishing and to close the tributaries to certain lakes and ponds in Somerset, Penobscot and Washington counties."

Chapter 381, entitled "An Act to allow open time on deer in certain towns in Cumberland county."

Chapter 387, entitled "An Act to prohibit the pursuit and killing of duck and other water fowl by the use of launches or other craft propelled by other than hand power, upon the waters of Lower Kezar Pond in the county of Oxford."

Chapter 446, entitled "An Act to prohibit the killing of deer in the town of Swan's Island in Hancock county."

Chapter 447, entitled "An Act to prevent ice fishing in Bonneg Beg and "L" Ponds, situated partly in North Berwick, Sanford and Wells, county of York."

Chapter 448, entitled "An Act to prohibit the catching of trout in Tufts, Dutton and Grindstone Ponds, and their tributaries, in the town of Kingfield, Franklin county, for sale."

Chapter 452, entitled "An Act to regulate the killing of deer in the county of Waldo."

Chapter 474, entitled "An Act to prevent the taking of fish from Ross and Conroy lakes, in Littleton and Monticello, in the county of Aroostook," and

Chapter 484, entitled "An Act additional to and amendatory of chapter two hundred and thirty of the private and special laws of nineteen hundred and one, relating to ice fishing in Boyd Lake in the county of Piscataquis."

SEC. 3. The repeal of the acts aforesaid does not revive any of the acts repealed by them. Acts of incorporation declared to be public acts are not repealed. The acts declared to be repealed remain in force for the trial and punishment of all past violations of them; and for the recovery of penalties or forfeitures already incurred; and for the preservation of all rights and their remedies existing by virtue of them; and so far as they apply to any office, trust, judicial proceeding, right, contract, limitation, or event, already affected by them.

SEC. 4. This act shall take effect on the first day of January, nineteen hundred and four.
