§ 2201. Licensed companies only

No individual, firm, association or corporation shall perform or offer to perform in this State, for a stipulated fee covering a certain period, any form of road or other tourist service relating to the repair, operation and care of automobiles or to the protection and assistance of automobile owners or drivers, other than licensed insurance companies, or to furnish or offer to furnish tourist service by selling or offering to sell to any proprietor of any so-called roadside house or camp furnishing or offering to furnish meals or lodging to the traveling public, any form of sign or other insignia indicating that said roadside house or camp has been approved by any individual, firm, association or corporation, without being licensed therefor by the commissioner.

§ 2202. Licenses; fee

If the commissioner is of the opinion that an applicant is reliable and entitled to confidence, such applicant shall be granted a license to perform such road or other service in this State, and such license shall expire on January 1st succeeding the date of issuance but may be renewed annually thereafter so long as the commissioner shall regard such licensee as financially responsible and entitled to confidence.

The applicant shall pay a license fee to the commissioner as provided in section 371, subsection 2.

§ 2203. Agents

No person, for himself or in behalf of any individual, firm, association or corporation, shall sell or offer to sell any such road

or other service without being licensed therefor by the commissioner.

§ 2204. —Licenses; fee

The commissioner shall grant a license to sell such service in behalf of any individual, firm, association or corporation licensed therefor to any applicant who shall furnish the commissioner with satisfactory evidence of his integrity and authority to sell the service offered. Such license, when granted, shall expire on January 1st thereafter, and annually thereafter may be renewed so long as the commissioner shall be satisfied of the licensee's integrity, authority and responsibility to provide the service stipulated.

The applicant shall pay a license fee to the commissioner as provided in section 371, subsection 2.

§ 2205. Revocation

The commissioner may revoke a license for cause, at any time, after hearing.

§ 2206. Penalties

Any person, firm, association or corporation, or any officer, agent, servant or employee thereof, who shall violate any of the provisions of this chapter shall be punished by a fine of not more than \$300 or by imprisonment for not more than 6 months, or by both.
