STATE OF MAINE.

Resolve authorizing the printing of the Returns of Clerks of Corporations.

RESOLVED, That the Secretary of State is hereby directed to cause the printing of four hundred copies of the returns of the several corporations (excepting banks,) of this State, comprising the name, residence, and amount of stock owned by each stockholder and furnish each city, town and plantation with a copy of the same.

[*Approved March 24, 1843.*]
