STATE OF MAINE.

RESOLVES providing for the collection of securities in the Land Office due the State.

RESOLVED, That payment of one third part of the

2 principal and interest due the State on all the notes 3 given for any tract of land, is hereby required to be 4 made on or before the first day of September, eighteen 5 hundred sixty; one other third part on the first day 6 of September, eighteen hundred sixty-one; and the 7 remaining balance upon such notes, on or before the 8 first day of September, eighteen hundred sixty-two. 9 If any such payments shall fail to be made in the 10 manner and at the times aforesaid, all the tracts, 11 townships or parcels of land for which the aforesaid 12 notes so unpaid were given, shall be, and the same 13 are hereby declared forfeited to the State, without 14 any further time for redeeming the same, together 15 with all the payments made thereon.

And provided further, that if any timber shall be 17 cut from any township or tract of land for which any 18 of the aforedescribed notes were given, the stumpage 19 on the same shall be fully paid, and the amount en-20 dorsed on the notes given for the township or tract 21 from which it was so taken; and if the stumpage is 22 not so paid, then the township or tract from which 23 said lumber was so cut, shall not be saved from for-24 feiture, but the same shall be forfeited, in the manner

The time of payment of said stumpage shall be 27 on or before the first day of November in each year.

Resolved, If any part owner of any tract of land, 2 or any mortgagee thereof, fails to pay his proportion 3 of the principal and interest to be paid as by the fore-4 going resolve, as provided on the first day of Septem-5 ber, eighteen hundred sixty, sixty-one and sixty-two 6 aforesaid, any other part owner or mortgagee, who 7 on that day pays his part of such principal and inter-8 est, may on the second day of September aforesaid, 9 pay to the Land Agent the sum which was required 10 to be paid on the said first day of September by said 11 delinquent part owner, and the part owner so paying 12 shall be considered the purchaser of the interest in 13 the land forfeited by such delinquent part owner, and 14 shall have the right to complete the payments for the

- 15 whole, in the manner in the aforesaid resolve provid-
- 16 ed; and having so done, shall be entitled to a deed of
- 17 the interest in the land forfeited by said delinquent
- 18 part owners.
- 19 No payment made by any part owner shall save
- 20 from forfeiture any part of the lands, unless the sum
- 21 so left unpaid by the delinquent part owner, is paid
- 22 and the land purchased in the manner before provided.
- 23 If there are two or more part owners, who desire to
- 24 pay their own shares of such sums and to unite in
- 25 paying the shares of such delinquent part owner, they
- 26 may do so, and shall be entitled each to his proportion
- 27 of the forfeited interest of such delinquent part owner
- 28 in proportion to their several interests.
