STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND FIFTY-NINE.

AN ACT for the establishment of a State Normal School.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

- Section 1. There shall be established, as herein-
- 2 after provided, a State Normal School, for the training
- 3 of teachers in the art of instructing and governing
- 4 the common schools of this State.
 - Sect. 2. There shall be appointed, by the governor
- 2 and council, six trustees of said school, one from each
- 3 congressional district; of whom, in the first instance,
- 4 two shall be appointed for one year, two for two years,
- 5 and two for three years; at the expiration of which
- 6 several terms, appointments to fill said offices shall
- 7 be for the term of three years, which time shall thence-
- 8 forth be the term of office of said trustees; and any

- 9 vacancy happening in the office of trustee, before
- 10 the expiration of the term of office, shall be filled by
- 11 appointment by the governor and council, for the
- 12 residue of said term.
 - Sect. 3. Said trustees, together with the superin-
 - 2 tendent of common schools, for the time being, shall
 - 3 constitute the Board of Trustees of the State Normal
 - 4 School, to which shall be committed the location of
 - 5 said school, the application of the funds for the sup-
 - 6 port thereof, the appointment of teachers, and power
 - 7 of removing the same; the authority to prescribe the
 - 8 studies and exercises of the school; the rules for its
 - 9 management, and the granting of diplomas; and they
- 10 shall report on or before the fifteenth day of January,
- 11 annually, to the legislature, their own doings and the
- 12 condition and progress of the school.
 - Sect. 4. The expenses necessarily incurred by said
 - 2 trustees, in the discharge of their duties, shall be de-
 - 3 frayed out of the funds hereinafter appropriated for
 - 4 the support of said school; but they shall receive no
 - 5 compensation for their services.
 - SECT. 5. Such persons only shall be admitted to
 - 2 said school as have the literary qualifications now re-
 - 3 quired by law for teachers in common schools; and
 - 4 no person shall be admitted to the same as a pupil
 - 5 who does not intend to pursue the profession of teach-

- 6 ing in the common schools of this State, and who
- 7 shall not before admission thereto file with the trustees
- 8 a declaration of such intention; and whenever a
- 9 greater number of persons so qualified and declaring
- 10 shall apply for admission as pupils to said school than
- 11 can be therein accommodated; the trustees shall
- 12 admit such applicants as will secure to every portion
- 13 of the State, so far as is practicable, an equal propor-
- 14 tion of pupils in said school.
 - Sect. 6. The trustees are authorized, and it shall
 - 2 be their duty, to establish such rules and regulations
 - 3 as they deem proper to secure the payment of a rea-
 - 4 sonable tution from such pupils as shall not engage
 - 5 in teaching in the common schools of this State for a
 - 6 time not less than twelve months during the three
 - 7 years next after their leaving the Normal School; but
 - 8 there shall be no charge for tuition to those who shall,
 - 9 in pursuance of their declaration, teach in the common
- 10 schools of this State, the time aforesaid.
 - Sect. 7. Whenever any person, or persons, or corpo-
 - 2 rations, shall offer to the Board of Trustees, for a time
 - 3 not less than five years, the necessary building or build-
 - 4 ings and apparatus for the accommodation of not less
 - 5 than two hundred and fifty pupils, to the acceptance of
 - 6 the said Board of Trustees, and shall place such build-
- 7 ings and apparatus at the disposal of the trustees for the

- 8 use of the State, and the Board of Trustees shall
- 9 accept the same; then the said Board shall establish
- 10 therein a State Normal School, as herein before pro-
- 11 vided, and appropriate for the support thereof the
- 12 sum provided in section eight.
 - Sect. 8. For the support of said school, there shall
- 2 be annually appropriated the sum of three thousand
- 3 dollars, for the term of five years, out of any money
- 4 in the treasury not otherwise appropriated; and the
- 5 governor, with consent of the council, is hereby
- 6 authorized to draw his warrant on the treasury for
- 7 the same.
- SECT. 9. This act shall take effect from and after its 2 approval by the governor.
