### STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SIXTY-ONE.

AN ACT to incorporate the People's Savings Bank.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. William H. Titcomb, Maynard Sumner, 2 Francis Cobb, John T. Berry, S. N. Hatch, Isaac C. 3 Abbott, A. G. Spear, John Crockett, Timothy Wil-4 liams, A. H. Kimball, Charles McLoon, Joseph Far-5 well, and their associates and assigns, are hereby 6 incorporated into a company by the name of the 7 People's Savings Bank, to be located in Rockland, 8 with all the powers and privileges conferred on similar 9 institutions by the laws of this state, and subject to 10 all liabilities and restrictions thereof.

SECT. 2. Said corporation shall receive from any 2 person any deposit or deposits of five cents or up-

3 wards, and may use the same for the purposes herein 4 provided.

SECT. 3. All deposits of money received by said 2 corporation shall be used as they shall judge for the 3 benefit of said corporation, and the net income or 4 profit thereof shall be by them divided among the per-5 sons making such deposits, their executors, adminis-6 trators or assigns, in just proportion, and such deposits 7 may be withdrawn at such reasonable times, and in 8 such manner as said corporation shall appoint.

SECT. 4. The first meeting of said corporation may 2 be called at such time and place as may be directed 3 by the three first named corporators in this act, by 4 giving notice in a newspaper published in Rockland, 5 at least ten days previous thereto, at which meeting, 6 and every subsequent annual meeting, said corpora-7 tion may elect, by ballot, any person or persons as 8 members thereof; may choose such officers as they 9 deem proper for their organization and government, . 10 who shall so continue one year and until others are 11 chosen in their stead; and the persons elected treas-12 urer and secretary, before entering upon their official 13 duties, shall be sworn to the faithful performance 14 thereof, and the former shall also give bonds satisfac-15 tory to said corporation for the faithful discharge of his 16 duties; provided, however, that the offices of treasurer

17 and secretary may, if deemed advisable, be united in 18 one person.

SECT. 5. A minor has the right to deposit or loan 2 money to the bank in the mode authorized by this act, 3 and the money so deposited or loaned by such minor 4 is not the property or credit of the parents of such 5 minor, or either of them, during the life of said 6 minor, but of the minor; and the minor has the power 7 to control, manage and dispose of the same, with the 8 same remedies by the appropriate form of action as 9 persons may who have attained their majority or full 10 age; *provided*, *however*, that this provision shall not 11 apply to any money fraudulently deposited or loaned 12 by any person in the name of a minor, or by a minor 13 for the benefit of a third person.

SECT. 6. The annual meeting shall be holden in the 2 month of May, and at that and all other meetings it 3 shall require seven persons at least to constitute a 4 quorum for the transaction of business, and meetings 5 may be directed at other times by the president or the 6 corporation.

SECT. 7. At any legal meeting of the members of 2 said corporation, they may establish a by-law provid-3 ing that any member who shall fail to attend the an-4 nual meeting for two successive years, or who shall 5 remove from this state, shall cease to be a member.
