AMENDMENT "C."

Mr. DYER'S Amendments to bill An act to aid Aroostook R. R. Co., and promote the settlement of the public lands :

Amend section 1, line 4, by inserting after the word
2 " payment " " or lawfully bargained or contracted
3 for, or held under claim of possession and improvement
4 or which may be reserved."

Amend section 1, line 8, by inserting after the word
2 " heretofore " the words " select out of townships lo-
3 cated and designated for settlement in the first seven
4 ranges of township in Aroostook county west of the
5 east line of the State, or to be located or designated,
6 as heretofore, and offer the same in lots for settlement."

Amend section 1, by adding to the end thereof,
2 " and he may sell the other public lands or lease the
3 same, or sell the timber and grass thereon or lease the
4 same under the direction of said board, and upon such
5 conditions as they may deem proper."

Amend section 2, by inserting after the word “ timber ” in line 3, the words “ hereafter sold.”

Amend section 4, by striking out in the first line the 2 words “ the point between,” and in lines 2, 3 and 4 3 the words “ and the eastern boundary of the state, 4 where the route of said railroad may deflect in a 5 southeasterly direction to the boundary aforesaid,” and 6 by adding to the end thereof, “ the Aroostook Rail- 7 road Company shall locate a branch of their railroad 8 from some point between Milford and Mattawankeag 9 to the eastern boundary of the state, so as most con- 10 veniently to connect with the European and North 11 American Railway of New Brunswick, said location 12 to be made by commissioners appointed by the Legis- 13 lature.”

Amend section 5, line 11, by inserting after the 2 word “ railroad,” the word “ branch ” and by strik- 3 ing out from said line the words “ from Mattawam- 4 keag,” and by striking out from lines 13 and 14 the 5 words “ Mattawankeag to the eastern boundary of the 6 State and,” and by adding to the end of said section 7 the words “ and one-half part on the branch to the 8 eastern boundary of the State.”

Amend section 8, by inserting after the word “ Houl- 2 ton ” in line 3, the words “ and the branch to the 3 eastern boundary of the State.”
