To the President of the Senate and Speaker of the House of Representatives.

In compliance with an order of the Legislature, I herewith transmit a statement of the expenditures made during the past year for furniture, alterations and repairs, the names of the persons to whom the money was paid, and the purposes for which it was paid.

I have further to state that the alterations and repairs were made under the order of the Governor and Council, in obedience to whose directions the duties of my office are discharged.

After the first of December, at which time I am obliged to close my yearly accounts, I am compelled to make new bills to meet the wants and convenience of the Legislature. It is not in my power to state the exact amount of these bills as they have not been presented for settlement. When so presented they will, like other bills, be laid by me before the Governor and Council for the purpose of being audited.

In regard to the appropriations, from which the bills were paid, I have no official information in my possession. When my accounts were allowed by the Governor and Council, I received a warrant on the Treasurer due me from such appropriations as they deemed expedient. As the warrants are not in my possession, and I have no record of them, other than the amount received, it is impossible for me to answer this question without myself applying for information to the Executive Department of the Government.
