RESOLVE for apportioning one hundred and fifty-one representatives among the several counties, cities, towns, plantations and classes in the state of Maine.

Resolved, That the county of Androscoggin shall 2 choose eight representatives, to be apportioned as 3 follows, to wit: Auburn, one; Durham, Lisbon 4 and Webster, one; Greene, Leeds and East Liver-5 more, one; Lewiston, two; Minot and Danville, 6 one; Turner and Livermore, one; Poland, one for 7 the years eighteen hundred sixty-two, eighteen hun-8 dred sixty-three, eighteen hundred sixty-five, eigh-9 teen hundred sixty-six, eighteen hundred sixty-seven, 10 eighteen hundred sixty-nine, eighteen hundred seventy,

11 eighteen hundred seventy-one; Wales, one for the12 years eighteen hundred sixty-four, and eighteen hun-13 dred sixty-eight.

The resolve entitled "Resolve for apportioning one 2 hundred and fifty-one representatives among the sev-3 eral counties, cities, towns, plantations and classes in 4 the State of Maine," approved April twenty-third, in 5 the year of our Lord one thousand eight hundred and 6 fifty-two, is hereby repealed; *provided*, *however*, that 7 it shall remain in force for the purpose of filling vacan-8 cies which may occur in the present house of repre-9 sentatives.
