STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND
SIXTY-ONE.

AN ACT to prevent imposition upon town agents appointed to sell intoxicating liquors for medicinal and mechanical purposes.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECTION 1. The governor and state treasurer are
2 hereby authorized and required to contract with some
3 person or party to furnish the municipal officers of the
4 cities and towns of this state, pure liquors, to be kept
5 and sold for medicinal and mechanical purposes, ac-
6 cording to the laws of the state.

SECT. 2. Such contract shall not be made with

2 any person or party not authorized by law to sell
3 intoxicating liquors for medicinal and mechanical
4 purposes.

SECT. 3. As soon as may be after making such
2 contract, the governor and treasurer shall issue to the
3 municipal officers of the several cities and towns of
4 this state, a notice of the name and place of business
5 of the person or party thus contracted with, a schedule
6 of the kinds of liquors kept by him for sale as afore-
7 said, together with the price of each kind, and the
8 terms of payment therefor.

SECT. 4. The person or party with whom such con-
2 tract shall be made, shall be required to keep a
3 record of the names of towns for which liquors are
4 sold, of the persons purchasing for said towns, of the
5 quantity and kind of liquor sold to each, together with
6 the prices paid for the same, and shall make report of
7 the same to the governor and council in the month of
8 December, annually, to be by them laid before the
9 legislature.

SECT. 5. This act shall be in force from and after
2 its approval by the governor.
