STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SIXTY-ONE.

AN ACT relating to the State Library.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

- Section 1. The state library shall hereafter be
- 2 under the management and control of the governor
- 3 and council as a board of trustees.
- Sect. 2. There shall be appointed by the governor
- 2 and council, a librarian of the state library, who
- 3 shall hold his office three years, unless sooner removed,
- 4 and shall give bond to the state, in such sum and with
- 5 such sureties as shall be approved by the governor and
- 6 council, for the faithful performance of the duties of
- 7 his office.

- Sect. 3. The library shall be kept open every day
- 2 in the year, Sundays and the usual public holidays
- 3 excepted, during the usual business hours.
- Sect. 4. All sums of money appropriated by the
- 2 legislature for the purchase of books, shall be expended
- 3 by the librarian, under the direction of the governor
- 4 and council.
 - Sect. 5. The librarian shall report to the legisla-
- 2 ture, annually, in the month of January, the receipts
- 3 and expenditures on account of the library, with a
- 4 list of all books, maps and charts acquired during
- 5 the preceding year, specifying those obtained by
- 6 purchase, donation, and exchange, and those, if any,
- 7 which have been lost or are missing, and make such
- 8 suggestions in relation to the library as shall lead to
- 9 its improvement.
- Sect. 6. Books may be taken from the library by
- 2 the governor, members of the council and of the leg-
- 3 islature, judges of the judicial courts, secretary of
- 4 state, treasurer of state, adjutant general, attorney
- 5 general, land agent, reporter of decisions, by the
- 6 chaplain, secretary and assistant secretary of the sen-
- 7 ate, chaplain, clerk and assistant clerk of the house,
- 8 provided that this privilege to the members of the leg-
- 9 islature and those officially connected therewith, shall

10 be limited to the time the legislature shall be in 11 session.

- Sect. 7. No person, authorized to take books from
- 2 the library, shall be permitted to have, at any one
- 3 time, more than three volumes, nor shall the same be
- 4 retained more than three weeks at a time; and all
- 5 shall be returned on or before the first day of January,
- 6 annually.
 - Sect. 8. No law works of this or any other coun-
- 2 try, belonging to the library, excepting those of the
- 3 State of Maine, Vattemare's exchanges, or books pre-
- 4 sented by the United States, or any other state, shall
- 5 be allowed to be removed from the library room, ex-
- 6 cept for the use of the two houses, and the committees
- 7 at their committee rooms, during their sessions.
 - Sect. 9. Every person shall be answerable for all
- 2 damage done by him to any book, and in case of the
- 3 loss of a volume belonging to a set, the person answer-
- 4 able therefor shall procure a new volume, or pay in
- 5 money the value of the set.
- Sect. 10. Action for the breach of said regulations
- 2 may be brought by the librarian in his own name for
- 3 the use of the state, and in case of his death or re-
- 4 moval from office, the action shall survive and be
- 5 prosecuted by his successor.

- Sect. 11. The governor may transmit to the gov-
- 2 ernors of the several states, and of the several British
- 3 North American Provinces, three copies of all the laws
- 4 and resolves published by order of the legislature, one
- 5 copy of all public documents printed and bound by
- 6 the like order, and one copy of the printed decisions
- 7 of the judicial courts.
- Sect. 12. The annual salary of the librarian shall
- 2 be eight hundred dollars, to be paid quarterly out of
- 3 any moneys in the treasury, not otherwise appropri-
- 4 ated.
 - Sect. 13. The librarian appointed as aforesaid,
- 2 shall enter upon his duties the first day of July then
- 3 next after his appointment, until which time the care
- 4 of the library to remain as before the passage of this
- 5 act.
- Sect. 14. All acts and parts of acts inconsistent
- 2 with this act are hereby repealed.
- Sect. 15. This act shall take effect and be in force
- 2 on and after its approval by the governor.
