STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SIXTY-ONE.

AN ACT relating to dogs.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

- Section 1. Every owner or keeper of a dog shall
- 2 annually, on or before the last day of April, cause it
- 3 to be registered, numbered, described and licensed for
- 4 one year from the first day of the ensuing May, in the
- 5 office of the clerk of the city, town or plantation where-
- 6 in he resides, and shall cause it to wear around its neck
- 7 a collar distinctly marked with its owner's name and
- 8 registered number, and shall pay for such license one
- 9 dollar for a male and five dollars for a female dog.

- SECT. 2. The clerk shall issue the license and re2 ceive and pay the money therefor into the city, town or
 3 plantation treasury, retaining to his own use ten cents
 4 for each license. The treasurer shall keep an accurate
 5 and separate account of all sums received and paid out
 6 under the provisions of this act, which account shall at
 7 all times be open to the inspection of any voter of the
 8 place.
- Sect. 3. The clerk shall annually, within one week 2 after the first of May, post in some conspicuous public 3 place a list of all dogs licensed for the current year, 4 and shall furnish a copy thereof to the chief of police 5 of the city, or one of the constables of the town or 6 plantation, and shall also, from time to time, furnish 7 said officers with a list of such dogs as are subsequently 8 licensed during the year.
- Sect. 4. Any owner of a dog may, at any time, 2 have it licensed until the first day of the ensuing May 3 upon paying the sum as provided in section one of this 4 act, but such license shall not exempt him from the 5 penalty for any damage done prior to the granting said 6 license.
- SECT. 5. Whoever keeps a dog contrary to the pro-2 visions of this act, shall forfeit ten dollars, to be recov-3 ered by complaint to the use of the place wherein the 4 dog is kept.

Sect. 6. Whoever wrongfully removes the collar

- 2 from, or steals a dog licensed and collared as aforesaid,
- 3 shall be punished by a fine not exceeding fifty dollars;
- 4 and whoever wrongfully kills, maims, or entices, or
- 5 carries away such a dog, shall be liable to its owner
- 6 for double the value thereof.
- Sect. 7. Any person may, and every police officer
- 2 and constable shall, kill or cause to be destroyed all
- 3 dogs going at large and not licensed and collared ac-
- 4 cording to the provisions of this act, and such officers,
- 5 when not otherwise paid for their services, shall re-
- 6 ceive from the city or town treasury fifty cents for
- 7 each dog so destroyed by them.
- Sect. 8. Any person may kill a dog that suddenly
- 2 attacks him while he is peaceably walking or riding
- 3 without the enclosure of its owner or keeper, or that
- 4 is found out of the enclosure or immediate care of its
- 5 owner or keeper, worrying, wounding or killing any
- 6 neat cattle, sheep or lambs, whether such dog is col-
- 7 lared or not; and if any person so assaulted or finding
- 8 a dog strolling out of the enclosure or immediate care
- 9 of its owner, shall, within forty-eight hours after such
- 10 assault or finding, make oath thereof before a justice of
- 11 the peace, or before the clerk of the city, town or
- 12 plantation where the owner of the dog dwells, and
- 13 further swears that he suspects the dog to be danger-

14 ous or mischievous, and shall give notice thereof to its 15 owner or keeper by delivering him a certificate of such 16 oath, signed by such clerk or justice, the owner or 17 keeper shall forthwith confine or kill it; and if he 18 neglects so to do for twenty-four hours after such 19 notice, he shall forfeit a sum not less than ten dollars.

SECT. 9. If, after such notice, the dog is not killed 2 or confined, and is found strolling out of the enclosure 3 of its owner or keeper, and shall assault, wound or 4 cause to be wounded, any person or persons, or shall 5 worry, wound or kill any neat cattle, sheep or lambs, 6 or do any other mischief, the owner or keeper shall 7 be liable to pay to the person injured thereby, treble 8 the amount of damage therefor.

Sect. 10. Whoever suffers loss by reason of the 2 worrying, maiming or killing of his sheep, lambs or 3 other domestic animals by dogs, may, within thirty 4 days after he knows of such loss, present proof thereof 5 to the mayor or selectmen of the city, town or planta-6 tion wherein the damage is done, and thereupon the 7 said officers shall draw an order in favor of the person 8 so suffering, upon the treasurer of said city, town or 9 plantation, for the amount of such loss. The treasurer 10 shall register such order at the time of its presenta-11 tion, and annually on the first day of January pay 12 them in full, if the gross amount received by his city,

- 13 town or plantation, under the provisions of this act,
- 14 and not previously paid out, is sufficient therefor, other-
- 15 wise he shall divide such amount pro rata among such
- 16 orders in full discharge thereof. After such order is
- 17 drawn, the city, town or plantation may recover
- 18 against the owner or keeper of any dog concerned in
- 19 doing the damage the full amount thereof.
 - SECT. 11. The mayor and aldermen of any city,
 - 2 and selectmen of any town or plantation, shall require
 - 3 all dogs not licensed and collared according to the pro-
 - 4 visions of this act, to be destroyed, and shall enforce
 - 5 all penalties herein provided. Any officer refusing or
 - 6 neglecting to perform the duties herein imposed upon
 - 7 him, shall be punished by a fine not exceeding twenty-
 - 8 five dollars, to be paid into the city, town or planta-
 - 9 tion treasury.
 - Sect. 12. All fines and penalties provided for in
 - 2 this act, may be recovered on complaint before any
 - 3 police court or trial justice in the county where the
 - 4 offence is committed.
 - Sect. 13. All acts and parts of acts heretofore en-
 - 2 acted inconsistent with the provisions of this act, are
 - 3 hereby repealed.
