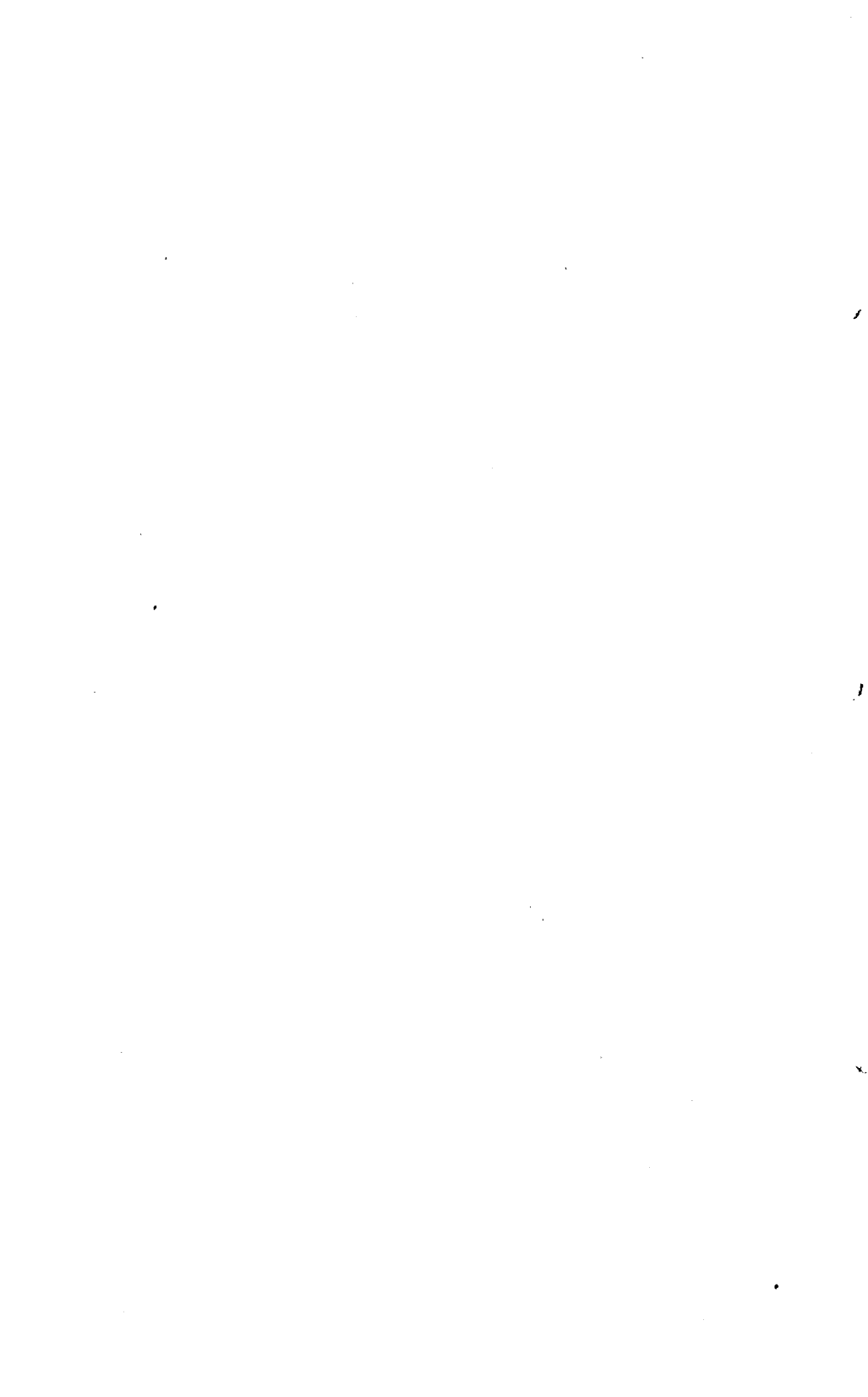

In compliance with the provisions of an act passed by the Forty-Third Legislature of this State, and approved on the twenty-fourth day of March, A. D. 1864, entitled "an act requiring the secretary of state to furnish the clerks of courts in the several counties a list of all persons commissioned and qualified as justices of the peace, justices of the peace and quorum, trial justices and notaries public," and of an act amendatory thereof, approved February 11, 1865, the following list has been prepared, exhibiting the names of all such officers, who prior to the date hereof, have filed their certificates of qualification in this office.
