## MAINE STATE LIBRARY REPORT.

---

*To the Honorable Senate and House of Representatives of the State of Maine:*

I have the honor to submit the report of the Maine State Library for the years, 1905-1906.

During the past two years many valuable additions have been placed upon the shelves of the library. The accession book shows that during the last twenty-eight months ending December 31, 1906, books have been added to the library as follows:

A larger number of documents have been received by exchange than usual, while about the average number have been received from other sources.

The first aim has been to secure material relating to the historical, industrial and commercial interests of the State of Maine.

Important additions have been made to the reference section, by completing broken sets of magazines and other serial publications and the purchase of new works. The importance of the law section is recognized and has been kept up to date by the addition of the latest authorized editions of statutes, digests, court reports and legal periodicals, and also important textbooks and cyclopedias.

Some of the sets of session laws of the different states are still incomplete, and it is hoped that some, at least, of the wanting volumes may yet be secured by exchange.

The medical section has been enriched by the addition of some of the best recognized authorities on surgery and the general practice of medicine. Valuable additions have also been made to the historical collection.

Many valuable maps and pamphlets which, owing to their size and form, could not be properly shelved, have been mounted and bound and made easily accessible.

An unusually large number of requests have been received from various departments in different states as well as public institutions, for partial or complete sets of the department reports and other publications of this State. These requests have been complied with, when it has been possible to secure for the library anything of equal value in exchange.

A number of applications for the loan of books have been received from the public libraries in the State, and in granting these requests the rules of the library have been construed as liberally as the proper protection of the property of the State would permit.

The State officials, scholars, club members and people of the State in general have patronized the library more freely during the past year than ever before and since fiction has been mostly eliminated from the library, these demands have necessarily been for books for study purposes rather than recreation.

The rapid increase in the patronage during the last few years seems to foretell the future needs of the library. Provisions should be made for more stack room, and for such extra help as will be necessary to keep the library in the front ranks of progressive libraries in the country.

The main room of the library contains only such books as are intended for reference and immediate use. The public documents and department reports which are saved for the purpose of exchange, as well as the newspapers and many other valuable books, are arranged in the four remaining rooms in the old library and a small packing room in the basement.

The patrons of the library appreciate the great need of more commodious and convenient quarters and it seems only necessary at this time to express the hope that some step will be taken before long to relieve the crowded condition. Owing to the lack of stack room the books cannot be properly shelved or arranged, which fact greatly increases the work of the depart-

ment. When the present library room was completed, it was said that the steel stack would afford shelving for 70,000 volumes, and would be sufficient for ten years growth. The ten years expired in 1901, and if the estimates which have been made from time to time are correct, the library now contains about 95,000 volumes.

The congested conditions of the library can be relieved to some extent by the erection of temporary stacks in the rooms of the old library.

The adopted policy of the State is to supply its citizens with the various State publications, so that they may be fully informed as to the work of the departments. There seems to be no more satisfactory way for the economical distribution of these publications than by supplying each member of the legislature with such a number as he can properly distribute. It is difficult to tell before the publication of a report what the demand will be, and as the edition is in most cases fixed, it becomes necessary to exercise the utmost care in the distribution of certain reports, and many times the edition is exhausted before the justifiable demands are met.

The library now receives from the State bindery for distribution and exchange 675 copies of each of the reports of the various State departments and institutions. While this number is sufficient to supply the demand when the legislature is not in session, many of the requests of the members, in the legislative year, must be denied or referred to other sources.

During the past two years over 7,600 packages have been sent out, and to say that 50,000 State publications have been distributed by this department, would be a conservative estimate.

An increasing interest is manifested by the people of the State in the free public library movement. So pronounced is the expression of this sentiment, it seems safe to venture the prediction that within a decade there will be very few of the organized places in the State which will not contain a free public library in some form. This condition seems to be the result of a natural tendency on the part of our people to educate themselves, coupled with the good work of our educational institutions and religious organizations, and also the effectual work of the library associations and clubs. The traveling library, which has passed the experimental stage, has become an active agent in exciting

interest in good reading and free libraries. By a still more hearty cooperation and effort upon the part of those engaged in educational work—the school, church, grange and club—the field of the traveling library could be greatly extended and its work increased. During the past two years free public libraries have been established in the towns of Yarmouthville, Damariscotta (joined with Newcastle), Weld, Rumford Falls, Bangor, Boothbay Harbor and Gray, and those have received \$700 in books as provided for by section 17, chapter 57, of the Revised Statutes.

No one doubts the efficient work that is being done by the public libraries, but from such observations as I have been able to make, I believe that most libraries are deficient in books relating to scientific subjects. While it is necessary that the demands for works of light literature should be met with the best books of that class, at the same time the wants of the great majority who work more and read fewer and better books, should not receive secondary consideration in making additions to a library. The worker should be able to find in his public library the books which will enlighten him that he may make greater progress in his chosen vocation.

One of the necessary improvements in the library is a change of the present card catalogue, which contains two sections—subject and author-title sections—into a dictionary catalogue, wherein authors, titles and subjects are combined in one alphabet. While this change will mean a great deal of labor, it seems to be essential that it should be done as soon as possible. It also seems necessary that some simple but efficient charging system should be inaugurated to better secure the contents of the library and save time and labor in the administration of its affairs. The value of the library for reference purposes could be greatly enhanced by the publications of lists of books (in the library) upon certain subjects; while this has been done to a certain extent the work has been of a temporary nature and nothing has been issued in printed form.

There is a large number of miscellaneous bound documents in the library, containing most valuable material, which is practically lost owing to the fact that the contents of these volumes have not been indexed. There is opportunity for analytical work to be done upon such documents which would make these now almost useless volumes invaluable.

Realizing the value and importance of such documents, and knowing how difficult it is to find anything in them, it seemed wise to take a step in the right direction by incorporating in this report an index to the contents of the "Maine Public Documents," from the time they were first published in 1829 down to 1867, since which time the volumes have been quite well indexed. The work has brought to light a great amount of material of a statistical and historical nature, relating to the State, and the time and labor has been well spent.
