## FOREWORD

By authority of Section 11 Chapter 83 Public Laws of Maine 1937 this report contains a complete list of licensed brokers and salesmen, Financial Statement, Summarized Report of the activities of the Commission.

Since this is a new law for the State of Maine, the majority of brokers and salesmen were unfamiliar with the requirements of the law. The Commission took this into consideration and to facilitate the carrying out of the law, endeavored to issue these licenses with the least possible inconvenience to the applicants.

On behalf of the Commission, I wish to acknowledge the fine spirit of cooperation manifested by our brokers and salesmen.

As the Maine Real Estate License Law does not require any examination, all those who apply for a real estate broker's or salesman's license must comply with certain regulations and furnish required information under oath, therefore, it is very important that every applicant carefully study the law and thoroughly familiarize himself with its provisions before attempting to fill out the application.

In drafting the original blanks, while the law gives the Commission full power and authority to make all reasonable rules and regulations to administer the act, it has included only requirements contained in the act itself.

Experience gained in the few months that the law has been in force has proven that certain rules and regulations will have to be made to clarify the meaning of some of its provisions and to better enforce and administer the act.

The primary object of this Commission is to protect the public from incompetency, fraud and deception and this it has faithfully tried to do. The Commission exercises utmost care in examining applications and unless the applicant cooperates with the Commission by furnishing the required information, no license is issued. The Commission reserves the right to hold all applications for a sufficient time for investigation.

The greatest difficulty confronting the Commission during its first year of activity was the matter of complaints. In order to revoke or suspend a license, the law requires that the complaint be in writing and must contain evidence documentary or otherwise, sufficient to make out a prima facie case. The Commission is most willing to protect its licensed brokers and salesmen and will act immediately upon receipt of written complaints duly sworn to.

We wish to call attention to the fact that if a broker is a licensed broker, it does not give him the privilege of using the word "Realtor" which is a copyrighted word of the National Real Estate Boards, and any person using the word "Realtor" who is not a member of the National Real Estate Boards is liable to a fine for such use.

Frequent requests have been made to the Real Estate Commission as to the legal rates of commission for selling or renting. The law gives no authority to the Real Estate Commission to establish rates of commission of sales or rentals. This commission is determined by the prevailing rate in the county in which the property is located.

Special attention should be given by every applicant to Section 12 of the Act which provides for penalties. In the matter of renewals, continuing to act and failing to renew shall be punished by a fine of from \$10 to \$25. Violating any other provision upon conviction, if a natural person, shall be punished by a fine of \$500 or 6 months imprisonment, or both fine and imprisonment. If a corporation a fine not exceeding \$1000. Any officer or agent of a corporation, or member or agent of a partnership or association, who shall personally participate in or be accessory to any violation of the provisions of this act by such partnership, association or corporation shall be subject to the penalties herein prescribed for individuals.

Note well that the law reads "shall be punished" and is therefore mandatory. There are other mandatory provisions, every one important to a licensed broker or salesman, and the failure to study and understand their meaning may cause a loss of commission fairly earned and/or a severe penalty.
