FOREWORD

The Maine Real Estate Commission presents its second annual report containing a complete list of licensed brokers and salesmen as well as financial statement and summary of the activities of the Commission.

It was the unanimous vote of the Commission to commend the brokers and salesmen of Maine for the wholehearted cooperation displayed during the fiscal year just ended, and to assure them of the desire of the Commission to at all times render every service within its power.

REPORT

Section 11 of Chapter 83 Public Laws of 1937 requires and authorizes the Maine Real Estate Commission to publish a list of names and addresses of all real estate brokers and salesmen licensed from July 1, 1938 to June 30, 1939. It is possible that some brokers or salesmen whose names are not listed herein have obtained licenses after June 30, 1939. Such information may be obtained by writing direct to this Commission.

The law provides that no person shall for compensation or valuable consideration, sell or offer to sell, rent or offer to rent, lease or exchange of or for another, until he has obtained a license. You will greatly serve the public and help yourself by promptly reporting any violation of this Act to the Maine Real Estate Commission, State House, Augusta, Maine.

Whenever a broker moves his place of business from the registered address or a salesman ceases to be employed, the certificate, automatically, ceases to be in force. This provision is important to both the commission and the broker or salesman. Many inquiries are received regarding brokers and unless the commission can furnish the proper information, it may result in a loss to the broker. We call this fact to your attention as this has been the biggest problem met with in the past year.

We again refer to the matter of complaints. Under this law the Commission cannot act as a collection agency. All complaints properly sworn to are investigated by the Commission when the facts deem it advisable. Hearing is given the parties involved and if guilt is established, restitution is demanded, and the penalty of revocation or suspension of license may be imposed by the Commission. During the past year, through the efforts of the Commission, restitution was made to clients of the sum of \$178.50 and with proper cooperation, similar violations can be detected and corrected.
