This report is published in accordance with Section 11 of Chapter 83, Public Laws of 1937 of the Maine Real Estate Broker and Salesman License Act and contains a list of all licensed brokers and salesmen from July 1, 1939 to June 30, 1940. A financial report is also included.

For the benefit of the licensed brokers and salesmen, a list will be printed of parties who have failed to renew their licenses for the year 1941. Such a list will be mailed to you upon request.

There were no formal hearings for the year 1940. Many informal complaints were received. Again we feel we must call your attention to the fact that all complaints must be sworn to, before the Commission can act on same. Your cooperation in this matter is requested.

Every broker and salesman should become thoroughly familiar with the License Act.

The license issued a broker, must be conspicuously displayed in his place of business.

An inquiry directed to the Maine Real Estate Commission, State House, Augusta, Maine, will receive prompt attention and the Commission invites such a practice.

The Commission takes this opportunity to thank all brokers and salesmen for their cooperation in the enforcement of the law.
