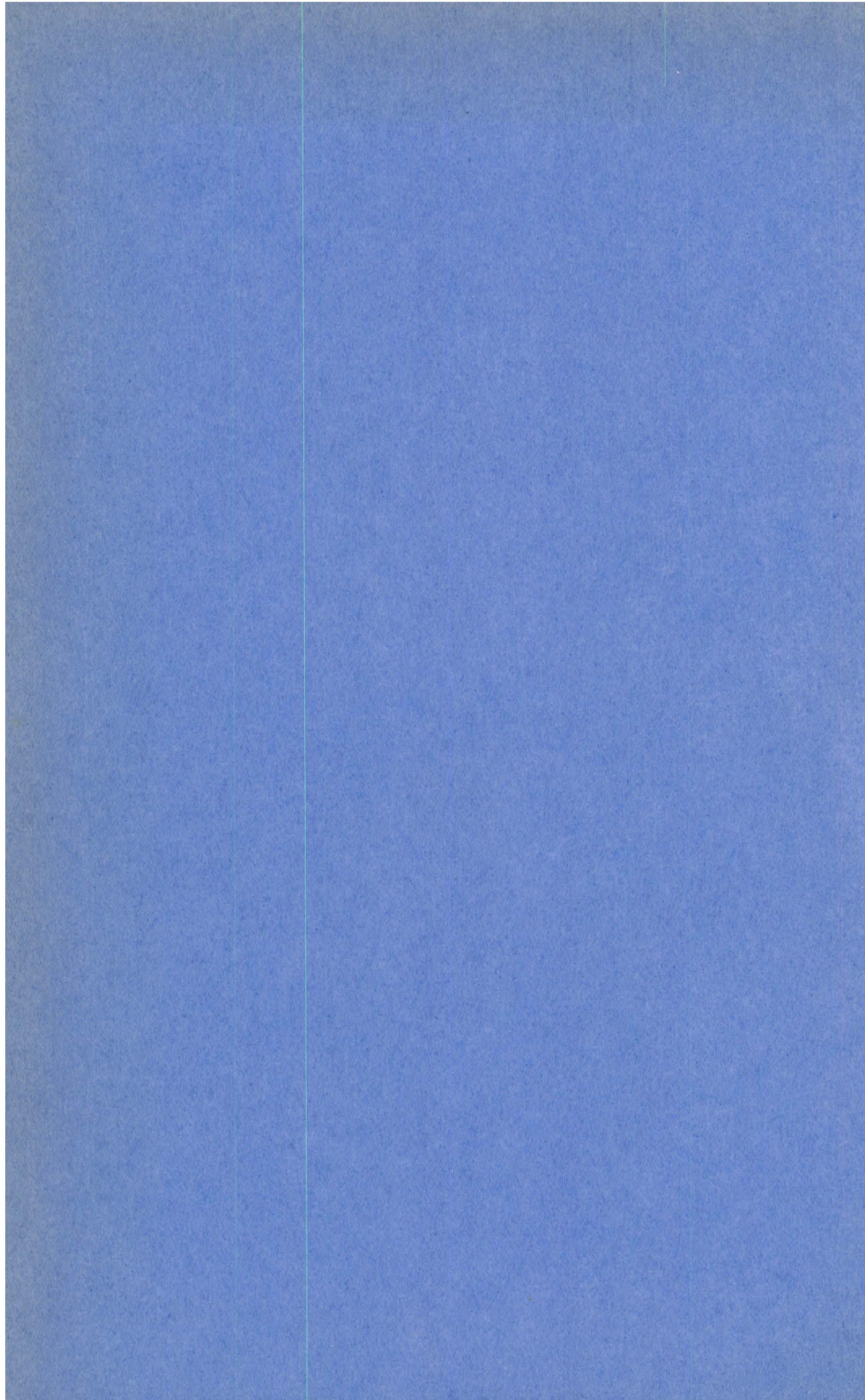

Dear Governor Hildreth:

Because of a delay in making available to you and the members of the legislature the enclosed report of the Maine Commission on Interstate Cooperation for the period January 1, 1943 to January 1, 1945, I am supplementing the report with this letter, enumerating certain changes which have occurred after January 1, 1945.

PERSONNEL

Representative Burton M. Cross of Augusta, by election, became a member of the Senate on January 3, 1945, and was appointed by the President of the Senate as a senate member of the Commission. Representative Joseph E. Sayward of Kennebunk was likewise elected to the Senate and was appointed to the Commission. Senator Lauren M. Sanborn did not seek reelection and Senator Ralph W. Farris automatically ceased to be a member of the Commission by virtue of his election as Attorney General.

Representative Albert A. Poulin, Rumford, was appointed by the Speaker of the House as a member of the Commission, and Representative Clarence S. Crosby of Farmington was likewise appointed. During the latter part of the legislative session Senator Sidney R. Batchelder of York County resigned and Senator John E. Townsend of Bangor was appointed to replace him. CONCLUSION

While the Commission voted not to sponsor any legislation in regard to forest conservation, including regulation of cutting practices, it did endorse the work done during the previous biennium by Commissioner Raymond Rondall of the Forestry Department, and suggested that additional information be obtained about this all important subject.

Conferences sponsored by the Council of State Governments, including the usual biennial meeting of that organization, were curtailed greatly and in most instances cancelled, because of travel restrictions.

In order to provide a continuous record of the Commission's activities, the material contained in this letter will be incorporated in the next biennial report.

PERSONNEL

The Commission was created by Chapter 250 of the Public Laws of 1939 (Chapter 9, Revised Statutes 1944) which established a commission of nine regular members, namely; three state officials to be appointed by the Governor, three members of the Senate to be appointed by the President of the Senate and three members of the House of Representatives to be appointed by the Speaker of the House; all of whom continue without interruption to hold the office by virtue of which they are appointed. The Governor, the President of the Senate and the Speaker of the House are ex officio members of the Commission.

During the period covered by this report the membership of the Commission has remained unchanged. The Hon. Harold I. Goss, Secretary of State, has continued to serve as Secretary of the Commission, and the Hon. David H. Stevens, State Tax Assessor, has remained as Chairman.

There have been several changes in the Committees of the Commission and a complete list of the membership of these Committees is being made a part of this report.

For convenience a copy of the original act creating the Commission (Chapter 250 Public Laws of 1939) is also being included in this report.

FUNCTIONS OF THE COMMISSION

The Maine Commission on Interstate Cooperation is one of forty-four similar state commissions which have for their main objective the sponsoring of either reciprocal or uniform legislation in matters of common interest to the states of the Union. All of the various commissions on interstate cooperation are affiliated with the Council of State Governments and assistance from that organization is readily available upon request by the Maine Commission on Interstate Cooperation. The organization and functions of the Council of State Governments are best described by quoting from the pamphlet published January 1, 1943, by that organization, and entitled "The Council of State Governments":

"The Council of State Governments is a joint governmental agency established by the States, serving the States, and supported by the States.

It is the secretariat for the Governor's Conference, the National Association of Attorneys General, the National Association of Secretaries of States, and it acts as a clearinghouse and research center for legislators, legislative reference bureaus, and for the above national organizations of state officials. In order to carry on its work, the Council maintains offices in Chicago, New York, San Francisco, and Washington, D. C.

It is a medium through which many Federal-State and interstate problems have been resolved and a forum for the consideration of the increasing number of problems growing out of the war emergency, including those which overlap state boundaries; questions of civilian defense, transportation, emergency fiscal problems, rationing, water supply and pollution, conflicting taxation, interstate trade barriers, highway safety, public welfare, and conservation of natural resources. All these matters have been subjects of conferences and reports which are of benefit to each of the States.

The component parts of the Council of State Governments are the Commissions on Interstate Cooperation, established by legislative action in the States. Close relationships are also maintained with the State Councils of Defense. Through these agencies the Council has

demonstrated that this method of cooperation among the several States, and between the States and the Federal Government, is necessary, valuable, and practical, and of increasing importance in winning the War."

ACTIVITIES OF THE COMMISSION

Since the Maine Commission on Interstate Cooperation was established in 1939, it has sponsored several legislative measures recommended by the Council of State Governments. The Commission has also undertaken to assist the Commissioners on Uniform Legislation in securing the passage of uniform legislation recommended by both the Council of State Governments and the Commissioners on Uniform Legislation of this State and other States. There have been several measures of interest from an interstate cooperation standpoint which have been enacted by the State of Maine legislature and not specifically sponsored by the Commission on Interstate Cooperation. For convenience there is listed as part of this report the title and legal reference of the laws now on the statute books of the State of Maine which are of interest from the standpoint of interstate cooperation.

During the period covered by this report the Maine Commission on Interstate Cooperation was interested in the following general subjects: fisheries, forest conservation, social welfare, highway safety, agricultural and dairy products, interstate waters taxation, crime, and war legislation.

Legislation sponsored or supported by the Commission and enacted by the 91st Legislature in 1943 in connection with the above subjects, was, the Reciprocal Warden Act, Bangs' Disease Act relating to cattle entering the State, Fire-Works Control Act, War Housing Act, and while not sponsored by the Commission other legislation as recommended by the Council of State Governments, passed during this session of the legislature, was: Compensation Involving Prior Injury, Temporary Licensing of Physicians, and Acknowledgments Act.

Members of the Commission have attended various regional and national meetings sponsored by the Council of State Governments and the commissions on interstate cooperation of other states, namely, the Commonwealth of Massachusetts, and the State of New York. These

meetings and conferences in every case, were called for the purpose of discussing some specific phase of governmental activity, such as liquor control problems, taxation of property owned by the Federal Government, Highway Safety and Motor Vehicle Problems and conservation as it relates to Flood Control from forestry cutting practices.

In addition to the members of the Commission who attended these meetings various administrative officials of the State of Maine were present and apparently derived considerable benefit from the material discussed and from their contacts with officials of other states. A list of the meetings and those attending, is also being made a part of the report.

CONCLUSION

The State of Maine Legislature has apparently enacted into law a great many of the legislative measures recommended by the Council of State Governments including nearly all of the war legislation which has been suggested. (See list of legislation enacted.) The major objective of the Council of State Governments for both state and local governmental units has been to pay off debts as rapidly as possible and at the same time build up financial reservations for the post-war period. These objectives have been carried out on an extensive scale by both the State of Maine and its political sub-divisions.

Future legislation is recommended along the following lines:

1. Legislation to enable the federal, state and local governmental units to coordinate the administration of taxes for the purpose of eliminating overlapping administrative agencies and the resulting inconvenience to tax payers.
2. Continuing attention to be given to the post-war situation as it develops for the purpose of establishing the proper relationship between federal, state and local governmental units in the matter of post-war construction and any other problems that may arise during that period.

3. Additional study and consideration to be given to conservation problems and more specifically in the State of Maine to forest taxation and cutting practices.
The Atlantic States Marine Fisheries in its efforts to bring about conservative practices in the fisheries industry, should be given such assistance as may be possible by the Commission on Interstate Cooperation.
4. Attention should be given to the problems of social welfare and relief as events in this field, from the standpoint of interstate cooperation, will no doubt transpire rather rapidly during the post-war period. The most specific problem which is emerging in this field is the abandonment of settlement in the distribution of general relief.
5. Because of the very close relationship between the States and Federal Government in the field of highway and motor vehicle transportation, a great deal of thought and consideration should be expended on the problems in this connection and more specifically in the State of Maine. Legislation should be originated to place on the statute books of the state, permission to extend from 40 ft. to 45 ft. the maximum length of tractor-trailer motor truck combinations. The 45 ft. length is now permitted through Executive Order dated August 18, 1942.

The Maine Commission on Interstate Cooperation is grateful for the help and assistance of Mr. Wayne D. Heydecker, former Regional Representative of the Council of State Governments and Mr. David W. Robinson, the present Regional Representative, and also to the staff of the Council of State Governments and the various administrative officers of the State of Maine as well as the members of the various Commissions on Interstate Cooperation in the Northeastern region.

CHAPTER 250 PUBLIC LAWS 1939

AN ACT to Establish an Unpaid Commission to Facilitate the Co- operation of this State with other States.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF MAINE AS
FOLLOWS:

Sec. 1. MAINE COMMISSION ON INTERSTATE CO-OPERATION, established. There is hereby established the Maine commission

on interstate co-operation. The commission shall be composed of 9 regular members; namely, 3 state officials to be appointed by the governor, 3 members of the senate to be appointed by the president of the senate, and 3 members of the house of representatives to be appointed by the speaker of the house of representatives. The governor, the president of the senate and the speaker of the house of representatives shall be ex officio members of the commission.

Sec. 2. TENURE OF OFFICE. The members appointed by the governor shall hold office as members of the commission so long as they shall continue to hold the respective state offices by virtue of which they shall have been appointed. The members appointed from the senate shall hold office as members of the commission so long as they shall continue without interruption to be members of the senate and the members appointed from the house of representatives shall continue to hold office as members of the commission so long as they shall continue without interruption to be members of the house of representatives.

Sec. 3. ORGANIZATION AND PROCEDURE. The commission shall organize by the choice of 1 of its members to be its chairman and of 1 of its members to be its secretary. The commission may enact such rules governing its procedure and the conduct of its affairs not inconsistent with law as it may see fit.

Sec. 4. FUNCTIONS OF THE COMMISSION. It shall be the function of this commission:

- (1) To carry forward the participation of this state as a member of the Council of State Governments.
- (2) To encourage and assist the legislative, executive, administrative and judicial officials and employees of this state to develop and maintain friendly contact by correspondence, by conference, and otherwise, with officials and employees of other states, of the federal government and of local units of government.
- (3) To endeavor to advance cooperation between this state and other units of government whenever it seems advisable to do so by formulating proposals for, and by facilitating:

- (a) The enactment of uniform or reciprocal statutes.
 - (b) The adoption of uniform or reciprocal administrative rules and regulations.
 - (c) The informal co-operation of governmental offices with one another.
 - (d) The personal co-operation of governmental officials and employees with one another, individually.
 - (e) The interchange and clearance of research and information, and
 - (f) Any other suitable process.
- (4) In short, to do all such acts as will, in the opinion of this commission, enable this state to do its part in forming a more perfect union among the various governments in the United States and in developing the Council of State Governments for that purpose.

Sec. 5. COMMISSION TO FORM CERTAIN COMMITTEES. The commission shall have power to establish such delegations and committees as it deems advisable (whose members may or may not be made up from the members of the commission, from state officials or from private citizens), such delegations or committees to be charged with the duty of conferring and formulating proposals concerning effective means to secure interstate harmony and of performing such other functions for the commission as it may from time to time require.

Sec. 6. REPORTS: TO SERVE WITHOUT COMPENSATION. The commission shall report to the governor within 15 days after the convening of each regular legislative session, which report shall be transmitted by the governor to the legislature, and it may report to the governor at such other times as it deems appropriate. Its members and the members of all delegations and committees which it establishes shall serve without compensation for such service.

Sec. 7. OTHER STATES TO BE NOTIFIED. The secretary of state shall forthwith communicate the text of this measure to the governors of the several states of the union.
