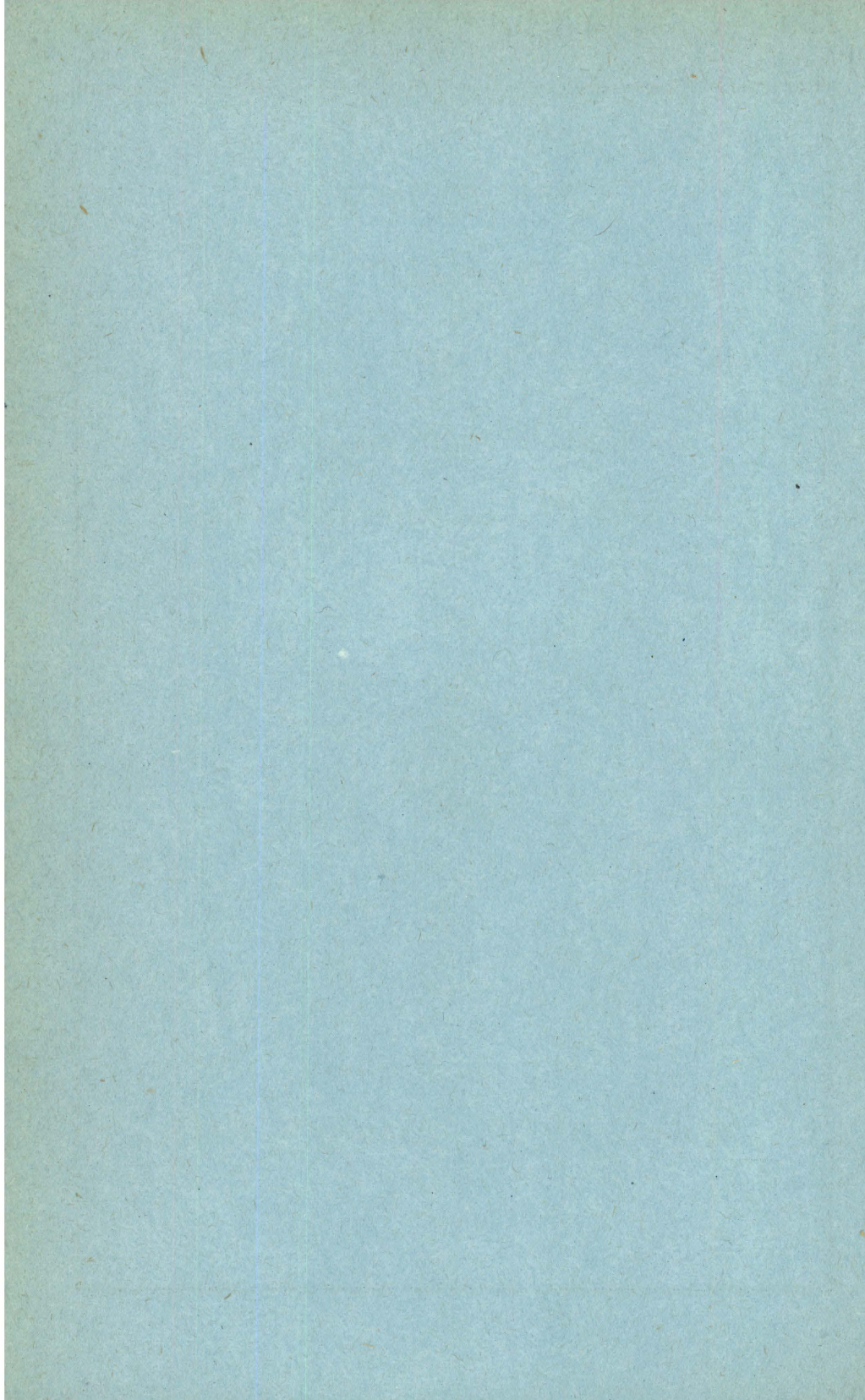

PERSONNEL

The Commission was created by Chapter 250 of the Public Laws of 1939 (Chapter 9, Revised Statutes 1944) which established a commission of nine regular members, namely: three state officials to be appointed by the Governor, three members of the Senate to be appointed by the President of the Senate and three members of the House of Representatives to be appointed by the Speaker of the House; all of whom continue without interruption to hold the office by virtue of which they are appointed. The Governor, the President of the Senate and the Speaker of the House are ex officio members of the Commission.

Representative Burton M. Cross of Augusta, a member of the Commission on Interstate Cooperation in the House, by election, became a member of the Senate. Representative Joseph T. Sayward of Kennebunk was likewise elected to the Senate and was appointed to the Commission. Senator Lauren M. Sanborn did not seek re-election and Senator Ralph W. Farris automatically ceased to be a member of the Commission by virtue of his election as Attorney-General.

Representative Albert A. Poulin, Rumford, was appointed by the Speaker of the House as a member of the Commission, and Representative Clarence S. Crosby of Farmington was likewise appointed. During the latter part of the 1945 legislative session, Senator Sidney R. Batchelder of York County resigned and Senator John E. Townsend of Bangor was appointed to replace him.

There have been several changes in the Committees of the Commission and a complete list of the membership of these Committees is being made a part of this report.

For convenience, a copy of the original act creating the Commission (Chapter 250 Public Laws of 1939) is also being included in this report.

FUNCTIONS OF THE COMMISSION

The Maine Commission on Interstate Cooperation is one of forty-four similar state commissions which have for their main objective the sponsoring of either reciprocal or uniform legislation in matters of common interest to the states of the Union. All of the various commissions on interstate cooperation are affiliated with the Council of State Governments and assistance from that organization is readily available upon request by the Maine Commission on Interstate Cooperation.

The Council of State Governments, representative of the forty-eight Commissions and Committees on Interstate Cooperation, has three major objectives: (1) to do everything possible to improve state government; (2) to encourage and promote full cooperation among the states in the solution of interstate problems; and (3) to facilitate federal-state relations with respect to common problems and objectives.

Five special national committees of state legislative and administrative officials have been at work during this 1945-47 biennium and are now preparing to submit recommendations. These committees are:

1. **On Tax and Fiscal Policy:** Carrying forward earlier and authoritative work in this field, definite and constructive suggestions for the improvement of state tax structures and fiscal policies in this postwar period will be referred to the states for action.

2. **On State-Local Relations:** This acute postwar problem has been examined from three points of view: (a) the constitutional and statutory provisions in the states which affect the problem; (b) the tax and fiscal relationship existing between the states and their localities; and (c) the functional and administrative situation that exists in the several states. A report, with recommendations, is now being prepared for state consideration and action.

3. **On Water Resources:** A tentative and preliminary report pertaining to the development and use of water resources in interstate river basins, with a suggested course of action for the states, has been prepared.

4. **On Insurance:** Federal legislation requiring the states to perfect their regulatory machinery in the insurance field or face the loss of this administrative function to federal agencies has caused a special committee of the Council to assemble and analyze the great quantities of information published in this field for use by state agencies.

5. **On Legislative Processes and Procedures:** All states have indicated a substantial interest in the modernization of their legislative organizations. A comprehensive report covering recent trends and practices has been prepared and will be available for state consideration during the forty-four legislative session of 1947.

National programs affecting airports, veterans, public works, social security, education, taxation, control of lands, surplus property, have required the attention of the states joint agency during the past two years and will continue to command its interest in the direction of strengthening a federal-state cooperative plan of administering national programs.

A suggested program of state legislation has been prepared for 1947, including:

1. Channeling of Federal Airport Funds Act
2. Municipal Airports Act
3. Hospital Survey and Construction Act
4. Investments in Securities of the International Bank Act
5. Act Relating to Minority of Veterans
6. Second Injury Fund Act Amendment
7. State School Lunch Act

These and other proposals as developed and proposed by the Council's Drafting Committee will be placed before the state legislatures in 1947.

Regional activities, the conservation of fish and fisheries (through the Atlantic States Marine Fisheries Commission), highway and motor vehicle problems, social welfare activities, alcoholic beverage control, these and similar fields of interest, continue to develop and progress toward solution through the medium of interstate cooperation.

ACTIVITIES OF THE COMMISSION

Since the Maine Commission on Interstate Cooperation was established in 1939, it has sponsored several legislative measures recommended by the Council of State Governments. The Commission has also undertaken to assist the Commissioners on Uniform Legislation in securing the passage of uniform legislation recommended by both the Council of State Governments and the Commissioners on Uniform Legislation of this State and other States. There have been several measures of interest from an interstate cooperation standpoint which have been enacted by the State of

Maine Legislature and not specifically sponsored by the Commission on Interstate Cooperation. For convenience, there is listed again as part of this report the title and legal reference of the laws now on the statute books of the State of Maine which are of interest from the standpoint of interstate cooperation.

Several legislative measures recommended by the Council of State Governments were adopted by the 92nd Maine Legislature, as follows:

CONCLUSION

During the past biennium, the Forestry Department of the State of Maine and the Bureau of Taxation have continued to carry on studies in connection with the effect of forest cutting regulations and forest land taxation. While no legislation was sponsored by the Commission on Interstate Cooperation during the 92nd Legislature in regard to forest conservation, the Commission did endorse the work done during the previous biennium by Commissioner Raymond Rendall of the Forestry Department and suggested additional information be obtained about this all-important subject. No doubt legislation should be originated during the 93rd Legislature to make a start at least in the matter of bringing about forest conservation in the State of Maine.

Another very important source of income to the citizens of the State is the fisheries industry. The Commission on Interstate Cooperation should, without a doubt, continue to give such assistance as may be possible to the Atlantic States Marine Fisheries Commission, an organization sponsored by the Council of State Governments and made up of those States on the eastern seaboard, which has for its purpose the advancement of better regulations and knowledge of fisheries. This subject is of particular importance to the State of Maine and one that should receive every consideration.

Problems in connection with social welfare and relief will no doubt be intensified as income payments and productivity slack off. Attention should be given to the effect of these problems from the interstate standpoint and more particularly to the growing trend that settlement should be abandoned in the distribution of general relief.

The State of Maine seems to be in conformity in the matter of its relations with other states in the field of highway and motor vehicle transportation. Legislation should be originated to be placed on the statute books of the state, permission to extend from 40 ft. to 45 ft. the maximum length of tractor-trailer motor truck combinations. The 45 ft. length is now permitted through Executive Order dated August 18, 1942, and still in effect.

The Maine Commission on Interstate Cooperation is grateful for the help and assistance of David W. Robinson, Regional Representative of the Council of State Governments and also to the staff of the Council of Governments and the various administrative officers of the State of Maine as well as the members of the various Commissions on Interstate Cooperation in the Northeastern region.

CHAPTER 250 PUBLIC LAWS 1939

**AN ACT to Establish an Unpaid Commission to Facilitate the
Cooperation of this State with other States.**

BE IT ENACTED BY THE PEOPLE OF THE STATE OF MAINE
AS FOLLOWS:

Sec. 1. MAINE COMMISSION ON INTERSTATE CO-OPERATION, established. There is hereby established the Maine commission on interstate cooperation. The commission shall be composed of 9 regular members, namely: 3 state officials to be appointed by the governor, 3 members of the senate to be appointed by the president of the senate, and 3

members of the house of representatives to be appointed by the speaker of the house of representatives. The governor, the president of the senate and the speaker of the house of representatives shall be ex officio members of the commission.

Sec. 2. TENURE OF OFFICE. The members appointed by the governor shall hold office as members of the commission so long as they shall continue to hold the respective state offices by virtue of which they shall have been appointed. The members appointed from the senate shall hold office as members of the commission so long as they shall continue without interruption to be members of the senate and the members appointed from the house of representatives shall continue to hold office as members of the commission so long as they shall continue without interruption to be members of the house of representatives.

Sec. 3. ORGANIZATION AND PROCEDURE. The commission shall organize by the choice of one of its members to be its chairman and of one of its members to be its secretary. The commission may enact such rules governing its procedure and the conduct of its affairs not inconsistent with law as it may see fit.

Sec. 4. FUNCTIONS OF THE COMMISSION. It shall be the function of this commission:

- (1) To carry forward the participation of this state as a member of the Council of State Governments.
- (2) To encourage and assist the legislative, executive, administrative and judicial officials and employees of this state to develop and maintain friendly contact by correspondence, by conference, and otherwise, with officials and employees of other states, of the federal government and of local units of government.
- (3) To endeavor to advance cooperation between this state and other units of government whenever it seems advisable to do so by formulating proposals for, and by facilitating:
 - (a) The enactment of uniform or reciprocal statutes.
 - (b) The adoption of uniform or reciprocal administrative rules and regulations.
 - (c) The informal cooperation of governmental offices with one another.
 - (d) The personal cooperation of governmental officials and employees with one another, individually.

- (e) The interchange and clearance of research and information, and
 - (f) Any other suitable process.
- (4) In short, to do all such acts as will, in the opinion of this commission, enable this state to do its part in forming a more perfect union among the various governments in the United States and in developing the Council of State Governments for that purpose.

Sec. 5. COMMISSION TO FORM CERTAIN COMMITTEES. The commission shall have power to establish such delegations and committees as it deems advisable (whose members may or may not be made up from the members of the commission, from state officials or from private citizens), such delegations or committees to be charged with the duty of conferring and formulating proposals concerning effective means to secure interstate harmony and of performing such other functions for the commission as it may from time to time require.

Sec. 6. REPORTS: TO SERVE WITHOUT COMPENSATION. The commission shall report to the governor within 15 days after the convening of each regular legislative session, which report shall be transmitted by the governor to the legislature, and it may report to the governor at such other times as it deems appropriate. Its members and the members of all delegations and committees which it establishes shall serve without compensation for such service.

Sec. 7. OTHER STATES TO BE NOTIFIED. The secretary of state shall forthwith communicate the text of this measure to the governors of the several states of the union.
