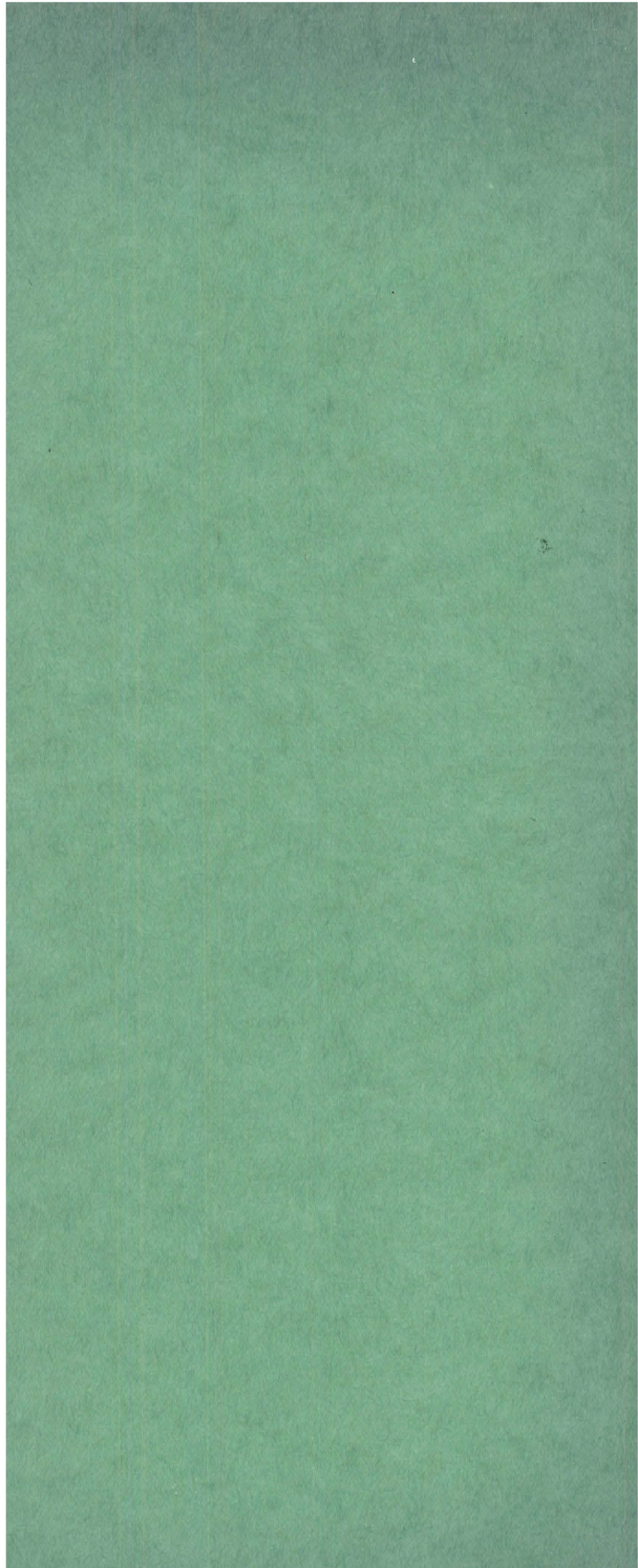

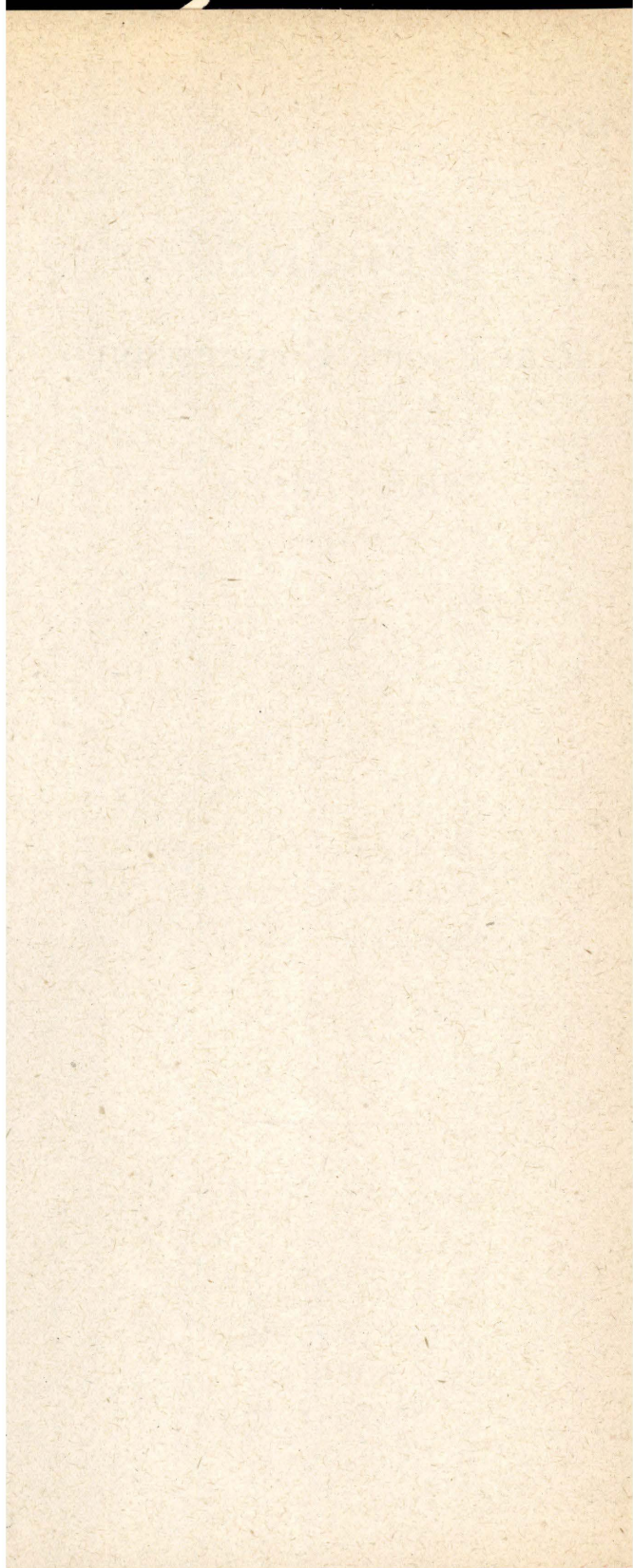

FOREWORD

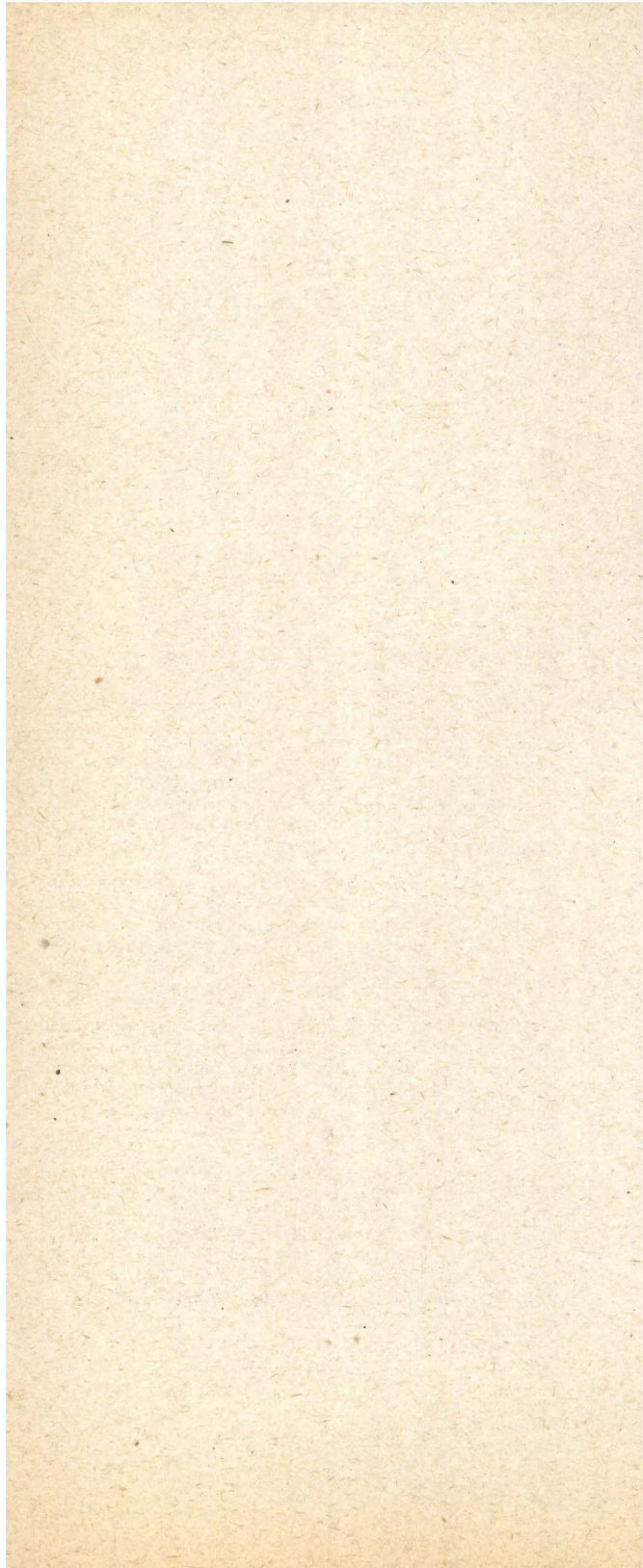
