INTRODUCTION

Whether it was hiking, walking, biking, camping, hunting, fishing, or utilizing recreational vehicles – the outdoor boom was still present and at times still burdening our public and private landowners.

The Landowner Relations Program continued to provide support to numerous landowners who reached out for assistance with signage or guidance on how to better control who was actively using their land. Additionally, the program worked with game wardens across the state to investigate and resolve cases of land abuse.

In effort to take a more proactive outreach approach, we worked closely with the Department’s Information and Education division to perform a targeted outreach effort to landowners to increase their awareness of the program. The effort resulted in a larger and broader email distribution list for the program to utilize when sharing helpful information to Maine’s landowners. Additionally, the outreach effort helped to gain a better picture of landowner’s current needs. The results of the included survey showed a high level of interest in additional information about managing habitat for both game and non-game species as well as forest management.

The Landowner Relations and Keep Maine Clean programs remain a top priority for MDIFW. Throughout the year we have been successful in cleaning up countless dump sites around the state with the largest effort focused on the annual Landowner Appreciation Day which occurs every fall. The success of these two programs is paramount in continuing the free and open access to private lands. We are now considering ways to increase participation in the annual event, such as moving it to a date in the spring or offering two days. Several other ideas may include having food trucks at each dumpster location bringing landowners in for an appreciation meal.

There will always be a need to provide the “one on one” attention Maine landowners deserve. We recognize the fragility of these relationships because without their cooperation we would all lose an important tradition we have all enjoyed. The very thing that makes Maine a great state to live in, could be gone if not nurtured. Let us not forget to respect Maine’s landowners.

Landowner Specialists Rick LaFlamme and Kris MacCabe field many calls from the public, department biologists, warden staff, DACF staff, ATV / Snowmobile clubs and private landowners throughout the year. The calls are handled or vetted by the appropriate personnel or advice is given to remedy the problem. There are times when the complaint is handled in house and special attention is given to the complainant, which is usually a landowner.

Large Landowners

Training:

- Met with new warden cadets for landowner relations training
- Built 8 new LOR gear bags and distributed them to the new wardens and training component
- Training for department sponsored outdoor ethics class (landowner relations portion)
- Finished all annual training required of the Maine Criminal Justice Academy

Education/Outreach:

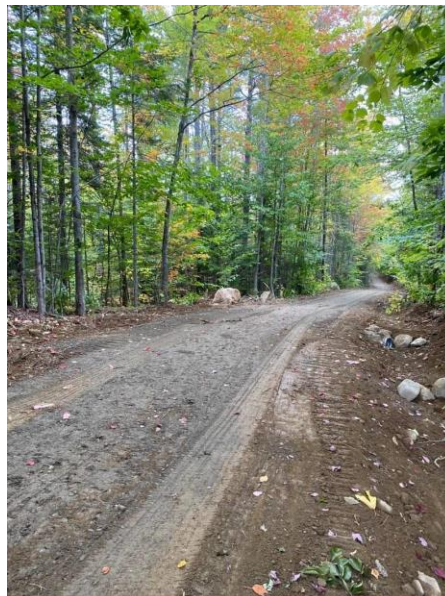
- Attended the 4th annual American Forest Management Bear meeting with their staff all permitted hunters and IFW staff.
- Attended the annual spring veteran's turkey hunt at Pineland in Gray.
- Assisted and organized staff with an Aroostook County landowner who coordinates the Veteran's Moose hunt in mid-September.

Landowner Issues:

- Meetings with landowners and snowmobile club in Glenburn to discuss future trail re-route. Worked with warden Rick Ouellette for enforcement and signs in the closed area
- Assisted a landowner in Milford with gate and signs to keep ATV trail open
- Met with large turf farm owner in southern Maine again this year due to a yearly problem with geese. Unfortunately, they don't qualify for depredation permit (not considered agricultural) Provided hazing information and cracker shells for deterrent
- Met with Shady Nook Lake Association to discuss open lands for hunting and lake association. Reviewed all bylaws, maps and documents to assist with mirroring state law
- Assist wind tower landowners in Bingham with abuse issues. Supplied cell cameras and LOR overtime to staff in that region. Most of damage has been done by vehicles, Towers have been shot and defaced
- Worked with large landowner in Hollis in conjunction with staff and snowmobile club to resolve land abuse issue Warden staff installed cameras and caught violators
- Assisted warden staff and landowner with installing a couple of gates, that were being misused by motorized vehicles
- Meetings with warden staff and Weyerhaeuser, on land use policies and discussions about electronic mapping of recreation trails
- Attended meeting with Brian Bronson regarding discontinued town roads and ATV use in Maddison
- Assisted several landowners with depredation permits for nuisance wildlife
- Worked on joint project with Piscataquis County Water District, KI riders ATV club on fixing a road access to "the look out, and outdoor classroom" Repaired Road for all access

Administrative:

- Meeting with Snowmobile council, MSA, and Joe Higgins to discuss future of Backwoods and off trail riding (Came up with verbiage for new law proposal from MSA)

- Assisted DACF with nuisance beaver, at several locations across the state
- Meetings with Maine woodland owner’s executive director and asst. director
- Phone conference with Executive Director of North Maine Woods
- Obtained several more motion sensor propane cannons to assist farmers & landowners with wildlife conflicts Approximately 16 cannons now offered on a loaner program
- We purchased and delivered 15 thousand signs, which included the Access by Permission, No Motorized Vehicles, “No discharge of firearms in this area, Access Permitted, and Safety Zone signs that are available to landowners for the upcoming year. We work to identify the landowner needs and use the signs to address misuse of their land
- We purchased 40 more live feed cameras to assist landowners with misuse issues
- Purchased 4 more electric mountain bikes for warden staff in the Ashland, Bangor and Gray regions. To deal with patrolling some more remote areas. Operation Game Thief also purchased two more.

Landowner Relations Program Mission Statement

Prioritize and address Maine's landowner concerns by quickly responding with assistance and enforcement while continuing to educate and bring awareness to all land users.

Program Funding

The use and access to private lands is unique to the Northeast and is of extreme importance to the State of Maine and its economy. The open and free access has been a longstanding tradition in which we all rely upon. The practice has been a long accepted and welcomed partnership amongst most landowners and users. This historical practice of free, public access to private lands has been acknowledged to be significant by the State of Maine as it relates to its citizens and economic well-being.



The initial creation of the Landowner Relations {LOR} Program approximately 27 years ago and newly created Keep Maine Clean {KMC} Program; was a direct result of the Legislature's understanding of the importance of the free access given graciously by Maine's private landowners. In 2018, MDIFW – Warden Service with support of the Landowner Sportsman Relations Advisory Board added another Landowner Specialist position to the program.

The following are funding sources the two programs have utilized for personal services, capital equipment, general expenses, etc. The "Support Wildlife" motor vehicle registration, the yearly \$150,000 General Fund

allotment, and the Outdoors Partners program helps ensure the mission of the two programs {which share the funding} will continue well into the future and provide benefits to the landowners and land users of this great State of Maine.

This access can never be forsaken or taken for granted. At times, it has and will continue to take substantial funding to ensure we can continue to provide remedies to issues regarding private lands. Since 2018 the Landowner Relations and Keep Maine Clean Programs spend on average \$180,000.00 plus annually. This money is utilized for enforcement details, essential capital equipment, landowner needs and other services, as well as a sign program which provides a variety of signs, usually at no charge to the landowner. Any surplus money that is not utilized goes directly back to the LOR/KMC dedicated account and is able to be used later by the programs.

It would be extremely detrimental to make any eliminations or changes to the funding. This would undermine these two programs that have direct impact to the State's economy and its citizens.

Outdoor Partners Program



The Outdoor Partners program provides an opportunity for the outdoor users to donate to the Landowner Relations and Keep Maine Clean Programs. It is a \$15 yearly contribution and is available through the Department of MDIFW online store or at the time of license purchase. We also offer for sale, Outdoor Partner decals and hats of various colors and patterns. We had **1,673** participants in 2022 showing that the numbers for participation are holding steady to prior years.

KEEP MAINE CLEAN PROGRAM

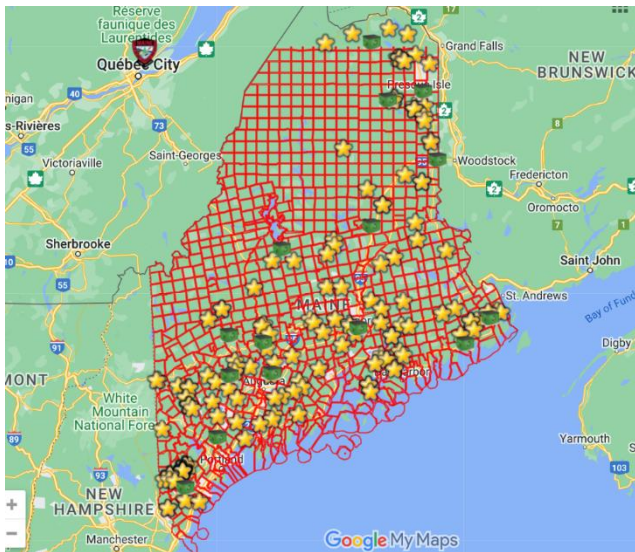
Keep Maine Program was established and placed within the Landowner Relations Program of Inland Fisheries and Wildlife. The sole purpose is to provide relief and assistance to Maine's landowners with illegal dumping {littering} issues. These illegal acts are a main reason for the POSTING of private property.

With the assistance and partnerships of the Maine Forest Service, BDS Tire and Waste Management the annual Landowner Appreciation Day which occurred on September 18th was a success. This litter is no longer on Maine's landscape thanks to the program and the volunteers.

The Keep Maine Clean Program is an essential and integral part for Landowner Relations and shall continue well into the future, to ensure we always Keep Maine Clean.

15 large dumpsters were filled statewide totaling **32.01 + tons of litter**; this does not include the tire totals listed below, which was taken by BDS tire disposal company in Fairfield Maine, for absolutely free! This phenomenal total of trash and tires were picked up within a day totally dedicated to Maine's landowners.

- Ensure the importance of landowner relations and its program mission is delivered to the public

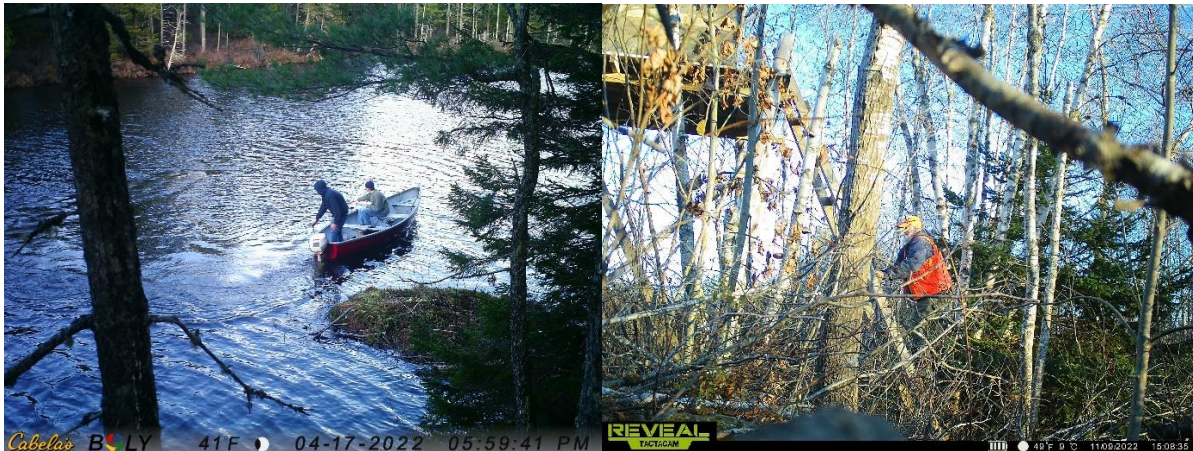

We would also like to extend our sincere gratitude to all State of Maine employees, volunteers, and outdoor recreationalist who go out every day to help, educate or respect Maine’s Landowners and Keep Maine Clean.

Landowner Relations and the Department’s I&E worked together to have a larger social media presence to address issues surrounding land use by non-traditional users. The selling and mailing of signs and merchandise increased dramatically. We also reached out and campaigned specifically to landowners – it was well received with over 1,000 landowners signing up for the program / communication.

2022 Landowner Relations – Maine Game Wardens

Warden Joe McBrine is a continuous landowner advocate for the area he patrols in Washington County. He spends a significant amount of his time ensuring landowners have their issues resolved. Below are examples of how he used the latest cell camera technology to illegal fishing activity and placing a game camera under a search warrant to apprehend a person who is revoked for hunting over bait in 2021. He was charged for Hunting while revoked and Hunting Over Bait (Again).

Other Violations captured by Game Wardens included:

Landowner Relations Program

- Game Warden Matthew Tenan in a pre-season bear baiter who we arrested on a warrant that was caught using your camera.
- Game Warden Matthew Tenan with a bear bait that was unlabeled and reported as on another's property that the person was apprehended using your cameras.
- Warden Scott Martin Investigated a skidder that had been stolen to pull out a truck that was stuck. The skidder had been driven over 16 miles to get the vehicle out causing damage to the road. The subject was charged with Criminal Mischief.

LOR Program / Warden Service – 2022 Veterans controlled moose, deer, and turkey hunts. Getting people outdoors to heal and give them an opportunity of a lifetime.



New Technology used by the Landowner Relations Program

We have continued to build the Landowner relations program with new technology that we feel useful for assisting with Landowner complaints in the field. We have continued to purchase cell cameras with 50 new Tactacam Reveal cameras being purchased in the past year. We also partnered with Operation Game Thief this year on the purchase of 6 more Rambo E-Bikes for low impact patrol. LOR funds purchased 4 of the bikes and OGT purchased two more with two more to be purchased in the spring of 2023 by OGT.

In 2022 we saw an increased request by landowners for propane cannons throughout the state. With the increased requests we discovered it was difficult to track where the 15+ cannons we own were placed throughout the state. In 2023 the Propane cannons will be fitted with a Apple Airtag to track the locations so we can move them to other locations nearby if needed.

We also purchased several Sky-High Game camera mounting systems to try to work with in the field and test to move away from climbing trees or using ladders.


Outreach and Education

The Landowner Relations corporals continue to work with Information and Education Division staff to educate both land users and landowners. Utilizing digital methods such as email communication, social media, and targeted digital ads, the Department can reach a specific targeted audience based on location, interests, and license or registration type at a specific time, such as the start of the fall hunting season or just before a long holiday weekend.

In 2022, the Department sent information to more than 60,000 snowmobilers who have snowmobiled in Maine within the past five years. Messages reminded snowmobilers that more than 95% of the 14,000 miles of trails are on private land, to stay on marked trails, modified exhausts are illegal, and other safe riding reminders. Information was sent through three separate emails (with nearly 30,000 unique people opening each message) and posted on Facebook and Instagram.

ATV reminders begin as soon as mud season begins in southern Maine, reminding excited ATV owners that trails do not open until May/June and to always check with a local club before making plans to ride. During the ATV season the Department sent information to more than 70,000 recent ATV registration holders, with reminders prior to each holiday long weekend. Messages remind riders of private landownership, to stay on marked trails, multi-use trails, to be mindful of dust on camp roads, access route laws, and other safe riding tips. Four ATV-related emails were sent in 2022, averaging around 30,000 unique individuals opening each message.

MDIFW regularly communicates with more than 200,000 licensed hunters and recent hunter education participants, sending multiple messages each month. On average, 75,000-100,000 hunters open each message. Landowner relations messaging is included in almost all hunter related messages, focusing on always asking for permission, and proper use of land. Each year, the message is customized based on themes wardens in the field are seeing or requests from stakeholder groups. This year the Department was

- Follow the rules and ride safe.



The Department also sends monthly fishing reports to more than 300,000 anglers, often including seasonal reminders on how to respect private landowners. For the past two years, the Department has sent private land law reminders to trappers. In all safe hiking reminders, outdoor enthusiasts are reminded to respect private landowners and always clean up after themselves.

The theme of the MDIFW booth at the 2022 Fryeburg Fair was landowner relations. The booth featured a map that illustrated Maine's private vs. public land, increasing the public's awareness that much of the land they recreate on is owned by individuals or corporations.
