A U T H O R I Z A T I O N

Maine Revised Statutes 1964, Title 26, § 42, 43, 46: "The department shall collect, assort and arrange statistical details relating to . . . industrial pursuits in the State. The Commissioner . . . may . . . cause to be printed and distributed bulletins . . . that shall be of public interest and benefit to the State."

C O V E R A G E

This survey, insofar as possible, is of universal coverage for Maine manufacturing establishments ranging from the single proprietorships to the largest corporations. Reports covering 2174 establishments were received since the original mailing January 2, 1973. Of these, 223 are in the combined reporting category, and 276 either did not operate or went out of business in 1972.

Final tabulations, according to the major breakdown, will appear as usual in the next Census. These tabulations will include the late reports which are not included in this Census.

Taking into consideration the nature of the Maine economy and the extent of coverage in this survey, the data contained in this, The Census of Maine Manufactures 1972, represent a comprehensive and valid statistical analysis of the Maine manufacturing economy.




PER CENT DISTRIBUTION of Product Value by Industry

F O R E W O R D

The following summary is based on 2,032 reports, or 97.8% of the total included in the survey that were received prior to the time of printing. Statistical data in this report are published on this basis, and adjustments for late reports are made in succeeding years' publications. Limitations for the current year, therefore, should be borne in mind.

S U M M A R YVALUE OF PRODUCT INCREASES \$254.2 MILLION

Maine manufacturing firms reported a product value of \$2,689.2 million, an increase of \$254.2 million, or 10.4% from the \$2,435.0 million reported in 1971.

NUMBER OF WORKERS DECLINES 0.3%

The number of workers (executives excluded) in Maine manufacturing establishments declined 0.3%, or 300, from 101,809 reported in 1971 to 101,509 reported in 1972. Male workers declined 5, from 68,509 in 1971 to 68,504 in 1972; and female workers dropped 295, from 33,300 in 1971 to 33,005 in 1972.

FOUR PRINCIPAL INDUSTRIES REPORT INCREASED VALUE OF PRODUCT

Four of the principal industries, Paper, Food, Lumber and Wood, and Textiles, reported an increased value of product of 11.3%, 8.4%, 15.1%, and 17.7%, respectively. The remaining principal industry, Leather, reported a decrease of 2.9%.

THREE PRINCIPAL INDUSTRIES REPORT INCREASE IN NUMBER OF WORKERS

Three of the principal industries, Paper, Lumber and Wood, and Textiles, reported increases in number of workers of 3.8%, 4.5% and 0.9%, respectively. The two remaining principal industries, Leather and Food, reported decreases of 10.0% and 1.1%, respectively.

VALUE OF PRODUCT INCREASES 23.3% in AROOSTOOK COUNTY

The value of product for Aroostook County increased 23.3%, or \$42.9 million more than the previous year. Manufacturing firms operating in Cumberland County reported the largest value of product with a total of \$517.2 million.

GROSS WAGES INCREASE 5.6%

The total gross wages paid workers (executives excluded) in manufacturing firms increased 5.6%, or \$36,127,812, from \$644,559,716 in 1971 to \$680,687,528 in 1972. This was considerable improvement over 1971 when the total gross wages reported showed a decrease over the prior year.

AVERAGE GROSS WAGE INCREASES 5.9%

During the year, the average gross wage increased 5.9%, or \$375, from \$6,331 in 1971 to \$6,706 in 1972. The Transportation Equipment industry paid the highest wages with a calculated average gross wage of \$9,812, while, during the same period, the Apparel industry paid the lowest with an average gross wage of \$4,405.

UNION COVERAGE

The number of workers covered by union contract dropped 2.2%, or 769, from 35,115 in 1971 to 34,346 in 1972. The Paper industry reported 13,572 workers covered by union contract, or 39.5% of the total.

CAPITAL EXPENDITURES UP 10.1%

Maine manufacturing firms reported capital expenditures of \$146,631,000 for plant modernization and equipment during 1972. This is an increase of \$13,410,000, or 10.1% over the \$133,221,000 reported in 1971. Planned capital expenditures were reported as \$121,873,000 in 1973 and \$89,644,000 in 1974. The Paper industry continues to lead with a reported investment of \$72,895,000, or 49.7% of the total reported.

- 19 **ORDNANCE AND ACCESSORIES** This major group includes establishments engaged in manufacturing artillery, small arms, and related equipment; ammunition; tanks and specialized tank parts; sighting and fire control equipment; and miscellaneous ordnance and accessories, nec.
- 20 **FOOD AND KINDRED PRODUCTS** This major group includes establishments manufacturing foods and beverages for human consumption, and certain related products, such as manufactured ice, chewing gum, vegetable and animal fats and oils, and prepared feeds for animals and fowls.
- 22 **TEXTILE MILL PRODUCTS** This group includes establishments engaged in performing any of the following operations: (1) preparation of fiber and subsequent manufacturing of yarn, thread, braids, twine, and cordage; (2) manufacturing broad woven fabric, narrow woven fabric, knit fabric, and carpets and rugs from yarn; (3) dyeing and finishing fiber, yarn, fabric, and knit apparel; (4) coating, waterproofing, or otherwise treating fabric; (5) the integrated manufacture of knit apparel and other finished articles from yarn; and (6) the manufacture of felt goods, lace goods, bonded-fiber fabrics, and miscellaneous textiles.
- This classification makes no distinction between the two types of organizations which operate in the textile industry; (1) the "integrated" mill which purchases materials, produces textiles and related articles within the establishment, and sells the finished products; and (2) the "contract" or "commission" mill which processes materials owned by others. Converters or other nonmanufacturing establishments which assign materials to contract mills for processing (other than

knitting) are classified in nonmanufacturing industries; establishments which assign yarns to outside contractors or commission knitters for the production of knit products are classified as Knitting Mills.

23 **APPAREL AND OTHER FINISHED PRODUCTS MADE FROM FABRICS AND SIMILAR MATERIALS** This major group, known as the cutting-up and needle trades, includes establishments producing clothing and fabricated products by cutting and sewing purchased woven or knit textile fabrics and related materials such as leather, rubberized fabrics, plastics and furs.

Included in the apparel industries are three types of establishments; (1) the "regular" or inside factories, (2) contract factories, and (3) apparel jobbers. The regular factories perform all of the usual manufacturing functions within their own plant; the contract factories manufacture apparel from materials owned by others; and apparel jobbers perform the entrepreneurial function of a manufacturing company such as buying raw materials, designing and preparing samples, arranging for the manufacture of the garments from their materials and selling of the finished apparel.

Custom tailors and dressmakers not operating on a factory basis are classified in nonmanufacturing industries; establishments which purchase and resell finished garments but do not perform the functions of the apparel jobbers are classified in Wholesale trade.

24 **LUMBER AND WOOD PRODUCTS, EXCEPT FURNITURE** This major group includes logging camps engaged in cutting timber and pulpwood; merchant sawmills, lath

mills, shingle mills, cooperage stock mills, planing mills, and plywood mills and veneer mills engaged in producing lumber and wood basic materials; and establishments engaged in manufacturing finished articles made entirely or mainly of wood or wood substitutes. Certain types of establishments producing wood products are classified elsewhere. For example, furniture, and office and store fixtures are classified in FURNITURE; pianos, musical instruments, toys and playground equipment, and caskets and coffins in MISCELLANEOUS MANUFACTURING. Woodworking in connection with construction in the nature of reconditioning and repair, or performed to individual order, is classified in nonmanufacturing industries.
- 25 FURNITURE AND FIXTURES This major group includes establishments engaged in manufacturing household, office, public building, and restaurant furniture; and office and store fixtures. Establishments primarily engaged in the production of millwork are classified in Millwork; cut stone and concrete furniture in STONE, CLAY, GLASS, AND CONCRETE PRODUCTS; laboratory and hospital furniture in PROFESSIONAL, SCIENTIFIC, AND CONTROLLING INSTRUMENTS; beauty and barber shop furniture in MISCELLANEOUS MANUFACTURING; and woodworking to individual order or in the nature of reconditioning and repair in non-manufacturing industries.
- 26 PAPER AND ALLIED PRODUCTS This major group includes the manufacture of pulps from wood and other cellulose fibers, and rags; the manufacture of paper and paperboard; and the manufacture of paper and paperboard into converted products such as paper coated off the paper machine, paper bags, paper boxes, and envelopes. Certain types of converted paper products are classified elsewhere, such as abrasive paper in Abrasive Products, carbon paper in MISCELLANEOUS MANUFACTURING, and photosensitized and blueprint paper in Photographic Equipment and Supplies.
- 27 PRINTING, PUBLISHING, AND ALLIED INDUSTRIES This major group includes establishments engaged in printing by one or more of the common processes, such as letterpress, lithography, gravure, or screen; and those establishments which perform services for the printing trade, such as bookbinding, typesetting, engraving, photoengraving, and electrotyping. This major group also includes establishments engaged in publishing newspapers, books, and periodicals, regardless of whether or not they do their own printing. News syndicates are classified in Service Industries, and textile printing and finishing in TEXTILE MILL PRODUCTS.
- 28 CHEMICALS AND ALLIED PRODUCTS This major group includes establishments producing basic chemicals, and establishments manufacturing products by predominantly chemical processes. Establishments classified in this major group manufacture three general classes of products: (1) basic chemicals such as acids, alkalies, salts, and organic chemicals; (2) chemical products to be used in further manufacture such as synthetic fibers, plastics materials, dry colors, and pigments; (3) finished chemical products to be used for ultimate consumption such as drugs, cosmetics, and soaps; or to be used as materials or supplies in other industries such as paints, fertilizers, and explosives. The mining of natural rock salt is classified in mining industries. Establishments primarily engaged in manufacturing nonferrous metals and high percentage ferroalloys are classified in PRIMARY METAL INDUSTRIES; silicon carbide in STONE, CLAY, GLASS, AND CONCRETE PRODUCTS; baking powder, other leavening compounds, and starches in FOOD AND KINDRED PRODUCTS; and embalming fluids and artists' colors in MISCELLANEOUS MANUFACTURING. Establishments primarily engaged in packaging, repackaging, and bottling of purchased chemical products, but not engaged in manufacturing chemicals and allied products, are classified in trade industries.
- 29 PETROLEUM REFINING AND RELATED INDUSTRIES This major group includes establishments primarily engaged in petroleum refining, manufacturing paving and roofing materials, and compounding lubricating oils and greases from purchased materials. Establishments manufacturing and distributing gas to consumers are classified in public utilities industries, and those primarily engaged in producing coke and byproducts in PRIMARY METAL INDUSTRIES.
- 30 RUBBER AND MISCELLANEOUS PLASTICS PRODUCTS This major group includes establishments manufacturing from natural, synthetic, or reclaimed rubber, gutta percha, balata, or gutta siak, rubber products such as tires, rubber footwear, mechanical rubber goods, heels and soles, flooring, and rubber sundries. This group also includes establishments manufacturing or rebuilding retreaded tires, but automobile tire repair shops engaged in recapping and retreading automobile tires are classified in Services. This group also includes establishments engaged in molding primary plastics for the trade, and manufacturing miscellaneous finished plastic products. The manufacture of elastic webbing is classified in TEXTILE MILL PRODUCTS; products made of elastic webbing and garments made from rubberized fabrics in APPAREL; synthetic rubber, and plastics materials in the form of sheets, rods, tubes, granules, powders, or liquids in CHEMICALS AND ALLIED PRODUCTS.
- 31 LEATHER AND LEATHER PRODUCTS This major group includes establishments engaged in tanning, currying, and finishing hides and skins, and establishments manufacturing finished leather and artificial leather products and some similar products made of other materials. Leather converters are also included.
- 32 STONE, CLAY, GLASS, AND CONCRETE PRODUCTS This major group includes establishments engaged in manufacturing flat glass and other glass products, cement, structural clay products, pottery, concrete and gypsum products, cut stone, abrasive and asbestos products, etc., from materials taken principally from the earth in the form of stone, clay, and sand. When separate reports are available for mines and quarries operated by manufacturing establishments classified in this major group, the mining activities are classified in mining industries; when separate reports are not available, the mining activities are classified herein with the manufacturing operations.
- 33 PRIMARY METAL INDUSTRIES This major group includes establishments engaged in the smelting and refining of ferrous and nonferrous metals from ore, pig, or scrap; in the rolling, drawing, and alloying of ferrous and nonferrous metals; in the manufacture of castings, forgings, and other basic products of ferrous and nonferrous metals; and in the manufacture of nails, spikes, and insulated wire and cable. This major group also includes the production of coke.
- 34 FABRICATED METAL PRODUCTS, EXCEPT ORDNANCE, MACHINERY, AND TRANSPORTATION EQUIPMENT This major group includes establishments engaged in fabricating ferrous and nonferrous metal products such as metal cans, tinware, hand tools, cutlery, general hardware, nonelectric heating apparatus, fabricated structural metal products, metal stampings, and a variety of metal and wire products not elsewhere classified. Certain important segments of the metal fabricating industries are classified in other major groups such as ORDNANCE; MACHINERY; TRANSPORTATION EQUIPMENT;

PROFESSIONAL, SCIENTIFIC, AND CONTROLLING INSTRUMENTS, WATCHES AND CLOCKS; and jewelry and silverware in MISCELLANEOUS MANUFACTURING. Establishments primarily engaged in producing ferrous and non-ferrous metals and their alloys are classified in PRIMARY METAL INDUSTRIES.
- 35 MACHINERY, EXCEPT ELECTRICAL This major group includes establishments engaged in manufacturing machinery and equipment, other than ELECTRICAL EQUIPMENT, and TRANSPORTATION EQUIPMENT. Machines powered by built-in or detachable motors ordinarily are included in this major group, with the exception of electrical household appliances (ELECTRICAL MACHINERY, EQUIPMENT AND SUPPLIES). Portable tools, both electric and pneumatic powered, are included in this major group, but hand tools are classified in FABRICATED METAL PRODUCTS.
- 36 ELECTRICAL MACHINERY, EQUIPMENT, AND SUPPLIES This major group includes establishments engaged in manufacturing machinery, apparatus, and supplies for the generation, storage, transmission, transformation, and utilization of electrical energy. The manufacture of household appliances is included in this group, but industrial machinery and equipment powered by built-in or detachable electric motors is classified in MACHINERY, EXCEPT ELECTRICAL.
- 37 TRANSPORTATION EQUIPMENT This major group includes establishments engaged in manufacturing equipment for transportation of passengers and cargo by land, air, and water. Important products produced by establishments classified in this major group include motor vehicles, aircraft, ships, boats, railroad equipment, and miscellaneous transportation equipment such as motorcycles, bicycles, and horse drawn vehicles.
- 38 PROFESSIONAL, SCIENTIFIC, AND CONTROLLING INSTRUMENTS; PHOTOGRAPHIC AND OPTICAL GOODS; WATCHES AND CLOCKS This major group includes establishments engaged in manufacturing mechanical measuring, engineering, laboratory, and scientific research instruments; optical instruments and lenses; surgical, medical, and dental instruments, equipment, and supplies; ophthalmic goods; photographic equipment and supplies; and watches and clocks. Establishments primarily engaged in manufacturing instruments for indicating, measuring, and recording electrical quantities and characteristics are classified in ELECTRICAL MACHINERY, EQUIPMENT AND SUPPLIES.
- 39 MISCELLANEOUS MANUFACTURING INDUSTRIES This major group includes establishments primarily engaged in manufacturing products not classified in any other manufacturing major group. Industries in this group fall into the following categories: jewelry, silverware and plated ware; musical instruments; toys, sporting and athletic goods; pens, pencils, and other office and artists' materials; buttons, costume novelties, miscellaneous notions; brooms and brushes; morticians' goods; and other miscellaneous manufacturing industries.

Descriptions of subordinate industry groupings may be found in the Standard Industrial Classification Manual, 1967, Manufacturing Industries.

INDUSTRIAL CLASSIFICATION The Standard Industrial Classification system as compiled by the Executive Office of the President, Bureau of the Budget, was used to determine the industry title applicable to each establishment. Descriptions of major industry groups may be found in Appendix B. Each establishment has been classified according to its principal activity during the current year.

VALUE OF PRODUCT is the net selling price of all goods manufactured or processed during the calendar year. If industrial operations were on a contract basis, the total of amounts received for contract work or services performed has been included.

GROSS WAGES PAID shows total earnings during the calendar year of all employees, except executives, before deductions for Old Age and Survivors Insurance, group insurance, withholding tax, savings bonds, union dues, etc. Pay for sick leave, holidays, vacations and bonuses has been included. Owing to the exclusion of various fringe benefits, payroll taxes paid by employers, etc., this data should not be interpreted as representing total labor costs on the part of the employer.

NUMBER OF WORKERS is that reported in each month operated as of the payroll period ending nearest the 15th of the month, and averaged over the full twelve months. Workers engaged in fabricating, processing, assembling, inspection, receiving, storage, handling, packing, warehousing, shipping, maintenance, repair, janitorial, watchman services and product development are included as are working foremen and all other employees below the executive level.

AVERAGE GROSS WAGES is the figure obtained by dividing GROSS WAGES PAID by the TOTAL NUMBER OF WORKERS.

ESTABLISHMENT is defined as a single physical location where industrial operations are performed; it is, therefore, a place of business rather than a legal entity or company which may have units in many locations. In instances where separate records for each establishment were not kept, data have been allocated equally by civil division and the entire report classified by size as "combined". This practice will, of course, inflate the values at some of the locations. Where appropriate (e.g., logging operations) such combined reports have been assigned to no specific civil division, merely to the county in which said principal location is found.

CIVIL DIVISIONS are geographical units established for governmental purposes. Major civil divisions are counties; minor civil divisions are cities, towns, plantations and townships.

SPECIAL STUDIES techniques of compiling data in the various special surveys included in the Census are generally covered in the texts of such surveys.

APPENDIX F: Investment in Plant Modernization and Expansion, Maine Manufacturers

This is a tabulation of the values reported by Maine manufacturing establishments representing the amounts spent to expand or modernize their physical plant and/or the machinery and equipment therein. Current year figures are found in the main body.

The values are those reported by the individual firms or establishments and are classified according to industry, county and size of establishment.

Certain values, however, must be used with care. The most questionable figure is that under lumber and wood products which is separated into two groups: Sawmills and logging establishments and wood products. The reason for this is the fact that the former group relocate and establish new mills and camps, or purchase equipment on a basis that is not comparable to the more stationary type of industry; hence the separation so that the values for that group may be pulled out if desired.



APPENDIX H: Trends in Major Industries, 1963-1971

The fluctuations in product values in Maine's five major industry groups, paper, leather, food, lumber and textiles, have aroused considerable interest among economists and other students of the economy. In order to facilitate analysis by those interested in such data, we are presenting here a tabular picture of those industrial groups; both the raw data and adjusted data are included. The applicable Wholesale Price Index (U. S. Department of Labor, Bureau of Labor Statistics, 1967 equals 100) is used to adjust the value of product data. Wage data is adjusted by the reciprocal series Purchasing Power of the Dollar.
