**Maine Prescription Drug Affordability Board**  
**Report to the Committee on Health Coverage, Insurance and Financial Services**

The Maine Prescription Drug Affordability Board was established in 2019 pursuant to [MRS Title 5 Chapter 167-1](#). The Board's purpose is to: determine annual spending targets for prescription drugs purchased by public payors; determine which public payors are likely to exceed the spending targets; and determine spending targets on specific prescription drugs that may cause affordability challenges to enrollees in a public payor health plan. To do that, the Board will evaluate and recommend methodologies that might be utilized to reduce costs.

The Board is required to meet once per calendar quarter. The first meeting was held on March 17, 2020. Unfortunately, due to the pandemic, the Board was not able to resume meetings until November 2020. In order to catch up, meetings are currently being held monthly or bi-monthly rather than quarterly. Meetings are currently scheduled through March 23, 2021.

Five meetings were held from March 2020 through January 2021. Meetings to date have been focused on subject matter related to the pharmaceutical industry, the structure of public payor health and prescription insurance plans, potential cost control measures that have been implemented in other states and countries, model legislative initiatives and legislative initiatives in other states.

From the National Academy for State Health Policy, the Board has heard from Jennifer Reck, Project Director, and Marilyn Bartlett, Senior Policy Fellow, NASHP Center for Health System Costs. Presentations included an overview of cost drivers for prescription drugs, a discussion of NASHP suggested model legislation, a tour of the complex financial relationships and players in the United States pharmaceutical market, and an introduction to a few cost-control measures that have been implemented in other states and countries. Karynlee Harrington, Executive Director of the Maine Health Data Organization, has presented data on prescription costs, cost increases over time, and cost drivers. The Board has also heard from Ann Woloson, Executive Director of Maine Consumers for Affordable Health Care, and in an upcoming meeting will be hearing from the Institute for Clinical and Economic Review (ICER).

Public payor presentations have included information related to health plans offered, number of covered members, average age, deductibles, co-pays and co-insurance levels, premium costs, and prescription tiers and co-pays. Presentations have been made by: Maine Education Association Benefits Trust, Maine Community College System, Maine Municipal Employee Health Trust, University of Maine System, and Maine State Employee Health Commission.

To aid the Board in its mission, the enabling statute established an Advisory Council to assist the Board in establishing annual spending targets and determining methods for meeting those spending targets.
