Major matters before the Board in 2018 included the appeal of a license amendment pertaining to the disposal of municipal solid waste at the State-owned Juniper Ridge Landfill, the appeal of the Commissioner1s Designation of Uncontrolled Hazardous Substance Site and Order for the Beal1s Linen Site in Auburn, and a hearing and decision on Proposed Amendments to the Water Quality Re-Classification of a number of waterbodies. The Board also had jurisdiction over renewal of a hazardous waste facility post-closure license for a facility in Standish, and the application by the Town of Topsham for Partial Delegation of Permit-Granting Authority under the Natural Resources Protection Act (NRPA)for Impacts to vernal pools. A similar application for partial-delegation of NRPA permitting authority is pending for the Town of Orono. Major substantive rulemaking in 2018 included provisional adoption of amendments to the Department1s Chapter 692 Siting of Oil Storage Facilities, and final adoption of amendments to Chapter 418 Beneficial Use of Solid Wastes and Chapter 502 Lakes Most at Risk from New Development and Urban Impaired Streams. The Board also adopted routine technical amendments to Chapter Rule Concerning the Processing of Applications and Other Administrative Matters. The Board also received five appeals of Commissioner licensing decisions in 2018, three of which were decided by the Board and two remained pending at year1s end.
