Recommendations

The Committee examined five areas to increase voter participation--Saturday elections, absentee ballots, voting by mail, early voting and standard times to open polls. Information was obtained from a survey of other states and research on specific state statutes on the various areas. A survey of Maine municipalities was also conducted to obtain information on poll opening times. The Committee's recommendations on the five areas are as follows:

Saturday Elections

The Committee surveyed other states and found that Saturday elections were used infrequently and only for local or municipal elections. No state has adopted legislation that would either substitute Saturday as election day for statewide elections or supplement the usual Tuesday election day. (Only the dates for state elections would be effected by any change since the dates for federal elections are proscribed by Federal law.) The survey results supported the initial reaction of the Committee that Saturday elections would not automatically guarantee higher voter turnout. The Committee was concerned that Saturday elections would raise a conflict for some religious denominations, as well as a concern that Saturday elections would have the reverse effect on turnout by competing with the ever scarce personal time in people's lives.

Recommendation

At this time, the Committee is not prepared to recommend Saturday elections as a method for increasing voter participation. The Committee finds more compelling methods available to provide people access to the polls.

Absentee Ballots

The Committee obtained and reviewed information from other states to determine the statutory requirements, if any, imposed in order to obtain an absentee ballot. Some states do require individuals to specify the reason they will be unable to vote at the polls. The survey information, however, supports a reverse trend in absentee ballot eligibility requirements by allowing greater access to absentee ballots. This is in the form of any reason absentee ballots.

Maine has already provided some flexibility in this area. Current law allows individuals to obtain an absentee ballot if they believe that they will not be available to go to the polls on election day. A reason does not need to be specified. Despite this modification to the law, confusion still exists which prevents people from availing themselves of this option. The Committee would seek to further expand the availability of absentee ballots as a method of improving voter participation.

The Committee also reviewed research on permanent absentee ballots. Under this method, a person who qualifies for a permanent absentee ballot receives an absentee ballot automatically

for every election. Tennessee and Georgia allow citizens to apply for permanent absentee ballots in certain circumstances. Georgia allows for permanent absentee ballots to anyone 70 years or older. Tennessee requires an application and certification regarding the individual's inability to go to the polls based upon disability or hospitalization.

The Committee discussed this issue at length and was concerned that absentee ballots would continue to be mailed to individuals after they had died. In particular, the concern was that the family would fail to notify the clerk or registrar of the death and cancel the absentee ballot request. The Committee determined a permanent absentee ballot request should be valid only in certain circumstances and for one calendar year. This would require only one yearly application from an individual who was permanently unable to go to the polls.

Recommendation

The Committee recommends that a change in the statute be pursued that would allow a voter to obtain an absentee ballot for any reason. This would increase the accessibility of the polls to many people. In many respects, the Committee finds the any reason absentee ballot as the first step to instituting some of the other voting innovations for improving voter participation that are outlined in this report.

The Committee further recommends a permanent absentee ballot with one yearly application for individuals who meet certain requirements, such as disability, hospitalization, or age. This would ease the burden for some individuals who require an absentee ballot each and every election.

Voting By Mail

Voting by mail has been adopted by a handful of states with positive results. Many of the States--New Mexico, Florida, and Missouri--limit mail voting to issue only ballots. However, Oregon has adopted legislation that allows mail ballots for elections that include candidates. The mail ballot process requires that a ballot be mailed to every registered voter. Many of the states that have adopted voting by mail have a centralized voting list. Although Maine does not have a centralized voting list at this time, voting by mail is an innovation that could increase voter participation.

Maine must resolve three issues before considering legislation to pursue statewide voting by mail. First, municipalities must complete the purge of voting lists by the year 2000, as required by the National Voter Registration Act (NVRA). Second, a determination must be made as to who would bear the postage costs associated with a vote by mail election. Some municipalities may not be able to pay for the cost of mailing a ballot to every registered voter. This leads to the third issue, a centralized voter list. By establishing a centralized voter list the ballots could be mailed out by the state and the cost could be borne by the state.

The Committee also discussed the possibility of allowing municipalities the option of using mail ballots for local elections, for example election of a vacancy for water commissioner or a local ballot issue.

Recommendation

The Committee would recommend pursuing enabling legislation to allow municipalities (at their option) to institute voting by mail for local issue and candidate elections in an effort to improve participation in these local elections and to save costs. This option would allow municipalities to increase voter participation in local elections and provide test cases for the state to determine if voting by mail should be instituted in statewide elections.

Recommendation for a Centralized Voting List

The Committee recognizes that voting by mail is an innovation that could increase voter participation, especially in referendum elections. The Committee strongly encourages the Secretary of State's Office to investigate the possibility of a centralized voting list and the cost and technology that would be required. The Committee is mindful that the Federal government might impose the requirement of a centralized voter list on the states to further the goals of the NVRA. Therefore, this issue should be monitored to determine if the Federal government will offer incentives for states using centralized voter lists. The Committee further recognizes that a centralized voting list would also be valuable in eliminating duplicate registrations and ensuring a voter is registered in only a single municipality. The Committee would be willing to assemble again at a later date and formulate a plan to develop a centralized voting list for Maine.

Early Voting

Early voting is a process that expands the period of time during which a ballot may be cast. Many states allow people to vote 20 days in advance of the election date. Unlike absentee ballots, early voting is usually distinguished by the fact that an application is not required. The states that allow early voting generally establish polling places where individuals may vote during specified times. Most states require that the polling place be established at a municipal or county building, however New Mexico has established polling places in shopping malls. The states that have adopted legislation allowing early voting have had positive results and positive feedback from the public and the election officials. This appears to be a popular method for improving voter participation and increasing voter access to the polls.

Early voting does require a method of securing the ballots during the early voting period, as well as a mechanism to allow for challenges to the ballots as they are cast. Additionally, there would be an increase in costs to the municipalities for the additional staff required to process the early voters.

The Committee recognized that some of the elements of early voting could be achieved by allowing for any reason absentee ballots, and therefore would seek to pursue this method before recommending early voting in statewide elections. The any reason absentee ballots, coupled

with increased awareness and advertising could obtain very similar results as early voting in increasing voter participation. The any reason absentee ballots might also increase the interest of the voters to take advantage of absentee ballots and the willingness of municipal clerks to establish expanded hours for taking absentee ballots.

Recommendation

Early voting is an innovation that can have positive results in improving voter participation. However, any reason absentee ballots would be a step in this direction and could provide a test case in providing valuable information on whether or not early voting should be pursued in the future. Expanding any reason absentee ballots could serve as a modified early voting without the concern regarding security of the ballots and challenges to ballots cast. Absentee voting already has an established procedure for both security of ballots and challenges.

Standard Poll Opening Times

A survey of other states found that most states have standard poll opening times for all municipalities in statewide elections. Nearly 70% of the states responding have a standard opening time that is no later than 7:00 a.m. Maine law states that "The polls must be opened no earlier than 6:00 a.m. and no later than 9:00 a.m. on election day; except that in municipalities with a population of less than 4,000, the polls must be opened no later than 10:00 a.m. on election day. The municipal officers shall determine the time of opening the polls within these limits." Title 21-A, section 626.

A statewide survey of Maine municipalities found that few municipalities open the polls at 6:00 a.m., even though this is allowed under the statute. Municipalities with a population of over 25,000 consistently open the polls at 7:00 a.m. The smaller municipalities, under 5,000, generally avail themselves of the later opening times.

The Committee agreed that more standardized poll opening times could be established to increase citizen access to the polls. There was concern regarding the increase in costs to the municipalities, but this was offset by the concern for individuals wanting to vote before going to work. In its recommendation, the Committee tried to balance these interests, while giving municipalities with smaller populations some flexibility.

The Committee recognizes that the people living in a town with a population of less than 2,000 may have the same desire to go to the polls before work as the people living in a town with a population of over 6,000. However, the Committee was not prepared to recommend one standard poll opening time for all municipalities regardless of size. In an effort to address this issue and perhaps move in the direction of one standard opening time, the Committee reviewed the survey results, reviewed the current law and determined that there were certain patterns and breaking points based upon municipality size. This helped the committee formulate its recommendation.

Recommendation

The Committee recommends continuing to allow different opening times based upon the size of the municipality. However, the recommendation would adjust the opening times for larger municipalities. The Committee would recommend the following changes in the statute for poll opening:

- Municipalities with a population of less than 100 may open at any time, provided the times are advertised and the polls do not close before 8 p.m., unless all registered voters have cast a ballot;
- Municipalities with populations from 101 to 5999 should be allowed to open no earlier than 6:00 a.m. and no later than 10:00 a.m.;
- Municipalities with populations of 6,000 or over should be allowed to open no earlier than 6:00 a.m. and no later than 7:00 a.m.

Those municipalities in the 101 to 5999 population range continue to have some flexibility regarding opening time. An added benefit to establishing specific opening times for the larger communities is the reduction of public confusion and frustration about poll opening times. Media misinformation regarding poll opening times should also be reduced.

Conclusion

The Committee through its discussions and research recognize the importance of giving Maine citizens every opportunity to cast a ballot. It also recognizes that improving voter participation is an incremental process and that there may be several methods available to achieve the desired result. The Committee considers many of its recommendations as important steps towards improving access to the polls for the citizens of Maine. Many of the recommendation can, and will be, the basis for additional changes in the future.

We are writing on behalf of the Joint Standing Committee on Legal and Veterans' Affairs to request your assistance in increasing the ability of Maine residents to vote in elections.

We considered a bill this past session, LD 613, An Act to Allow Primary Elections to be Held on Saturdays. The committee voted against the bill because there were legal and technical questions about implementing the bill. However, we were sympathetic to the goal of the bill, which was to increase voter participation by making it easier for people to get to the polls. For people who work on weekdays, and people who work hours other than 8 to 5, the current timing of elections can make voting difficult.

We would ask that your office review these issues, collect information on what other states do to increase voter participation, talk to municipal officials about possible solutions and let us know what you find out. We would appreciate this information, and any recommendations you might have to increase voter participation in Maine.

Be it enacted by the People of the State of Maine as follows:

Sec. 1. 21-A MRSA $\S626$, sub- $\S1$, as amended by PL 1997, c. 436, $\S88$, is further amended to read:

1. Opening time flexible. The polls must be opened no earlier than 6 a.m. and no later than 9 7 a.m. on election day; except that in municipalities with a population of less than 4,000 6,000, the polls must be opened no later than 10:00 a.m. on election day. Municipalities with populations of less than 100 may set their own opening times. The municipal officers of each municipality shall determine the time of opening the polls within these limits.

SUMMARY

This bill amends the election laws by making it easier for a person to vote by absentee ballot. The bill allows any voter to vote by absentee ballot at any election. The bill further allows a voter whose physical incapacity prevents the voter from going to the polls to obtain an absentee ballot for all elections during a calendar year, after submission of a properly completed application. The bill also allows municipalities to conduct elections by mail for municipal officers or a municipal referendum.
