



SUBJECT: Report of Enforcement of Maine's Operating Under the Influence Law

Under the 1981 Drunk Driving Law, the Department of Human Services is required to prepare an annual report on the enforcement of Maine's operating under the influence law. The Department is pleased to submit the Fourth Annual Report that covers the period from January 1 to December 31, 1985.

Findings from reports for 1982-84 indicated that despite some minor variability in application of the law that Maine has had a generally positive experience in its enforcement. The findings for 1985 are consistent with this earlier experience. The highlights of the 1985 Report include:

- Fewer arrests were made during calendar year 1985 than during any other previous OUI reporting period.
- After the 1981 OUI Law was implemented, rates of refusal by drivers to submit to a blood alcohol test declined steadily through 1984. However, the rate has increased in 1985.
- Maine's 1985 OUI conviction rate was at the lowest level, 83.5%, since the 1981 OUI Law was implemented, and the dismissal rate increased to a high of 15.2%.
- The average fine for criminal convictions dropped from \$390 in 1984 to \$381 in 1985.
- Jail sentences and license suspensions have been imposed with relative consistency during the period of the law's effect.
  - However, the average license suspension period imposed by the courts on persons convicted for criminal OUI decreased by 43 days from 1984 to 1985.
  - Fewer OUI offenders were sentenced to jail in 1985 (91.9%) than in 1984 (99.3%).
  - The average BAC in 1985 was .1%; the same as 1983 and 1984.
  - The average jail sentence increased from nine days to fifteen days.

- The 35.7% referral rate to evaluation and treatment for DEEP clients is the highest rate since the 1981 OUI Law was implemented.

A contributing factor to the decline in some 1985 indicators is the February 1985 decision of the Maine Supreme Court that the civil OUI procedure was unconstitutional. This meant that all cases had to be treated as criminal arrests, elevating the conviction standard to "beyond a reasonable doubt," and making a jail sentence mandatory. This was bound to make changes in arrests and convictions. One other factor, as evidenced by the increase in refusal rates, may be that the public has become more aware of the severity of some of the penalties imposed on OUI offenders.

In an effort to deal more effectively with the drinking and driving problem, Commissioner Stilphen and I, in the fall of 1985, formed an OUI Committee to review all aspects of the OUI problem and to make recommendations where necessary. Some of the recommendations of this group, when implemented, could impact favorably on the problem areas highlighted in this year's report. That report will be made available shortly.

## INTRODUCTION

---

The 1985 OUI Report is the fourth annual report prepared by the Office of Alcoholism and Drug Abuse Prevention, Maine Department of Human Services. The annual reports are in response to the reporting requirement contained in Chapter 468 of The Public Laws of 1980, "An Act to Reform the Statutes Relating to Driving under the Influence of Intoxicating Liquor or Drugs" enacted in the Spring of 1981 by the 110th Maine Legislature.

This report covers the same three offenses as did previous reports: operating under the influence (OUI), operating after suspension (OAS), and operating after habitual offender revocation (HO). The primary focus is on 1985 OUI, OAS, and HO case disposition and sentencing statistics. Selected statistics from previous OUI reporting periods (1982-84) are also presented for comparison purposes.

Chapter II presents OUI statistics: arrests, revocation of implied consent, court findings, legal sanctions imposed upon conviction, and Driver Education Evaluation Program (DEEP) participation information. Data are presented by county, and by District and Superior Court.

The presentation of OUI data in this report differs somewhat from previous years primarily in two ways. First, civil OUI statistics are deleted from most of the analyses, except where noted, for two reasons: (1) the question of constitutionality which arose early in 1985, and (2) only 228 cases were prosecuted under the civil statute -- all occurring prior to the implementation of the revised OUI statutes in September 1985. Secondly, OUI statistics are presented in formats used in previous reports, as well as before and after the 1985 revised OUI statutes were implemented in September.

Chapter III and Chapter IV present OAS and HO statistics, respectively. Within each category of offense disposition of cases and legal sanctions are presented for 1985 by county and by court. Data are also broken down by OAS and HO license suspensions/revocations which were OUI-related. Selected statistics from previous years are presented to facilitate comparisons across reporting years.

The last section of this report contains numerous statistical tables which support data discussed and/or presented in the narrative.

## HIGHLIGHTS

---

### OUI ARRESTS, REFUSALS AND BAC

- Fewer arrests were made during calendar year 1985 than during any other previous OUI reporting period since the 1981 OUI Law was implemented; and, at arrest, a greater percentage of the drivers apprehended in 1985 refused to submit to a chemical test (blood or breath).

- The average BAC in 1985 was .19 percent; the same as in 1983 and 1984. (The average BAC in 1982 was .18%).
- As of March 13, 1986 (the date statistics were generated for this report), 7,730 OUI cases with a 1985 violation date had been adjudicated (81.7%).

### OPERATING UNDER THE INFLUENCE

- The OUI conviction rate, criminal and civil cases combined, dropped to 83.5 percent in 1985; the lowest rate experienced by Maine since the 1981 OUI Law was implemented. The dismissal rate increased during calendar year 1985.

- Excluding the 228 cases prosecuted under civil statute in 1985, the conviction rate then increased to 84.1; however, this rate is still lower than the criminal OUI conviction rates experienced during previous reporting periods as depicted below.

- District Courts obtained convictions in 85.1 percent of the 6,474 OUI cases adjudicated as of March 13, 1986 while Superior Courts had a conviction rate of 77.7 percent (1,027 cases). (Only OUI cases having a 1985 violation date were included in these statistics.)
- Penalties imposed by Superior Courts tended to be more severe than those imposed by District Courts; however, District Courts imposed legal sanctions somewhat more frequently than did Superior Courts.
- At both judicial levels, mandatory sanctions were not imposed in 100.0 percent of the convictions; and in some instances, the sanctions imposed were below the mandatory minimum.

DEEP  
COMPLETION

- A total of 6,603 OUI offenders participated in the State's Driver Education Evaluation Program (DEEP) during calendar year 1985; 29.8 percent were participants whose OUI violation occurred in 1985.
- Of the 6,455 drivers convicted of a 1985 OUI violation, 30.5 percent of them had met all DEEP requirements (1,966 drivers) as of March 13, 1986. Thirty-six percent of those who met all requirements satisfactorily were required to complete more than the 10-hour DEEP course. The additional requirement included an alcohol evaluation to ascertain the extent of the driver's drinking problem and, when indicated, referral to and completion of treatment.
- At the time that previous annual OUI reports were prepared, DEEP completion rates were slightly higher.

- An analysis of OUI statistics alone cannot explain the declining completion rate; however, one factor which may have an influence on the completion rate is the license suspension period imposed by courts. The average has increased from 46 days (civil OUI) and 96 days (criminal OUI) in 1982 to 149 days in 1985. Because of these longer license suspension periods, drivers may be allowing more time to elapse before they register for the DEEP course, thereby delaying the completion date. Completion may be delayed further if the DEEP participant is referred for evaluation/treatment.

OPERATING  
AFTER SUSPENSION

- As of March 13, 1986, a total of 5,654 OAS cases (with a 1985 violation date) had been adjudicated. This represents an overall increase in OAS cases of 1,139 compared to the number of cases adjudicated at the time the 1984 OUI report was prepared.
- The overall 1985 OAS conviction rate was 82.0 percent. Ninety-one percent of the drivers convicted were fined an average of \$129; 15.5 percent were sentenced an average of 31 days in jail; and 3.5 percent had their license suspension periods extended an average of 282 days.

- Twenty-four percent of the 1985 OAS violations involved drivers whose licenses were under suspension for an OUI conviction; the percentage in 1984 was also twenty-four percent. Court findings in OUI-related OAS cases and the penalties imposed in 1984-85 are shown below:

OPERATING AFTER  
HABITUAL OFFENDER REVOCATION

- A total of 497 HO cases with 1985 violation dates had been adjudicated as of March 13, 1986. In 61.6 percent of these cases, the basis for HO revocation included one or more OUI violations. In 1984, 66.2 percent of the HO cases adjudicated were OUI-related HO revocations.
- During the last four OUI reporting periods, the highest HO conviction rate was achieved in 1984 (78.1%). In 1985, however, the overall conviction rate dropped to 64.9 percent and the dismissal rate increased to 34.3 percent.
- Ninety-five percent of the drivers convicted of a 1985 HO violation were sentenced to an average of 252 days in jail; 15.2 percent were fined an average of \$539; and 1.6 percent had their revocation periods extended one year.
