Summary of the activities of the board or commission related to accomplishing its mission in 2012: The Maine Pilotage Commission held three regularly scheduled meetings in 2012. The Commission is charged with issuing pilotage licenses, administering rules and laws relating to pilotage, investigating pilot conduct, and providing training and other resources in order to ensure the safe passage of vessels along the Maine coast. A rate hearing was conducted for increases in rates of pilotage for vessels that transit Penobscot Bay, the Kennebec River, the Sheepscot River and Boothbay Harbor and for vessels that provide pilotage to docking facilities at Rockland and Camden Harbor. Two licenses were renewed, one member was reappointed by the Governor and an application for a Penobscot River license was accepted for testing as well.
