State of Maine Bureau of Liquor Enforcement

Enabling Legislation:

- MRSA 25, section 3901
- MRSA 28-A, section 82
- 21st Amendment of the U.S. Constitution

Organizational Purpose:

- Enforce State liquor laws and Bureau rules and regulations governing the manufacture, importation, transportation, storage, and sale of liquor
- Responsible for issuing all liquor licenses and the taxation of all alcoholic beverages except spirituous liquor sold by the Bureau of Alcoholic Beverages

Organizational Structure:

- 28 positions
- Divided into two divisions Enforcement Division and Licensing & Taxation Division
- Enforcement Division: (1) Director, (1) Assistant Director, (3) Liquor Enforcement Officers II, (13) Liquor Enforcement Officers I, (1) sworn Training Coordinator, (1) Administrative Secretary and (1) Clerk Typist II
- Licensing & Taxation Division: (1) Liquor Tax Auditor, (1) Account Clerk I, (2) Clerk Typist III and (3) Public Safety Inspector I.

 - May apply for this one additional license at the area to consume spirits, wine, or malt liquor on the premise

- Off-Premise Catering License
 - A Class A Restaurant, hotel, bed and breakfast, or club licensed to sell spirits, wine, and malt liquor
 - May obtain a license to conduct off-premise catering of spirits, wine, and malt liquor

Pending Legislation:

- 1. An act to clarify the definition of table wine. This bill will clarify the definition of table wine and make the distinction between table wine and fortified wine.
- 2. An act to clarify the delivery of spirits. This bill will clarify the language in Title 28-A, where the word "liquor" is currently incorrectly used instead of "spirits", as agency liquor stores may only deliver spirits, and not all types of liquor, to liquor-licensed premises.
- 3. An act to increase the application time limit for BYOB Function Permits and Off-Premise Catering Permits. This bill will increase the application time limit for such permits from the current 24-hour time frame to 5 business days. This would create adequate time for the Bureau to process the application, provide notification to the area officer of the pending function and arrange for an inspector to inspect the function site.
- 4. An act to restrict On-Premise establishments from allowing patrons to possess or consume liquor off the licensed-premise. This bill will clarify current language that to too vague to be effectively enforced. The intent of the current law is to prevent on-premise establishments from allowing patrons to take liquor from the premise, except under certain circumstances, however, the law requires the sale of liquor to be made for the off premise consumption before a violation of law occurs.
- 5. An Act to restrict the sale of spirits from a delivery vehicle. With the increase in the number of agency liquor stores that provide delivery service of spirits, this modification of a current law is necessary to require these agency stores to adhere the same delivery standards (orders placed and invoices required) as the wholesale licensees who provide delivery service.

Agency Liquor Stores:


The State has closed 18 liquor stores. This past summer, the Bureau advertised for agency liquor store applications in many communities throughout the State. All applicants' premises were inspected by liquor licensing inspectors and hearings were held in Augusta. A number of new agency stores were licensed. Agency liquor stores in the State have now increased from 190 to 230.

Major Current Projects:

• Statewide compliance checks of retail premises in association with the Maine Attorney General's Office and the Office of Substance Abuse with grant funding provided by the U.S. Office of Juvenile Justice and Delinquency Prevention; Program started Jan 16, 03 = 20 violations detected from 59 retail premise checks. To date, there is a 34% non-compliance rate in the sales of liquor to minors in this program.

- Implementation of tax collection by Internet;
- Transitioning of owned State vehicles to leased State vehicles;
- Accreditation process through CALEA.
- Bureau Programs and Publications:
 - Officers as Agents Program
 - Developed in 1994 as a result of a Highway Safety Grant
 - Intent is to reduce the number of underage people purchasing and consuming liquor
 - Officers pose as a patron or employee of a liquor licensed premise
 - Officers detect and deter underage liquor purchases, minors using false identification cards, adults furnishing liquor to minors, thefts, and other violations of law
 - Program has prevented many violations
- D.A.R.E.
- B.A.S.I.C. (Bureau's Alcohol Server Informational Course)
 - Developed in 1989 at the request of Maine Legislature
 - 4 hour class for sellers and servers of liquor and liquor licensees
 - Instructed by Liquor Enforcement Officers
 - Topics covered include: liquor laws, identifying minors and intoxicated persons, false identification detection, how to slow alcohol consumption, alcohol affects on people, and preventing lawsuits.
 - Students are tested and certificates are issued for successful completion
 - Class fee: \$28 per person
 - Program is reviewed by the Maine Alcohol Server Education Advisory Committee
 - Program approved biannually by the Commissioner of the Department of Public Safety
 - Currently instructing over 1,500 liquor sellers/servers annually (1,674 in 2002)


