The 1990 Commission includes five new members and two incumbents. This was an exceptionally busy year for the Commission. Not only were there Senate and House elections to plan for, but a Gubernatorial election as well. Although required to meet only four to six times during an election year, the Commission and its subcommittee met a total of nine times. In addition to reviewing complaints, the Commission ruled on the lateness of reports, issued advisory recommendations on campaign reporting and financial disclosure, proposed revisions in the ethics and campaign finance laws, and clarified procedures for handling of complaints.

NEW STAFF

In 1989, a Blue Ribbon Commission consisting of former Governor Kenneth Curtis, Congressman Stan Tupper, and Professor Eugene Mawhinney recommended that the Commission be given adequate staff to carry out its duties. To its credit, the Legislature approved two full-time staff positions, both of which were filled in February 1990. Additional staff made it possible to increase efforts to reach out and acquaint people involved in the political process with their responsibilities. The Commission believes that this type of activity reduces the number of violations of campaign law and makes participation in the process more enjoyable.

ADMINISTRATION

Staff Functions

To administer its affairs, the Commission employs a staff of three full-time employees. They are the commissioners' day-to-day presence in the office: the link between those who determine policy and priority (the commissioners) and those who carry it out (the staff). The director serves as spokesperson and liaison between the Legislature and the Commission, consulting with a Commission legislative subcommittee on issues. In the interim between commission meetings, the director consults with the chairman of the Commission on important matters.

The staff advises and assists Legislators, candidates, treasurers, political action committees, and others with questions concerning the requirements of laws within the Commission's jurisdiction. Throughout the business day, staff is available to answer questions over the telephone or in person in the Commission office. Staff also spends many hours assisting candidates in completing forms and reports required by law. Other duties include research, budget preparation, literature development, compilation of statistical information, response to written requests for information from both in-state and out-of-state entities, report audit, and filling of requests for photocopies of campaign finance reports and other public documents. Finally, the staff tries to keep abreast of significant issues relating to ethics and campaign financing on the national as well as the state level and brings relevant concerns to the attention of the Commission.

Commission Counsel

The Attorney General's staff advises the Commission and serves as counsel in proceedings. In recent years, campaigns have become more sophisticated, spending has skyrocketed, and political action committees (PACs) have played an increasingly prominent role in elections. This has resulted in more requests for legal advice on ever more complex issues. Consequently, in 1990, Commission counsel spent more time than ever before in advising the Commission. The commitment of both Commission counsel and an investigator contributed significantly to the overall effectiveness of the Commission.

Secretary of State

Since the Commission is "in but not of" the Department of the Secretary of State, that Department has no legal authority over the Commission; however, it does maintain Commission financial and payroll records. In addition, a systems analyst assists with the Commission's computer program. The important support provided the Commission staff by the staff of the Secretary of State is very much appreciated by the Commission. This support allows the small Commission staff to concentrate on its primary mission.

Authority

The duties and authority of the Commission are set forth in 1 M.R.S.A. Section 1008.

Location

The Commission is located in Room 221 of the State Office Building. In 1990, the Secretary of State renovated its quarters and reorganized its work force. As "tenants," the Commission negotiated for and was granted space in an area that is segregated from the mainstream of Secretary of State operations. The new location underscores the Commission's autonomy, while nicely accommodating new staff members; however, the Commission is still badly in need of a "public area" for patrons to review reports.

SUBCOMMITTEE ACTIVITY

In 1990, the Commission established subcommittees to issue advisory recommendations and review the following matters:

- 1. Fair Campaign Practices Code
- 2. Financial disclosure queries and legislation
- 3. Campaign finance legislation

The Commission's Fair Campaign Practices Subcommittee planned a workshop for the Spring of 1991 as part of a study mandated by P.L. 1989, Ch. 802.

The subcommittee on financial disclosure recommended amendments to the law that would exclude from reporting requirements: 1) credit card liabilities, 2) educational loans made or guaranteed by a governmental entity, educational institution or nonprofit organization, 3) loans made from a state or federally regulated financial institution for business purposes.

Subcommittee Activity (Continued)

The subcommittee on campaign finance legislation recommended simplifying current reporting requirements by eliminating dual filing for candidates and their committees. An additional proposal would tighten the law by requiring out-of-state political action committees to register and report to the Commission.

Bipartisan sponsors were obtained for all legislation proposed by the Commission.

ADVISORY RECOMMENDATIONS ON FINANCIAL DISCLOSURE

The Commission approved the following guidelines for legislators:

- Income from IRA's is considered deferred income for tax purposes and thus reportable on statements of sources of income.
- In reporting income from a self-directed IRA, the names of each entity from which the filer derives dividends of \$1,000 or more must be reported.
- In reporting income from a self-directed IRA in which no one investment of the IRA yields \$1,000 or more, but the aggregate of all such investments yields \$1,000, the IRA must be listed as an income source.
- Where an individual owns stock in several different firms engaging in essentially the same economic activity that collectively yield \$1,000 or more, but no one of which yields \$1,000 or more, the sources of income need not be reported.
- Credit card liabilities of \$3,000 or more are considered unsecured loans and hence reportable. Likewise, lines of credit of \$3,000 or more are reportable.
- Sources of income derived from investments of a corporation in which the filer owns a substantial interest need not be reported.
- Where a filer has sole-proprietorship, he/she must report sources of income of \$1,000 or more derived from investments of that proprietorship.
- Sources of income from rentals must be disclosed even if no profit was realized from the rental.
- Only in commercial rentals must the name and address of tenants be reported. The names of tenants in noncommercial rentals need not be disclosed.
- Where there is joint ownership (as with a spouse or other) of stocks or other investments, and the total amount of income realized from those stocks is \$1,000 or more, the source of income must be disclosed.

ADVISORY RECOMMENDATIONS ON CAMPAIGN FINANCE LAWS

Commission staff issues ad hoc recommendations on questions concerning application of the campaign finance laws. Where questions touch on areas of the law that are subject to interpretation, Commission members provide guidance. The Commission issued the following recommendations during 1990:

- Funds transferred from a congressional to a gubernatorial campaign are subject to the contribution limitations set forth in 21-A M.R.S.A. Section 1014.
- Contributors may not designate for use in a general election any portion of a contribution made to a candidate prior to the primary election.
- Party committees are subject to the contribution limitation set forth in 21-A M.R.S.A. Section 1015(2).
- Funds accepted after an election by a candidate who has met all financial obligations could be deemed a gift if the candidate does not seek reelection.
- Under the reporting laws, the term "consulting" is sufficient to describe an expenditure.
- A candidate need not reprint signs and other printed materials to delete the name of a treasurer who resigns during the campaign.
- The law is silent on the question of whether a candidate who served as Legislator in 1986-87 may represent him/herself as an incumbent on campaign literature.
- A candidate need not report the occupation and place of business of individuals who make a joint contribution of \$100.00 or less to his/her campaign.
- The law is silent on the question of whether a subsidiary or affiliate of a corporation is considered a separate entity for purposes of the contribution limitations.
- Where candidate "A" appears in a TV advertisement produced by her spouse (candidate "B") for the sole purpose of furthering his candidacy, and where candidate A's name, office, and occupation are not mentioned in the ad, no part of the cost of the ad would constitute an in-kind contribution from candidate B to candidate A. Where candidate B introduces candidate A by title or states the fact of her candidacy, part of the cost of the ad would constitute a reportable in-kind contribution, the fair market value of which would be determined by the candidates.

ETHICS SEMINAR

In accordance with P.L. 1989, Ch. 561: An Act Regarding Governmental Ethics, the Commission conducted an ethics seminar for legislators in December 1990, in conjunction with the Attorney General and the Chair of the Legislative Council. Commission staff provided instructions for completing statements of income and Commission counsel discussed the responsibilities of Legislators under the conflict of interest laws. Counsel also distributed to newly elected legislators a compilation of the legislative ethics laws and a summary of advisory opinions pertaining to ethics and conduct. The Commission chairman urged legislators to consult with Commission staff on questions relating to conflicts of interest.

FAIR CAMPAIGN PRACTICES CODE

In accordance with P.L. 1989, Ch. 802, the Commission distributed to Senate and House candidates forms containing a copy of the Maine Code of Fair Campaign Practices. Of 336 candidates who received forms, 217 subscribed to the Code.

COMPLAINTS

When complaints are filed, the director conducts preliminary investigations and, in consultation with Commission Counsel, submits findings and recommendations to the Commission. The Commission then reviews the facts and determines whether a violation was committed and a penalty warranted. Complaints filed during calendar year 1990 totalled 17. A breakdown by category follows:

The Commission investigated to determine the facts and obtain compliance regarding all reported disclaimer violations. A lengthy investigation of one such violation, conducted in conjunction with the Attorney General's office, was successfully concluded in January 1991. Complaints dealing with the Fair Campaign Practices Code were referred to the Commission's Subcommittee to study compliance with the Code. Complaints relating to alleged election violations and those categorized "other" were deemed not to be within the scope of the Commission's jurisdiction. The Commission conducted an extensive preliminary investigation regarding an allegation of noncompliance with contribution limitations, and upon reviewing the facts, voted not to pursue the matter. A complaint alleging conflict of interest was reviewed and filed, the Commission finding no basis for hearing the complaint.

COMMISSION FILINGS

Reports Processed

Much of what the Commission does revolves around filing of campaign finance reports. The Commission's reporting clients and the number of filings processed by the Commission during 1990 are as follows:

Report Audits

Commission staff reviews and audits filings of state and county candidates and state political action committees and makes periodic reports to the Commission on findings. Report review enables staff to contact filing entities and assist them in correcting and/or clarifying discrepancies in the reports. When errors and violations are found in reports, attempts are made to remedy the matter on an administrative level by notifying filers of the problems. If this fails to produce a response, the report is brought before the Commission who then determines whether the report substantially conforms to the law. In 1990, all deficient reports were duly amended, thus no filings were reviewed by the Commission.

The trend of candidates and political action committees to file lengthier and more detailed reports continued in 1990 making the audit process more complex and time consuming than in previous years. This was especially true of gubernatorial candidate reports. A total of 1868 candidate reports and 560 PAC reports underwent audit. A summary of staff findings follows:

A total of 155 candidates showed surpluses or deficits of more than \$50.00 on post-election reports. Those candidates will be required to show the disposition of surplus funds in semiannual filings.

Late Filers

Before filing deadlines, Commission staff sends notices to state and county candidates and political action committees. A total of 6,930 reminders were mailed in 1990. Additionally, late notices went out to delinquent filers in accordance with 21-A M.R.S.A. Section 1020. The Commission considered the lateness of campaign finance reports and registrations required of state and county candidates, political committees, and political action committees engaged in state and county political campaigns. After reviewing the filings of 45 candidates and 5 political action committees involved in the 1990 primary and general elections, the Commission ruled that 37 candidate reports and 2 political action committee reports were filed late. Also considered were late filings of three candidate revocation notices. The Commission determined that two such notices were filed late.

Fines were imposed as follows:

Candidates \$2,495.00 PACs 500.00

Total fines \$2,995.00

The total amount collected in calendar year 1990 -- \$3,602.00 -- includes \$1,227.00 in penalties owed from 1989. At the end of calendar year 1990, there remained \$620.00 in uncollected penalties.

The Commission considered the lateness of 25 candidate registrations and granted amnesty to all late filers.

MUNICIPAL CANDIDATES

At the request of the Legal Affairs Committee, Commission staff conducted a study of municipal candidate compliance with the campaign finance laws. Upon reviewing results, the Commission directed staff to provide municipal clerks with a summary of recording and reporting requirements to ensure that municipal candidates are duly notified of their legal responsibilities and that information provided them is consistent with that offered to state and county candidates. Accordingly, staff disseminated campaign literature, along with standardized registration and reporting forms, to all municipal clerks employed by cities of 10,000 or more -- candidates in those cities being governed by 30-A M.R.S.A., Section 2502, subsection 1.

COMPUTERIZATION

For the first time since its creation, the Commission used computer generated mailing lists to send notices to candidates, treasurers, and political action committees. The staff also keyed in total receipts and total expenditures of the 1990 elections. The information is used for two purposes: 1) public information 2) as a staff reference for determining candidates' financial status at the end of a campaign. The staff has been working with the systems analyst to add to and improve the existing program; however, the one computer shared by all staff members is inadequate for producing needed programs. Adding equipment and expanding the computer function would result in a smoother work flow and allow staff to devote more time to counseling people in the political process. A request for additional funds for computers was delayed because of the economic problems facing state government.

PUBLICATIONS

The Commission staff developed a candidate brochure and distributed 535 copies to newly registered candidates. Staff also prepared a summary of guidelines on campaign financing for inclusion in "Running for Office in Maine," a publication distributed by the Secretary of State. The Commission filled 375 requests for copies of the campaign finance laws, and 62 requests for copies of the laws on legislative ethics.

1991 OBJECTIVES

As campaign costs mount and candidates are forced to wage increasingly difficult campaigns, the Commission, in turn, is called upon more and more to assist candidates with questions that are not expressly addressed in the campaign finance laws. For this reason, the Commission planned a public workshop in 1991 to air relevant issues and review the laws governing candidates and political action committees. Current budget constraints have forced the Commission to postpone the workshop until later; however, the Commission will continue to focus on timely issues in regular meetings.

Political Action Committees

In 1990, 88 State political action committees participated in the political process in Maine. This represents a 19 percent increase over the 1988 total of 74. Twenty-six new PACs registered in 1990, and 5 terminated.
