

INTRODUCTION

In 1880 the Legislature made the two Maine Fisheries Commissioners responsible for enforcing the laws that had been enacted to control the taking of important game species. The uncontrolled taking of moose, caribou, and deer during the 1800s had contributed to a serious depletion of big game populations. This early enforcement effort represented the beginning of the Department of Inland Fisheries and Wildlife. At the time, game wardens were appointed to patrol the State's woods and waters and bring poaching under control. They did not receive a salary, but instead received half the amount of the fines paid by violators they apprehended.

The mission of the Department was soon expanded to include the propagation of game fish. Thousands of trout, salmon, and bass were stocked annually across the state to support a rapidly growing tourist industry. Through the early 1900s, many new hunting and fishing laws were enacted to conserve fish and wildlife. Hunting and fishing licenses were established to pay for fish and wildlife conservation programs. Detailed studies of the status and needs of wildlife began in the 1940s to guide the management of these resources. Statewide fisheries management programs were initiated in the 1950s. Today, the Department carries out a wide variety of fish and wildlife conservation programs. These programs focus on maintaining abundant game resources, as well as managing non-game wildlife and restoring endangered species, such as the bald eagle. The Department's mission has also been significantly broadened with responsibilities for white-water rafting; registration of watercraft; snowmobiles; ATVs; enforcement of laws governing their use; hunter, trapper, and recreational vehicle safety; conservation education; and other matters.

Although the Department's mission has been steadily expanded, it remains focused on the protection and enhancement of the state's inland fisheries and wildlife, while at the same time providing for the wise use of these resources. Assuring the conservation and use of these resources is vital to the state's economy. Fish and wildlife continue to be highly valued by Maine people and hundreds of thousands of people who come to Maine each year. Economic impacts directly attributable to the use of these resources amount to over one billion dollars annually. These expenditures play a major role in the State's economy.

The Department is dedicated to assuring these highly valued resources are available for the use and enjoyment of future generations.

ENABLING LEGISLATION AND RELEVANT MANDATES

MRSA 12, PART 13, CHAPTERS 901-941 as enacted by Public Law establishes the statutory basis for the Department and its operations. The principle mandate of the Department is to preserve, protect, and enhance the inland fisheries and wildlife resources of the State; to encourage the wise use of these resources; to ensure coordinated planning for the future use and preservation of these resources; and to provide for effective management of these resources.

Additional mandates include: (1) recreational vehicle (watercraft, snowmobile, and ATV) registration, safety, special event permitting, and law enforcement, (2) the administration of hunting, fishing, trapping, and related licenses and permits established by the Legislature, (3) regulation of commercial white water rafting, taxidermy, guides, camp trip leaders, wildlife propagators and exhibitors, (4) search for lost persons, (5) hunter, trapper, and archery training, (6) acquisition, development, and management of access to public waters, (7) protection of private property (animal damage/nuisance wildlife and trespass), (8) landowner relations, (9) promotion of the state's fish and wildlife resources, (10) conservation education, (11) public health issues associated with fish and wildlife resources (rabies/fish and wildlife consumption advisories), and (12) public outreach.

The Commissioner is also a member of the Baxter Park Authority, Land and Water Resources Council, Land For Maine's Future Board, the Maine Outdoor Heritage Board, Maine Tourism Commission, the Atlantic Salmon Board, and advisor to several other Boards and Commissions.

There are several Federal Agencies with congruent responsibilities affecting fish and wildlife or the use of these resources, which the Department must interrelate and respond to. These include the U.S. Fish and Wildlife Service, National Parks Service, Forest Service, Natural Resource Conservation Service, Environmental Protection Agency, the Army Corp of Engineers, and the U.S. Geological Survey. On the state level, the Land Use Regulation Commission (LURC), Department of Environmental Protection (DEP), Department of Conservation, and other agencies and commissions impact directly on the resources for which this Department is responsible. Initiatives and mandates such as shoreland zoning, municipal comprehensive planning, and economic and community development bring additional external forces to bear on Department operations and management decisions. As an example, Appendix B contains a spreadsheet of agencies and organizations that the Department typically coordinates and interacts with on a regular basis.

DEPARTMENT VISION AND VALUES

A Department Vision and Values statement was developed through the TQM process and incorporated into the Strategic Plan specifying that Maine should offer all people the opportunity to enjoy a unique diversity of fish and wildlife resources. The Vision is of an IF&W that:

- conserves, protects, and enhances the inland fisheries and wildlife resources;
- increases opportunities for the use of these resources by all people;
- responds to the needs of the people by providing services of the highest quality;
- fosters public awareness and involvement;

WORK PROGRAM PRIORITIES

1-6 are the most important core programs

- 1. <u>Fish and wildlife conservation</u> includes assessment, planning, management and wise use of all fish and wildlife in Maine. These programs are partially (about 60%) federally funded. Impacts all of Maine's public. Funds: Federal, License revenue/GF, Dedicated
- 2. <u>Fish and wildlife law enforcement</u> the final arm of effective fish and wildlife management ensures that effective management is achieved by balancing impacts of public use of resources. Impacts all resource users in the state. <u>Funds: License revenue/GF, Federal, Dedicated</u>
- 3. <u>Licensing/registration</u> provides licenses and registration from all outdoor recreational users allows IFW to know numbers of participants and gain revenues from some users of the resources. Funds: License revenue, Federal, Dedicated
- 4. **Propagation of fish** provides additional angling opportunity where sustained pressure from public use has otherwise reduced the opportunity or where habitat is not sufficient to support a fishery. Impacts all anglers. Funds: License revenue, Federal
- 5. <u>Facilities/engineering</u> with 9 hatcheries, 8 regional offices, over 70 dams, and many other buildings, this group is essential to keep our necessary facilities together. <u>Funds: License</u> revenue/GF, Dedicated
- 6. <u>Conservation education</u> the future of conservation ethic and appreciation in Maine. Impacts all publics that IFW can target with information about needs and values of conservation. Funds: License revenue, Dedicated
- 7. <u>Landowner relations</u> coordinates use and issues of private lands by Maine's recreational users. Impacts landowners with issues and future use of private lands by public. <u>Funds:</u> License revenue/GF, Dedicated
- 8. <u>Land acquisition</u> permanent conservation of lands for public use and habitat for the future. This program is self-funded both acquisition and management of lands is done with dedicated and/or federal and private funds. Impacts the future conservation of Maine. (channeled over \$100 million in federal and private funds into projects over 950,000 acres in last 12 years). Funds, LMF, Federal, Dedicated, Private
- 9. **Boat access** some funds from DOC are used to match federal funds to acquire and develop sites primarily for Maine's boating and angling public. Impacts all boaters and anglers. Funds: Dedicated, Federal
- 10. <u>Search and rescue</u> searches by Warden Service for any member of the public lost in Maine's woods and waters. Impacts all lost persons and their loved ones. <u>Funds: GF</u>
- 11. <u>Hunting (archery, trapping, gun) safety</u> Known as 'Hunter Safety', this program trains all new resource users in safety and conservation ethics. Has greatly helped reduce the incidents of hunter accidents of all kinds in the past few decades. Impacts all hunters and trappers. <u>Funds: Federal</u>
- 12. <u>Snowmobile/ATV/Boat safety</u> program to train users of motorized sporting equipment to operate safely and within the law. Impacts all new users and makes all outdoor users more safe by having new users operate their machines in a safer fashion. Program is paid from dedicated funds from registration fees and federal funds. <u>Funds: Dedicated, Federal</u>
- 13. <u>Environmental permitting</u> provides analyses for DEP and LURC as well as federal processes on the impacts of proposed projects on fish and wildlife resources of the state.

- Impacts all of Maine's public from the person proposing a project to the citizens that demand conservation of fish and wildlife (i.e. Plum Creek, windpower, LNG). <u>Funds:</u> License revenue/GF
- 14. <u>Public outreach</u> outreach efforts to keep the public informed about IFW activities includes press, trade shows, events, etc. Impacts those people wanting to know what IFW is working on. <u>Funds: License revenue/GF, Dedicated</u>
- 15. <u>Guides licensing</u> testing and licensing of all types of guides for professional standards. Impacts licensed guides and public that wish to hire guides. Could be handled by another professional licensing agency. Funds: License revenue/GF
- 16. <u>Fish and wildlife possession</u> assessment and permitting of possession of any fish and wildlife for any reason, including exotics. Important to restrict because of the extreme danger of environmental damage to Maine from unrestricted use of, especially, exotic species can live and propagate in the state. Impacts public involved in the pet trade, those desiring exotic pets, and certain agricultural activities that want biological control agents (i.e. forestry use of beetles). Funds: License revenue/GF
- 17. <u>Taxidermy</u> licenses people engaged in taxidermy that may have many animals in their possession. Could be handled by another professional licensing agency. <u>Funds: License</u> revenue/GF
- 18. Whitewater management management of the whitewater rafting industry, including safety and spacing allocations along the major rivers. Could be handled by another professional licensing agency. Impacts the whitewater rafting companies. Funds: Dedicated, License revenue/GF
- 19. <u>Public Health/Animal Diseases</u> IFW coordination with Public Health on issues like rabies, Lyme disease, and West Nile Virus. Impacts various wildlife conservation issues and policies for public health. <u>Funds</u>: <u>License revenue/GF</u>
- 20. <u>Special & miscellaneous permits</u> includes permits for bass fishing tournaments, snowmobile races, fishing derbies, etc. Impacts public where these events take place, as the permits usually contain conditions that govern the behavior, timing, and conduct of the event. Funds: License revenue/GF, Federal
- 21. <u>Animal damage control</u> all activities related to the negative interactions of wildlife with the public, from squirrels in the attic to bears in oat fields and beehives. Impacts all public, especially in the rural interface (most of the state), as IFW would no longer respond to any calls for help with problems. Some areas have developed a private sector ADC business to help the public for pay. Funds: License revenue/GF

AGENCY NAME: DEPARTMENT OF INLAND FISHERIES AND WILDLIFE

EMERGENCY RULES: As necessary.

INTENT: It is the intent of the Department of Inland Fisheries and Wildlife to adopt and amend reasonable regulations as necessary to ensure that all species of inland fish and wildlife are perpetuated to be used now and for the foreseeable future; and also to repeal regulations that are deemed no longer necessary for the protection, enhancement and continued use of these resources.

STATUTORY AUTHORITY: 12 MRSA, Section 10104, subsection 1 states: "The Commissioner may, with the advice and consent of the Advisory Council and in conformity with the Administrative Procedures Act, Title 5, Part 18, and except as otherwise provided, adopt, amend and repeal reasonable regulations, including emergency regulations, necessary for the proper administration, implementation, enforcement and interpretation of any provision of the law that the commissioner is charged with the duty of administering. These rules duly adopted have the full force and effect of law and are effective upon filing with the Secretary of State, unless a later date is required by statute or specified in the rule." The provisions of the law that he is charged with the duty of administering are Title 12 MRSA Chapters 901 to 939.

PURPOSE OF THE REGULATIONS: The purpose of any proposed regulation regarding fish and wildlife is to provide for the fullest level of use of the resource without adversely affecting species distribution and abundance. In order to have an organized and systematic way of accomplishing this goal, Species Management Plans were developed, and updated at five-year intervals, for all major fish and wildlife species or species groups. All proposed regulation changes will be based on the adopted goals and objectives for a particular species or species group. Species management goals and objectives are developed with input from representatives of the public from various geographic areas of the state, biological staff and members of Warden Service, and are presented to the Commissioner and his Advisory Council for adoption. Regulations regarding recreational vehicle use are adopted to provide for the use, to the fullest extent possible, of such vehicles (watercraft, airmobiles, snowmobiles and all-terrain vehicles), without adversely affecting the resource and the safety and welfare of persons and property; and administrative regulations are promulgated for the purpose of setting forth reasonable criteria for the proper licensing, registering and tagging, and training requirements specified by law for the safety and welfare of the resource and citizens of the State.

PROGRESS AND ACCOMPLISHMENTS

Fish and Wildlife Management - Long range management plans have been developed for most major species and are used to guide program initiatives for these species. These plans cover 14 wildlife game species, which include numerous waterfowl species, and 12 sport fish species, as well as recovery programs for 12 threatened and endangered species. Progress towards established management goals and objectives covered by these plans is summarized in Planning for Maine's Inland Fish and Wildlife, 1996-2001, Volume I Wildlife, Part 2, and Volume 11, Inland Fisheries, Part 2, Species Assessments and Strategic Plan Updates.

Management goals and objectives for big game wildlife (white-tailed deer, black bear, and moose) are generally on target, except for deer in northern and eastern sections of the state where habitat quality, predation, and other factors are thought to be impacting our ability to attain deer management objectives. The management of deer in these areas is being reviewed by a public working group, and recommendations will be formulated regarding future management opportunities, needs, and objectives.

The management of small game, such as snowshoe hare, ruffed grouse, woodcock, and waterfowl, is generally limited to regulating season and daily bag limits within the framework of Maine's Inland Fisheries and Wildlife Laws. Long term population trends are being driven by the reversion of agricultural land to forest and by forest management practices. Changes in the amount and quality of wetlands have a direct impact on waterfowl populations. In some areas having ideal habitat conditions good small game hunting can be found. But, significant year-to-year natural fluctuations in the abundance of these species occur in response to weather conditions which affect survival and reproductive success. Federal restrictions on the timing and length of the season on woodcock have greatly reduced the opportunity to hunt this species in Maine, while recent additions to the federal framework for waterfowl hunting has resulted in a significant increase in waterfowl hunting opportunity. Since there is little the Department can do with existing resources to significantly affect the availability of quality habitat for upland game species, management focuses on the maintenance of sustainable harvest levels. While the same is true for waterfowl, the Department is focusing a great deal of attention on the acquisition and management of wetlands and sea bird nesting islands which are vital to the conservation of these species.

Furbearer populations are similarly affected by land use and the associated habitat qualities. Management is focused on the maintenance of sustainable harvest levels. Fluctuating fur prices and trapping pressure can, however, have a significant impact on the abundance of individual species. In recent years, fur prices have been relatively low and species such as the raccoon and beaver have reached nuisance levels in many areas. The raccoon and fox have also been impacted by distemper, rabies, and other disease outbreaks which may have affected their abundance in many localities. Research on the suitability of the habitat for marten, fisher, and other highly valued furbearers is being used to develop forest management guidelines for use by private landowners. At the same time, cooperative animal damage control programs have been initiated to reduce the impact of beaver on private landowners. Programs designed to support the recovery of threatened or endangered species are working well to stabilize factors that adversely

affect and promote their recovery. Assessments are being carried out on a number of other non-game wildlife species.

Progress towards improving the quality (catch rates, quantity, and size) of fishing is generally on target with established objectives. These programs were evaluated in 2001 and management programs are being modified to achieve new goals and objectives with public input. New objectives focus on catch rates, and products, rather than harvest rates because of the trend towards catch and release. The catch is generally increasing, while the actual harvest (keeping of fish) is declining. Although the general philosophy of managing for size quality has been emphasized in recent regulation initiatives, the geographic distribution of diverse fishing opportunities needs to be formulated in the future.

A second and very important part of the Department's fisheries management involves the culture and stocking of over 1 million trout, salmon, and togue annually in over 700 waters. These fish supplement natural reproduction and are vital to sustaining the availability of these sport fish to the angler. In order to improve the program, new strains of brook trout and lake trout are being developed from wild populations. The development of these brood stocks, coupled with continuously improved stocking techniques, should continue to increase the survival of stocked fish. Fish culture facilities are being assessed, and maintenance and improvement projects implemented using both Department resources and the highly successful "Adopt A Hatchery" program, in which major corporations participate in the support of these facilities. Long range needs are also being assessed and plans formulated that will support the production of up to 1.4 million fish annually.

Hunter Safety - The purpose of the Maine Hunter Education program is to provide training for hunters and trappers to develop the skills, knowledge, and attitudes necessary to be responsible participants in these activities. The education program provides training in the safe and proper use of hunting and trapping equipment and when appropriate, demonstration of that knowledge. Instruction is provided in wildlife management principles, knowledge of wildlife resources and proper identification of wildlife. Currently the firearms and bow hunter education programs conform to national standards adopted by the International Hunter Education Association. The curriculum includes outdoors ethics and hunter responsibility and trapper education is currently being revised to conform to the education standards adopted by the Association of Fish & Wildlife Agencies. A new five year plan was completed, and will result in expanded programs, increased technology, and a greater emphasis on outdoor ethics.

During both the 2006 and 2007 seasons, 11 incidents of injured hunters were reported to and investigated by the Maine Warden Service each year. This level does exceed the 2001-2005 average of 8 per year but is in line with the average of 1996 - 2000. The 2007 incidents resulted in minor injuries to the hunting parties and there were not any fatalities associated to the sport.

Recreational Vehicle Safety -The Recreational Safety Division currently offers safety training for ATVs, snowmobiles and watercraft. The ATV safety program is the only one of the three programs that is mandatory by law. The ATV safety program has provided safety instruction to an average of 1,487 students per year since 2001. Since 1985, a total of 19,737 students have attended the ATV safety training.

Both 2006 and 2007 saw a reduction in the reported number of incidents and personal injury related to ATV operation. 2006 saw 246 incidents with 284 reported injuries while 2007 saw 213 incidents with 254 injuries. When compared to the five year average of 303 incidents and 328 injuries and the highs from the 2004 reports of 332 incidents and 362 injuries, this shows considerable reduction in crashes and injuries in this sport. Factors that likely have contributed to this reduction are increased law enforcement by multiple agencies, increased education efforts, club development and increased approved trails.

The snowmobile safety training course that is currently offered is not a mandatory program, therefore attendance at the classes is low and in some cases classes have had to be canceled. The average number of students attending snowmobile safety classes since 2001 has been 622 per year. A total of 20,482 students have attended snowmobile classes since the beginning of the program. With the increase in interest in snowmobile safety the Department is working closely with the Maine Snowmobile Association to increase the number of people involved in the program.

117 incidents and 92 injuries were reported in the winter fo 2006 and 172 incidents and 155 injuries occurred in the winter of 2007. These are notable decreases from the five year average of 320 incidents and 227 injuries. Fatalities occurring in the last two seasons were 6 and 7 respectively compared to the average of 11 in the previous five seasons.

The watercraft safety program is a non-mandatory program and has also experienced the same problems with enrollment as the snowmobile safety classes. The number of classes offered has remained consistent or in some cases are increasing, but individuals do not choose to attend or are not required to attend by law. The average yearly attendance since 2001 has been 329 students, with a total since the program began of 5,910. The Recreational Safety Division is currently working with the Coast Guard Auxiliary and the Power Squadrons to bring the various programs being offered into a central data base.

The Recreational Safety Division has recently computerized data related to recreational vehicle safety courses and accidents. With an increased emphasis on recreational safety, the Division is reviewing all programs in anticipation of an increase in course request.

Search and Rescue - Maine's search and rescue effort entered the modern age in 1980 when a group of Maine Wardens attended the National Association of Search and Rescue's Managing the Search Function Course. In the same year, the Department of Inland Fisheries and Wildlife was given statutory responsibility for SAR in the state of Maine. At that time Warden Service had the money to purchase a command post, equipment and pay for training. Additionally, the understanding was that the Legislature would reimburse the Department for SAR expenses.

Since 1980, the Maine Warden Service has searched for or rescued an average of 260 people a year. In fiscal year 2003 a detailed analysis of time records, direct costs and administrative costs showed a total expenditure of \$592,667 for Search and Rescue efforts. We believe that this is typical for the last five years. In addition to these agency costs, the volunteer search and rescue units which comprise the Maine Association of Search and Rescue (MASAR) have provided thousands of volunteer hours at SAR incidents. Wardens and MASAR members also give numerous preventative

search and rescue courses to children and other outdoor groups. The Warden Service Recreational Safety Division provides a great deal of preventative instruction in all its Outdoor Safety Programs, and has probably contributed to the drop in lost person incidents from approximately 300 a year in 1980 to the current 200 a year.

Trained wardens plan and supervise searches for lost persons in Maine. Training in search planning has allowed wardens to respond quickly and effectively to lost person incidents. The quicker they respond, plan and start the search, the more likely the victim will be found unharmed. At the larger searches, civilian volunteers provide the bulk of the ground search manpower, as well as do most of the technical or high angle rescue in Maine. The ability to call on and supervise hundreds of trained and untrained volunteers at searches makes Warden Service unique among law enforcement agencies in Maine. No other agency does this or has this capability.

The National Association for Search and Rescue (NASAR) has set the standard for SAR in the United States by providing training in SAR at all levels from supervisors to ground searchers. Since taking the NASAR Managing the Search Function course in 1980 and establishing an effective search organization, Maine has been recognized as a leader in SAR in the country. Training in SAR has continued, in part because of funding from the Outdoor Heritage Fund, with a number of wardens attending NASAR sponsored courses over the past year. In addition, the Warden Service now has several wardens who have qualified to be NASAR instructors. This will now allow Warden Service to train its own people using the NASAR courses.

Increased efficiency in locating and rescuing lost persons will provide more time for resource related law enforcement, save lives and SAR costs, and provide greater service to the people of Maine.

Fish and Wildlife Consumption Health Risks - The Department has been participating in an interagency initiative to identify health risks associated with the consumption of fish and initiate actions to reduce the threat to human health. The Department of Human Services, Bureau of Health, the Department of Environmental Protection, Department of Inland Fisheries and Wildlife, and Department of Marine Resources have formed three committees to work on this issue. They include a Policy Committee made up of the agency Commissioners, a Technical Committee made up of key agency technical staff, and a Public Relations Committee made up of the key agency public information specialists. This work has resulted in the development of "official" state fish health consumption advisories ad the transfer of this information to the media and appropriate target groups.

Wild Animal Related Human Health Risks - The Department has been participating in inter agency initiatives to reduce the threat to human health from Rabies and Lyme disease. The inter agency Rabies Work Group is chaired by the State Epidemiologist and includes representatives from many state agencies and municipal authorities. The committee has established protocols and procedures regarding the response to rabies epidemics and identified areas which need to be addressed and resolved. The Department has also been coordinating the pre-exposure immunization of Department staff and other high risk groups such as ADC cooperators,

trappers, and municipal animal control officers. The Department has cooperated with the Maine Medical Center to explore ways of minimizing the impact of Lyme Disease by oral immunization of deer and other mammal carriers. This research was carried out on Monhegan Island where a large deer population was contributing to a high incidence of Lyme disease among the island residents and visitors. This approach did not provide an effective way of addressing the problem, and the Department cooperated with the town with the removal of a significant portion of the deer on the island. The Department has also been disseminating information regarding the disease and preventative measures.

Wildlife Motor Vehicle Collisions –Moose/deer motor vehicle collision records are compiled for both population trend assessment and accident prevention planning. Department staff work with regional DOT staff to identify high risk areas and take appropriate actions. Areas with high deer populations due to firearm discharge ordinances are being identified and proposals developed for special hunting seasons.

Public Access to Private Lands - The Department's Landowner Relations Program primary goal is to develop more access and enhance current access to private property. The outdoor recreation industry is a vital part of the Maine economy and way of life. The primary goal can be achieved through the education of landowners and land users. Landowners need to have their property and their rights protected and respected. Land users must become more respectful for. private property and landowners rights. More cooperation between land users and landowners will help achieve more access.

ASK FIRST, which the Landowner Relations Program promotes, is one example of how the Department is encouraging land users to respect and cooperate with landowners. Production and distributions of informational brochures and posters, printing of articles in newspapers, and magazines, and inclusion of landowner related laws in all Department lawbooks are additional methods being utilized to educate land users and landowners.

The scope and goals of the landowner relations program are somewhat restricted due to available funding. Current program goals are being met. However, the program needs to expand which will require additional funding.

Public Access to Public Waters - Public waters with important fisheries values that have no legal public access, likely to lose existing public access, or with inadequate public access are identified and prioritized. Opportunities to obtain public access to these waters are aggressively explored. Candidate sites are assessed and appropriate sites acquired. Since 1990, an average of 6 sites per year have been acquired, and one site fully developed per year.

Acquisition and Management of Fish and Wildlife Habitat - The Department currently owns approximately 130,000 acres of upland, inland wetland, coastal salt marsh, riparian strips along major rivers, and over 250 coastal islands. Recent acquisitions have been made possible through the Land For Maine's Future Fund, National Wetlands Conservation Act Funds, Federal Coastal Wetlands Grants, National Fish and Wildlife Foundation Grants, Federal Aid to Wildlife Restoration, Outdoor Heritage Fund, Duck Stamps, and Loon Plate funds.

Department Operations - A number of actions have been taken to improve the efficiency and effectiveness of internal operations. These include:

- MOSES
- Warden Service automation
- On-line capabilities for applications for moose and any-deer lotteries
- On-line registration
- Hatchery production computerized (by species, body of water, year)

PERSONNEL AND ORGANIZATIONAL STRUCTURE

Authorized Staffing

The Department has a total of 320 positions throughout the State.

- 7 Office of the Commissioner
- 17 Administrative Services
- 23 Licensing and Registration
- 54 Bureau of Resource Management Wildlife Division

FACILITIES AND LANDS

In addition to the main office in Augusta (which is leased), there are 7 regional offices (Gray, Sidney, Machias, Strong, Greenville, Enfield and Ashland), and a leased facility in-Bangor that houses a Warden Division and the Fisheries and Wildlife Research offices. In addition there are numerous outlying facilities, most of which are owned, but in all cases are the full responsibility of the Department. They include:

- 9 fish culture stations
- 130,000 acres of wildlife management areas in 140 properties, including over 250 seabird nesting islands.
- 37 wildlife sanctuaries.
- 222 buildings, structures, housing units, remote camps, etc.
- Gray Visitors' Center and Wildlife Park facility.
- Swan Island historic site (Steven Powell Wildlife Management Area), in Richmond, which includes several historic buildings that are maintained by the Department.
- Frye Mountain Management Area in Morrill including a 5 bay storage barn
- 59 dams and 113 fish ways, (some of which we do not own but have responsibility for), including Atlantic Salmon Commission facilities.

- 2 float plane hangers
- Governor Hill (Augusta) complex including a fish pathology laboratory, engineering building and storage buildings.
- 117 (to date) aquatic access sites
- 50 miles of access roads/ 18 bridges/numerous culverts.

ALTERNATE DELIVERY OF SERVICES AND EFFICIENCY EFFORTS

Over the last 5 years the Department has steadily improved delivery of programs to the public at a reduced cost by streamlining programs, automating licensing and registration processes and providing more complete information to the public. The following are some examples of the efforts the Department has taken to become more efficient:

The Commissioner's Disabled Hunter, Trapper and Angler Advisory Committee, established by the Legislature to approve/issue special accommodation permits to persons with permanent physical disabilities to engage in hunting, fishing and trapping, began issuing lifetime permits rather than requiring annual review/renewal. Streamlining this process has been great for not only the permit holders, saving them time and money, but has saved this Department staff time and money as well.

The Maine Warden Service has implemented the following efficiencies:

- Downsized from 5 Divisions in 5 headquarters to 2 Divisions with Lieutenants in Augusta. This was not effective for span of control. We restructured in 2007 to 3 Divisions and 3 Lieutenants in appropriately-located offices.
- Automation of the bureau starting in September 2006.
 - E-mail communication
 - RMS by partnering with other State law enforcement
 - Activity reporting
 - TAMS
- Downsized Central Fleet Management vehicles from ³/₄ ton pick-ups to ¹/₂ ton pick-ups and smaller vehicles for administration staff.
- Administration of all specialty teams under one Lieutenant in Augusta.
- Utilization of conference calling for Command Staff.
- Reduced Supervisory meetings from monthly to quarterly.
- Reduced number of "All-Warden meetings" to 1 per year.
- Secured outside resources and funding for some of our equipment needs.

The Bureau of Resource Management has implemented the following initiatives (in no order of priority):

- On-line publishing of information trapping, management reports, lynx information, etc.
- Statewide plan (Maine Wildlife Action Plan) with extensive public input that prioritizes species management activities for all Maine fish and wildlife.
- Environmental permitting streamlined by putting all environmental data on the web allowing towns, consultants, applicants to search the area of their project to determine whether there are fish and wildlife issues.
- Integrated all nongame and game management eliminates the need for a parallel division/organization as is present in many other states.

- Changed statistical analysis software to eliminate a \$25,000 software license fee.
- Developed on-line lotteries for moose and antlerless deer permits, thereby eliminating one data entry position due to less paper data entry.
- Installed round tank systems in several hatcheries to make fish rearing more efficient less energy, less water, less effluent issues.
- Improved waste discharge treatment at hatcheries to improve downstream water quality.
- Developed an internal fish stocking database that allows tracking of all fish culture from initial order through final stocking allows more efficient planning of numbers and pounds of fish at all facilities to improve forcasting feed and energy needs.
- Privatized Animal Damage Control efforts in many parts of the state allowing IFW to funnel requests for help to private ADC businesses that charge the public for services.
- Developed a new self-funded lands management program with the U. S. Fish & Wildife Service to better manage IF&W lands for habitat and public use funded with sales of wood products from IF&W lands.

Our Licensing and Registration Division has made the following changes creating efficiencies in the issuance of licenses and permits:

- Online Any-Deer Permit Applications
- Online Moose Permit Applications
- Online Any-Deer Permit Transfers
- Online Hunting and Fishing licenses and permits
- MOSES system (online electronic sales of licenses and registrations by agents)
- ATV Registration Process Simplification
- Snowmobile Registration Process Simplification
- Lake & River Protection Sticker Process Simplification
- Shut down of BULL system (previous IF&W licensing system)
- Any-Deer Permit material change
- Turkey Permit Process Simplification
- Native American Hunting and Fishing License Simplification

Streamlining efforts within the Division of Public Information and Education's Merchandise and Marketing Programs include:

Dept. Logo Merchandise Program

- Reduced inventory management and consolidated branding/merchandise sales efforts of IF&W logo products on website. We have streamlined products offered and increased overall distribution by securing L.L. Bean, in a long term agreement, as a retail partner. IF&W receives \$2.00 per item on production and worldwide brand recognition for mission goals and objectives. We manage no inventory yet have increased product inventory, availability and brand distribution.
- L.L. Bean's Hunting and Fishing Store sales have exceeded 10,000 items sold in less than a year. Items are extensive and are featured at the front door of the retail store. Since the

original 10 month sales period L.L. Bean has sold an additional 8900 items in 3 months with the addition of IF&W items in their catalog and internet sales programs, and have put a full-page IF&W feature in 2008 Fishing Catalog. Tokyo L.L. Bean will be featuring IF&W items with an initial stock order of 3,000 items.

- In conjunction with the Division of Licensing and Registration's initiatives to move toward electronic licensing sales, we implemented an incentive program for license buyers to use the MOSES electronic licensing system. Rate of conversion from paper to e-purchasing doubled resulting in excellent cost savings. We followed up the hugely successful 2006 Classic Truck Giveaway Program with a Classic Rangeley Boat Giveaway in 2007. This was a major success in moving paper license users into more efficient electronic purchasing using the Moses System.
- Eliminated all marginal in-state PR events and cut in-state event operational costs in half by incorporating the *Operation Game Thief* mobile display into the schedule formerly operated by our Outdoor Partner's Program trailer unit. This mobile information trailer unit was created to enhance Department public relations efforts. Unit formerly traveled to 60 plus instate events, festivals and fairs communicating Department goals, missions and objectives with various brochures, posters and collateral. A newer unit was just added to replace this program featuring the *Operation Game Thief Program*, which is a function of a non-state agency non-profit, resulting in operational costs being reduced by 50%.
- Reduced the amount of print collateral necessary to communicate the Department's mission, goals and objectives by creating flash video capability and partnership with an outdoor media group, <u>MyOutdoorTV.com</u>, to feature an extensive IFW online video library to communicate our messages more effectively.
- Developed, executed a *Targeted User Group E-mail effort to* include user surveys, user specific *Landowner Relations and Operation Game Thief* messaging, and streaming Department video links via MyOutdoorTV.com partnership. This partnership and video streaming capability was at zero cost to the Department by using Maine IF&W as a pilot agency to promote *My Outdoor TV* efforts nationwide.
- Reduced demands on actual license dollars to fund out of state marketing functions from a budget of \$100,000 in 1999 to only \$16,000 in 2007, by supplementing lost funds with sales of Department Logo merchandise to actually exceed the amount of exposure above 1999 levels.
- Utilized media editorial rather than paid advertising by pursuing and operating media familiarization trips thus increasing total exposure and securing testimonial support rather than paid advertisement at a fraction of the cost.

EMERGING ISSUES

The Department continues to struggle to obtain sufficient funding to support the expectations of Maine's public that benefits from the conservation of fish and wildlife. In response to the strong demand for wildlife-related activities and particularly because of the significant economic contribution of those activities to the state's economy, Maine needs to provide greater financial support for wildlife programs. We need a commitment to an investment from a broad-based revenue source in our fish and wildlife industry, to keep it strong and competitive with other states through marketing and exemplary programs, and to provide continued public understanding, appreciation, and access to fish and wildlife for future generations.

The Department needs to secure a new headquarters building by June of 2009. The current lease expires at that time and any future headquarter space will cost significantly more than the per square foot cost of the current building. Planning work has already started and preliminary space needs have been defined. Additional funding and proposals for development must be identified by September of 2008.

DEPARTMENT OF INLAND FISH & WILDLIFE POLICY STATEMENT AGAINST HARASSMENT

I. General Policy Statement

The State of Maine recognizes the dignity of the individual employee and the right of employees to work in an environment which is free of intimidation and harassment. Such intimidation or harassment based on race or color, sex, sexual orientation, physical or mental disability, religion, age, ancestry or national origin, whistleblower activity, previous assertion of a claim or right under the Maine Workers' Compensation Act, or marital status is a violation of State policy. Because such harassment seriously undermines the integrity of the work place and adversely affects employee morale, it is unacceptable and will not be tolerated. In addition, it is considered grounds for disciplinary action up to and including discharge. Harassment based on race or color, sex, sexual orientation, physical or mental disability, religion, age, ancestry or national origin, whistleblower activity or previous assertion of a claim or right under the Maine Workers' Compensation Act may also constitute illegal employment discrimination.

Examples of harassment related to race or color, sex, sexual orientation, physical or mental disability, religion, age, ancestry or national origin, whistleblower activity or previous assertion of a claim or right under the Maine Workers' Compensation Act, include the following, which may be a series of incidents or a single occurrence:

- Unwelcome sexual advances, gestures, comments, or contact;
- Threats:
- Offensive jokes;
- Subjecting employees to ridicule, slurs, or derogatory actions;
- Basing employment decisions or practices on submission to such harassment;
- Refusal to cooperate with employees in performing work assignments;
- Inequitable disciplinary actions and work assignments.

Further examples of sexual harassment include: behavior that is verbal and sexual in nature – such as comments about a person's looks, personal inquiries, sexual jokes, use of derogatory sexual stereotypes, uttering sexually suggestive sounds, writing sexual notes, use of State computer equipment to send, receive and/or download material of a sexual nature; **non-verbal sexual behavior-** such as looking someone up and down, staring or leering at someone's body, deliberate blocking of a person's path, displaying sexual visuals, making sexual gestures; or **physical** – such as pinching, grabbing, sexual assault or any physical contact of a sexual nature.

As a matter of State policy, <u>any</u> behavior of a sexual nature in the workplace is considered unprofessional regardless of whether it constitutes illegal sexual harassment. Similarly, any conduct that degrades, ridicules or otherwise draws unwanted attention to any employee or other person having dealings with the department on the basis of race or color, sex, sexual orientation, physical or mental disability, religion, age, ancestry or national origin, whistleblower activity, previous assertion of a claim or right under the Maine Workers' Compensation Act, or marital status is considered unprofessional regardless of whether it constitutes unlawful harassment. Such unprofessional conduct will not be tolerated in the work place because it undermines morale, interferes with performance and demeans its victims. Each employee is personally responsible for compliance with this policy.

As part of their supervisory responsibilities, supervisors are required to actively prevent or stop inappropriate, unprofessional conduct in the workplace regardless of whether the conduct rises to the level of illegal harassment. If they become aware of any such conduct occurring, they must take immediate and appropriate corrective action, including discipline, to end the conduct. Corrective action is required regardless of whether a complaint is made or the conduct appears to be unwelcome.

The Department's EEO Coordinator may be consulted for advice and direction and <u>must</u> be contacted if a complaint is received, even if the complainant requests that no action be taken. Managers and supervisors who fail to fulfill their obligations under this policy will be subject to disciplinary action, up to and including discharge.

II. Definitions

"Sexual harassment" is defined as unwelcome sexual conduct that is a term or condition of employment. Unwelcome sexual conduct is sexual harassment when submission to such conduct is expressly or implicitly made a term or condition of employment.

"Quid pro quo" harassment occurs when submission or rejection of such conduct is used as the basis for employment decisions affecting an individual, such as promotions in exchange for sexual favors, or an unfavorable change of duties in response to rejected sexual advances.

"Hostile Work Environment." Unwelcome sexual conduct which unreasonably interferes with an individual's work performance or creates an intimidating, hostile or offensive working environment also constitutes illegal sexual harassment. Conduct which is not sexual in nature may still create a sexually hostile work environment if it is based on the victim's gender. Such conduct may include excluding or isolating employees, tampering with belongings or equipment, or physical or verbal abuse based on gender.

III. Applicability

This policy applies to:

- Co-workers and supervisors
- Outside parties having dealings with the department (i.e., customers, vendors, contractors)
- Interactions between individuals of the same sex as well as of the opposite sex
- Interactions in the workplace during work hours as well as outside activities related to the workplace (i.e., parties, trips, conferences)

IV. Complaint Process

The State of Maine is committed to preventing harassment prohibited by this policy through education and dissemination of information as well as employee accountability. Such harassment may be reported by any employee, regardless of whether that employee is the recipient of the harassment, a witness or otherwise becomes aware of harassment prohibited by this policy.

Internal complaints may be filed by contacting any of the following individuals:

- Immediate supervisor or any supervisor/manager in the chain of command
- Departmental Equal Employment Opportunity Coordinator
- Departmental Human Resource Manager
- State Equal Employment Opportunity Coordinator

Although every attempt will be made to resolve complaints at the lowest possible level, if an investigation is warranted, it will be conducted promptly and with as much confidentiality as possible, respecting the rights of all parties involved. All employees are expected to cooperate in any departmental investigation of harassment.

In addition to initiating the internal complaint procedure, employees covered by collective bargaining agreements may file a grievance through the applicable grievance procedure. A discrimination complaint alleging harassment on the basis of race or color, sex, sexual orientation, physical or mental disability, religion, age, ancestry or national origin, whistleblower activity or previous assertion of a claim or right under the Maine Workers' Compensation Act may also be submitted to the Maine Human Rights Commission at any time within 180 days of the alleged discriminatory incident. It is not required that any of the above procedures be utilized first or in any sequence, nor is it required that any procedure be exhausted before the other is used. In those instances where the prior workers' compensation claim or right is made against the State of Maine, the complaint may be submitted to the Maine Workers' Compensation Board.

V. Retaliation

Any form of retaliatory action or threat or suggestion of retaliation by either employees or supervisors against any person filing a complaint under this policy or assisting in an investigation is a violation of State policy. Any discriminatory action against any individual because the individual has opposed a practice that would be a violation of the Maine Human Rights Act, Title VII, the Americans with Disabilities Act, or the Age Discrimination in Employment Act or because the individual has made a charge, testified or assisted in any investigation, proceeding or hearing under the Maine Human Rights Act, Title VII, the Americans with Disabilities Act or the Age Discrimination in Employment Act is illegal. A complainant is protected from retaliation regardless of the merits of the original complaint. Retaliation should be reported in the same manner as described above for complaints of harassment and will be promptly investigated. Such retaliatory conduct will be grounds for disciplinary action.

EQUAL EMPLOYMENT OPPORTUNITY/AFFIRMATIVE ACTION POLICY STATEMENT

The State of Maine shall continue to pursue a policy of non-discrimination in all employment actions, practices, procedures and conditions of employment.

- 1. Employment decisions will be based on the principles of equal employment opportunity. Recruitment, testing, selection, and promotion will be administered without regard to race or color, sex, sexual orientation, physical or mental disability, religion, age, ancestry or national origin, whistleblower activity, previous assertion of a claim or right under the Maine Workers' Compensation Act or marital status unless a bona fide occupational qualification exists.
- 2. Further, personnel actions and conditions of employment, such as compensation, benefits, layoffs, job assignments, employee development opportunities and discipline shall be administered without regard to race or color, sex, sexual orientation, physical or mental disability, religion, age, ancestry or national origin, whistleblower activity, previous assertion of a claim or right under the Maine Workers' Compensation Act or marital status.
- 3. Reasonable accommodations will be made for any qualified individual, applicant or employee, in accordance with the provisions of the Maine Human Rights Act and the Americans with Disabilities Act.
- 4. Managers and supervisors are responsible for awareness of and response to potential discriminatory situations. Employees are required to cooperate fully with the investigation and/or resolution of any discrimination complaint.
- 5. Managers and supervisors are required to actively prevent and correct retaliation or harassment toward any employee who has been involved in the filing, investigation, or resolution of a discrimination claim.
- 6. The Department will address and attempt to resolve employee complaints regarding discrimination and harassment as expeditiously as possible. Supervisors and managers are required to contact the agency EEO Officer if they receive a complaint of this nature.
- 7. This policy shall not be construed to prohibit any employment action or policy which is required by federal law, rule or executive order.

Each State agency has a designated EEO Officer who is responsible for the implementation, monitoring, and record keeping of the agency EEO/AA Program as well as providing technical assistance to applicants and employees. The State EEO Coordinator in the Bureau of Human Resources is also available as a resource to any state employee or supervisor. She may be reached at 287-4651 (TTY - 287-4537). Special Programs

Health and Safety Issues

The Department continues in its efforts to improve the health and safety of the workplace, both through facility management and providing employees with information on safe work practice, and equipment.

Employee injury statistics are monitored by staff at the Natural Resources Service Center's HR Division, with annual OSHA reports completed and posted in all work sites, as required.

Workers Compensation

The Department is in compliance with all workers compensation requirements including notification of injuries, filing of reports, compensation to employees, coordination payment of bills, and coordination of necessary medical evaluations in a timely manner. Through management by the Natural Resources Service Center and assistance from the Workers Compensation Division, the Department continues to review long-standing cases for possible settlement which will reduce the overall workers compensation costs to the Department

Through the Natural Resources Service Center's HR Division, supervisory workers compensation training has been provided to managers to ensure that supervisors are trained in and aware of notification requirements. The Department, through the NRSC, has also issued written procedures on notification processes for employee injuries. This information is also provided on the NRSC website, along with all necessary forms, which is available to employees.

Affirmative Action/EEO

The Department complies fully with federal and state affirmative action requirements. An Affirmative Action Plan is in place and the agency strives to meet the goals established for recruiting purposes. It is intended that the plan will be updated for all state agencies within the coming year. All recruitment and employment initiatives comply with federal and state laws for equal employment opportunities.

The Department holds to its position of no tolerance for sexual harassment, discrimination, or employee harassment. Allegations or complaints are investigated promptly and appropriate action taken. During the past year, the Natural Resources Service Center HR staff has conducted workplace harassment training for senior management employees and Maine Warden Service supervisors. The NRSC intends to provide the mandatory training to all other employees within IFW during the coming year. Workplace harassment training is provided to all new employees during the new employee orientation process. In June of 2007 the Department's policy on both Workplace Harassment and Equal Employment was redistributed to all employees within the Department. As new changes and/or interpretation to EEOC law and court decisions are received, the NRSC on behalf of the Department will continue to conduct additional training.

ADA Requirements

The Department makes every reasonable effort to comply with ADA requirements to include insuring that work sites and public use areas are readily accessible. The Department complies with all requirements under ADA relating to employment and public meetings. The Department strives to successfully accommodate employees in employment related requests.

POLICY CONCERNING THE USE OF STATE-OWNED INFORMATION AND TECHNOLOGY (I.T.) AND RELATED COMMUNICATIONS EQUIPMENT:

NOTE: State information and technology and related communications equipment may include, but is not limited to: Computer workstations, voice mail, computer networks, printers, copiers, telephones, fax machines, modems, fax modems, e-mail, local and wide area networks, Internet, and Intranet.

PURPOSE

The purpose of this policy is to set out the rules to be followed while using any or all of the State-owned information and technology equipment under the control of the Department of Inland Fisheries & Wildlife.

BACKGROUND

The Department of Inland Fisheries & Wildlife provides its employees access to Stateowned I.T. equipment to accomplish tasks, process, and communicate to effectively achieve its mission, as directed by law and the administration.

The State of Maine "Freedom of Access Law" (1 MRSA, § 401-410) clearly provides that any and all materials, files, notes, records, copies, etc., regardless of the media used to store or transmit them (paper, film, microfiche, magnetic media, electronic media, etc.) in public offices or in the possession of public employees while at work are public property. As such, the public has access to those materials. All material created, modified, stored, moved, distributed, transferred, printed, imaged, or otherwise manipulated on State-owned office automation equipment is considered to be public property and, as such, is subject to examination by the public. The law places some very narrow restrictions on the public access, such as personnel files, employment applications, employee testing and rating criteria, workers' compensation files, certain investigation files, etc., but most materials are subject to public viewing. *Employees are advised that there should be no expectation of privacy when using any State-owned I.T. or related communications equipment*.

E-mail systems, Internet and WorldWide Web browsers, bulletin board systems, etc., are intended to be used for State business purposes. IF&W staff should be aware that cell phones and internet messages are generally not secure and can be easily intercepted by outside parties. Voice mail and e-mail messages may have backup

copies that cannot be deleted by the operator. A history of accessed web sites is recorded by most browser software. All of this information may be subject to release under a "Freedom of Access Law" request. In addition, IF&W staff and the Office of Information Technology may monitor voice, e-mail, and Internet traffic to improve service levels, enforce this policy, and prevent unauthorized access to State systems.

Unofficial and/or unauthorized use of State-owned equipment places unanticipated and possibly excessive demands on the State's I.T. resources.

Accessing unofficial and/or unauthorized sources unnecessarily exposes the State to the spread of computer viruses, which may be both costly and disruptive to clean from IF&W's I.T. and related systems.

POLICY

State-owned I.T. equipment is made available to staff to conduct official Inland Fisheries & Wildlife business. The use of State-owned I.T. equipment to create, record, store, transmit, distribute, image, modify, print, download, or display inappropriate or unprofessional materials that demean, denigrate, or harass individuals or groups of individuals, on the basis of race, ethnic heritage, religious beliefs, disability, sexual orientation or gender, and/or materials that are sexually explicit or pornographic in nature, whether or not the material was intended to demean, denigrate or harass any employee or group of employees, is prohibited.

The State's E-mail is not to be used to forward or otherwise broadcast "chain letters," mass communications that are not work related, or solicitations for causes unrelated to the State's business, no matter how worthy the cause may be perceived to be. If in doubt as to whether your proposed e-mail meets these guidelines, contact the HR Division of the NRSC at 287-2214. Solicitations or mass communications for causes believed to be related to State business should be brief, not endorse any particular product or provider, and should refer readers to a webpage for further information. The Commissioner or his/her designee must approve such solicitations or mass mailings. [NOTE: In the Capitol area, Capitol Security must give written permission for solicitations. The *Maine State Employees Combined Charitable Appeal* is the only solicitation with on-going, or "blanket" approval]. State-owned automation equipment may not be used to conduct outside business nor may it be used in conjunction with any outside employment activity.

Additionally, state law makes it a crime to use a computer system operated by a state department or agency to advocate for or against a candidate for federal office, a constitutional office, an elective municipal, county or state office, including leadership positions in the Senate and House of Representatives, as well as to solicit contributions required by law to be reported to the Commission on Governmental Ethics and Election Practice.

Any personal use of State-owned I.T. equipment must be incidental in nature. Examples of incidental use may include, but are not limited to, brief e-mails, accessing an appropriate subject on the Internet, phone calls of an urgent nature, using computer

capabilities for incidental correspondence, etc.² The use of State-owned supplies represents a cost to the State and, as such, printing and copying for personal use is restricted to incidental use only. Any personal, incidental use of State-owned equipment shall not interfere with the Department's business activities, must not involve solicitation in any form, must not be associated with any outside business or employment activity, and must not potentially embarrass or offend the State of Maine, its residents, its taxpayers, or its employees.³

GUIDELINES AND PROCEDURES

In the event that an employee inadvertently accesses inappropriate or prohibited material, the employee is required to immediately secure the material from view. It is recommended that if an employee inadvertently accesses inappropriate or prohibited materials, his or her supervisor or management should be advised of the circumstances surrounding the inadvertent access. This will ensure that the employee is held harmless for inadvertently accessing the inappropriate or prohibited materials.

If supervisory or management staff become aware that inappropriate or prohibited materials are being accessed, downloaded, or otherwise transmitted to or by an employee in his or her organization, he or she must act immediately to stop such activity. Supervisors and managers should contact the NRSC Human Resources Director for guidance and consultation.


These rules may be amended as necessary by State policies and procedures or by updated IF&W policies.

Each employee of the Department of Inland Fisheries & Wildlife is expected to comply with this policy. Violation of this policy may lead to progressive discipline, up to and including dismissal consistent with applicable bargaining agreement and/or *Civil Service Rules*.
